# Minnesota Fringe reports attendance of 47,882 for 2016 festival

MINNEAPOLIS – Minnesota Fringe released the final numbers from its 23rd annual festival Monday afternoon. Over its 11-day run, the performance festival saw attendance of 47,882 at 869 performances of 168 shows, a record for a year in which the Fringe is up against the Olympics. In 2015 festival attendance was 50,338 for 909 performances of 174 shows. Top-10 lists and sell-out shows are listed below.

Executive Director Jeff D. Larson commented, "We undertook an enormous thing this year," referring to the festival's move away from single tickets to day passes. "This year marked a shift in audience behavior. With day passes we saw audiences taking more chances and being more adventurous, which is better for artists and better for the Fringe's mission."

Larson added, "As always, I'm blown away by the way this community shows up to support new and exciting work."

The festival pays 70% of box office revenue back to participating artists. In 2015 box office revenue was \$411,799, with \$285,770 paid out directly to artists.
