<u>Program Goals</u>: The Cultural Resources Diversity Internship Program (CRDIP) provides career exploration opportunities to diverse undergraduate and graduate students in historic preservation and cultural resources management. The program also gives National Park Service offices, national park units, government agencies at all levels, and private organizations opportunities to meet promising young people who might choose a career in this field. The National Park Service Cultural Resources Directorate, through the CRDIP, cooperates with intern sponsors to provide quality work experiences to students.

How the Program Works:

- The NPS Washington Office's Cultural Resources Diversity Internship Program (CRDIP), in partnership with the Student Conservation Association (SCA), will sponsor interns during a 10week summer session, beginning approximately June 1, 2015.
- The cost is shared on a 50/50 basis between the CRDIP and the intern sponsor. In FY2014, the maximum total cost for each summer intern was approximately \$10,207, which included intern recruitment, salary, housing, and transportation. Thus, intern sponsors were expected to contribute \$5,104. This amount was matched by the CRDIP. Please contact the coordinator, Paloma Bolasny, with questions concerning costs. Total final cost will depend on varying factors associated with your site.
- Intern applicants apply directly to the SCA and intern hosts interview and select interns.
- CRDIP interns are required to participate in several educational activities organized by the WASO CRDIP coordinator, including providing blog updates and attending webinars.
