National Geospatial Advisory Council (NGAC) – September Public Meeting

The NGAC held its September advisory council meeting in the National Conservation Training Center (NCTC) in Shepherdstown, WV on September 27-28, 2016. Chair Julie Sweetkind-Singer conducted the meeting. Members had the opportunity to discuss Transition ideas with Camille Touton, Deputy Assistant Secretary for Water and Science as well as small group discussions to identify key messages regarding the geospatial community. Members also had lively discussions around the NSDI and the OMB Circular A-16 and the policy framework. NGAC Vice Chair, Keith Masback, convened a panel of technology specialists to share their perspectives on new technologies and their impact on the geospatial industry and programs. NGAC Subcommittees had an opportunity to meet prior to sharing progress on their study topics. This year's subcommittees include: Emerging Technologies, Policy Framework, Standards, and Landsat Advisory Group.

Throughout the meeting, 12 members presented lightning talks, which included topics ranging from Data USA, GIS in Government, National Geospatial Preparedness Summit, GIS&T Advanced Placement Program, and a video on North Caroline/South Carolina Boundary Dispute (https://www.youtube.com/watch?v=WTOzwI4HUQE)
