

Cash receipts from meat animals during the first 5 months of 1946 remained relatively close to the 1945 level, but have fluctuated violently since then, sinking below the 1940-44 average in June and September and rising far above the 1945 level in July, August and October.

During the first half of the year, cash receipts from dairy products were maintained slightly below the 1945 levels but rose about 16 percent in July, sagged slightly in August and September, and recovered in October. Dairy-production payments, discontinued in June, are not included in cash receipts from dairy products.

FARM INCOME SITUATION

Total cash receipts from farm marketings during the first 11 months of 1946 amounted to around 21.6 billion dollars, 14 percent above the same period in 1945. Receipts from livestock and products were about 10 percent greater than last year, and crop receipts were probably about 19 percent higher. The increases in cash receipts were due largely to higher prices for nearly all farm products.

Preliminary estimates indicate that cash receipts in November were 3.0 billion dollars, about 10 percent below October, but 30 percent above November 1945. Receipts from livestock and products were about the same as in October but crop receipts declined nearly one-fifth. Large seasonal decreases occurred in receipts from cotton, tobacco, and oil-bearing crops.

In October, total cash receipts from farm marketings are now estimated at 3,366 million dollars. Higher prices and greatly increased marketings of meat animals during the last half of that month resulted in an unusually large gain in cash receipts from livestock and products. The increase in crop receipts was brought about mainly by large gains in receipts from cotton and oil-bearing crops.

State and Regional Estimates


Total cash receipts from farm marketings for the entire country in September were 8 percent greater than in September 1945. Prices of both crops and livestock in September averaged about 23 percent higher than a year earlier. Cash receipts ranged from 6 percent below last year in the East North Central Region to 37 percent above in the South Central Region. Total receipts were greater than in 1945 in all other regions except the West North Central Region.

Receipts from livestock and products in September declined 4 percent from last year, with decreases in the central and southern regions only partially offset by substantial increases in the North Atlantic and Western Regions. Declines of 9 percent in the East North Central Region and 16 percent in the West North Central Region resulted from rather severe decreases in income from hogs and cattle, which more than offset gains in receipts from dairy products. A small decline in the South Atlantic Region was due to decreases in receipts from broilers, cattle, and hogs with partly offsetting increases for dairy products. Substantial gains in all dairy-product items accounted for most of the 14-percent increase in livestock receipts in the North Atlantic Region; and dairy products and cattle were largely responsible for the gain of 12 percent in the Western Region. In the South Atlantic Region, no significant change occurred as increases in dairy products were offset by decreases in meat animals.

Receipts from crops in September showed a gain of one-fifth over the same month last year. Crop receipts in the North Atlantic and East North Central Regions dropped slightly, but receipts in all other regions showed substantial gains, with income from wheat in the North and cotton in the South increasing generally.

During the first 9 months of 1946, total cash receipts for the United States as a whole increased 7 percent over the same period last year. Moderate gains were made in all regions except the North Atlantic, where no change occurred. Receipts from livestock and products in the United States increased 10 percent over last year. They decreased 10 percent in the South Atlantic Region, where receipts from broilers and hogs declined sharply. Receipts from wholesale milk made definite gains in all regions; and increases in income from hogs were important in the East and West North Central Regions. Receipts from crops for the 9-month period were 13 percent above 1945 for the country as a whole, with the largest percentage increases occurring in the East and West North Central Regions, where substantial gains were made in all States. Increases in receipts from wheat and soybeans were especially significant in these two regions.
