## CASH RECEIPTS, JANUARY-NOVEMBER 1953

Farmers received about 28.1 billion dollars from marketings in the first 11 months of this year, 4 percent less than they received during the corresponding months of 1952. Prices of farm products averaged about 10 percent lower than last year, but the total volume of marketings was about 5 percent larger. Cash receipts from livestock and products totaled 15.6 billion dollars, down 8 percent because of lower prices for cattle and calves, wholesale milk, and butterfat. Receipts from poultry and eggs, however, were up 8 percent, with prices averaging higher for eggs and chickens. Crop receipts for the 11-month period were about 12.5 billion dollars, practically the same as in 1952, with increased receipts from wheat and corn about offset by declines in receipts from potatoes and soybeans.

### Cash receipts in October

Total cash receipts in October were 3.7 billion dollars, up 15 percent from September because of seasonally larger marketings. However, they were 8 percent less than in October 1952, largely because of price declines. Receipts from livestock and products of 1.5

billion dollars were 5 percent above the previous month because of larger marketings of meat animals, eggs, and turkeys. Lower prices, however, held receipts from meat animals and dairy products below last year, and the October total for livestock and products was 15 percent less than a year earlier. Crop receipts in October were 2.2 billion dollars, 24 percent above September but 2 percent below October 1952. Receipts from many of the principal crops were up seasonally.

#### Cash receipts in November

Total cash receipts in November are tentatively estimated at 3.4 billion dollars, down 7 percent from October but slightly higher than in November of last year. Receipts from livestock and products of 1.5 billion dollars were about the same as in October but 6 percent below a year ago. Receipts from each of the three major livestock groups were below November of last year, largely because of smaller marketings of turkeys and lower prices for cattle and calves and for milk and butterfat. Crop receipts in November of 1.9 billion dollars were down 12 percent from October but about 10 percent above November of last year. Marketings of nearly all major crops except corn were down seasonally, but marketings (including loans) of cotton, wheat, and corn were larger than a year ago.

#### REVISED MONTHLY CASH RECEIPTS, 1951 AND 1952

Revised monthly estimates of cash receipts from farm marketings are given in tables 6-13, by States, for the years 1951 and 1952. They add to the revised annual totals for those years as published in the July-August issue of this report.

The revised monthly estimates for 1951 are published here for the first time. Those for 1952 constitute a further revision of the 1952 monthly estimates given in the September-October issue. In the latter, minor changes have been made in the monthly distributions for livestock and products. The estimates for crops are not changed, but they are shown along with the revised livestock estimates so as to provide a complete picture of the 1951 and 1952 monthly data in this issue.
