## FARM INCOME IN THE FIRST HALF OF 1959

Farmers' realized net income in the first half of 1959 was at an average annual rate of approximately 12 billion dollars. This was a billion dollars or 8 percent lower than in the first half of 1958, but over a billion dollars higher than in 1957.

Cash receipts from farm marketings in the first half of 1959 were only slightly smaller than in the first half of 1958, as lower average prices of farm products were largely offset by an increase in volume of sales. However, Government payments were lower than last year as Acreage Reserve payments were discontinued, and realized gross farm income was down about 1 percent from the first half of 1958.

Production expenses continued their upward trend in the first 6 months of 1959, reaching a new high rate of 25.8 billion dollars, 3 percent above their 1958 first half rate. Contributing to this increase were higher wage rates, property taxes, and interest charges plus higher prices paid for feeder livestock, feed, farm machinery, and motor vehicles. Seed and fertilizer were the only important cost items for which average prices declined.

The 1958 estimates of farmers' realized gross income, production expenses, and realized net income are all revised upward slightly in this issue. Realized gross income, now 38.3 billion dollars, and production expenses, 25.2 billion, both remain a record high. Realized net income at 13.1 billion dollars remains the highest in 5 years. However, the 1957 estimate of realized net income was revised upward a little more than the 1958 estimate, so the increase from 1957 to 1958 is now 19 percent instead of 20 percent as was indicated by the preliminary figures. But the percentage increase is still the largest since the war-time rise from 1942 to 1943. The revised 1958 estimate of per capita income of the farm population from all sources was practically unchanged; at \$1,066, it was the highest on record and 9 percent above 1957.

Annual and quarterly estimates of farm income from 1956 to date are revised in this issue (table 1). Estimates for 1955, also given in table 1, and for earlier years, are not revised. Revisions for the last 3 years incorporate the latest information on production and disposition of the various farm commodities. The pattern of change from year to year is not significantly affected, but revisions of some of the quarterly estimates are relatively large.

Previously published estimates for the first quarter of 1959 are revised slightly in table 1 to allow for revisions, discussed on page 55, in the estimates of cash receipts for the first 3 months of the year.

#### Cash receipts in the first half of 1959

Cash receipts from farm marketings in the first half of 1959 totaled approximately 13.9 billion dollars, only very slightly below the revised estimate for the same period in 1958. Prices received by farmers averaged 3 percent lower in 1959, while the volume of marketings was up nearly 3 percent.

The estimate of total cash receipts for the first 6 months of 1959 includes a preliminary estimate for June. It also includes some minor downward revisions in estimates previously published for the first 3 months of the year. Since estimates for the early months of 1958 were revised upward, cash receipts so far this year are now slightly below last year instead of slightly above as previously indicated.

Farmers received about 9.0 billion dollars from livestock and livestock products in the first half of 1959, or 3 percent less than in the same period of 1958. Receipts from cattle made a substantial gain, but receipts from hogs dropped sharply, so that the total for meat animals showed little change. Lower prices of hogs more than offset larger marketings, but higher prices for cattle more than compensated for lower volume. Receipts from poultry and eggs were down because of lower prices of eggs and chickens (including broilers). The January-June 1959 volume of marketings of livestock and products was up about  $2\frac{1}{2}$  percent from a year earlier because of larger marketings of hogs and record-breaking sales of broilers.

Crop receipts of 4.9 billion dollars were about 5 percent above the revised estimate for the first half of 1958, as increased marketings more than offset slightly lower prices. Movement to market of the record 1958 wheat crop was the principal factor in maintaining cash receipts above a year ago, but receipts from oranges, corn, and tobacco were up also. These increases were partly offset by smaller marketings of sorghum grain and lower average prices of potatoes.

Preliminary estimates for June 1959 indicate receipts from farm marketings of 2.3 billion dollars, up slightly from a year earlier. Receipts from livestock and products are tentatively estimated at 1.5 billion dollars, down about 4 percent. Receipts from crops are estimated at 0.8 billion dollars, 14 percent above June 1958, mostly due to the earlier wheat harvest this year.

Cash receipts in May came to 2.2 billion dollars, down slightly from the same month last year. May crop receipts were 0.6 billion dollars, livestock receipts nearly 1.6 billion.

#### VOLUME OF FARM MARKETINGS IN 1959

The volume of farm marketings is likely to reach a new high in 1959, 28 percent above the average for 1947-49 and 2 percent larger than last year's record volume. This estimate is based on conditions as of July 1, and assumes average weather and other growing conditions for the rest of the year. (See table 2 on the facing page).

Most of the increase over last year's sales volume is in the livestock items, with little if any gain for crops. A large pig crop is expected to increase hog marketings by about 12 percent. Increased production of poultry and eggs will likely increase the index number for that group by about 5 percent.

REVISIONS IN ANNUAL ESTIMATES OF  
FARM INCOME AND EXPENDITURES, 1956-58

The following tables carry the estimates of gross farm income, production expenses, net farm income, and related series back to 1910 on an annual basis for the United States as a whole. State estimates will appear in the next issue, for release on September 17.

For the years 1956-58, the various series in the tables reflect revisions resulting for the most part from the routine incorporation of final data for some of the components of gross income and production expenses. Also reflected are small downward adjustments in the estimates of rental value of farm dwellings, based on results of a recent survey relating the value of dwellings to the value of all land and buildings.

The net effect of the revisions has been a slight lowering of the estimate of farm operators' net income for 1956, and a slight increase for 1957. The preliminary 1958 estimate of farm operators' net income, published earlier this year, has also been raised slightly.

Estimates of average per capita income in table 7 are only very slightly revised for the farm population. For the nonfarm population, however, per capita income has been raised for each of the last three years. For example, average income per person in the nonfarm population is now estimated at \$2,066 in 1958 or \$32 higher than the preliminary estimate published in the February issue of this report. The higher estimates of nonfarm per capita income reflect rather substantial upward revisions in the Department of Commerce estimates of total nonagricultural income.

Revisions in estimates for years prior to 1956 were made only in tables 8 and 10 on pages 40 and 42. In table 8, "Income of farm and factory workers," the second column on number of farm workers has been revised back to 1950, and the estimates of average annual farm income per worker have been revised accordingly. In table 10, "Purchasing power of net farm income," the price index numbers in the first column have been revised back to 1952, necessitating a revision of all the purchasing power estimates for the same period.

Food and nonfood commodity groups are expected to share proportionately in the increase in total farm marketings.

#### REVISED ESTIMATES OF CASH RECEIPTS

Revised estimates of cash receipts from farm marketings in 1957 and 1958 are given by commodities in table 23, beginning on page 28. This detailed table, which also shows value of individual farm products consumed directly in farm households, has been included in the July issue of The Farm Income Situation for several years. Estimates of monthly cash receipts, however, in line with the revised annual totals, are included in full detail in the July issue for the first time this year. Previously, most of the revised monthly estimates, including those for individual States, were not published until the September issue.

Revised monthly estimates of cash receipts by commodity groups for 1957 and 1958 are given in tables 13 and 15 on pages 14 and 15. Corresponding revisions in monthly index numbers are in tables 14 and 16 on the same pages. Revised monthly estimates of cash receipts from farm marketings in each State are given in tables 17-22, pages 16-27.

#### Revisions for the first quarter of 1959

Previously published monthly estimates of cash receipts from farm marketings for January-March 1959 are also revised in this issue. The revised estimates by commodity groups are given in table 3 on page 6, with corresponding index number revisions in table 4 on the same page. Revised estimates for each State appear in tables 7-9, pages 8-10. New estimates for April and May and revised cumulative totals through May are given on page 7 for commodity groups and on pages 11-13 for the individual States.

Revisions for the early months of 1959 were made so as to incorporate new information on the monthly pattern of farm marketings. Based in considerable part on the Crop Reporting Board's latest reports covering 1958 crop production and disposition, they are mostly in the crop component of cash receipts, although some minor changes have also been made in the livestock group.

The new estimate of cash receipts in the first quarter of 1959 is only 54 million dollars lower than the estimate previously published. An increase of 50 million dollars in the January estimate was more than offset by reductions of 21 and 83 million dollars for February and March, respectively. Although the national first quarter estimate is changed only three-quarters of one percent, revisions in some States are relatively large.
