



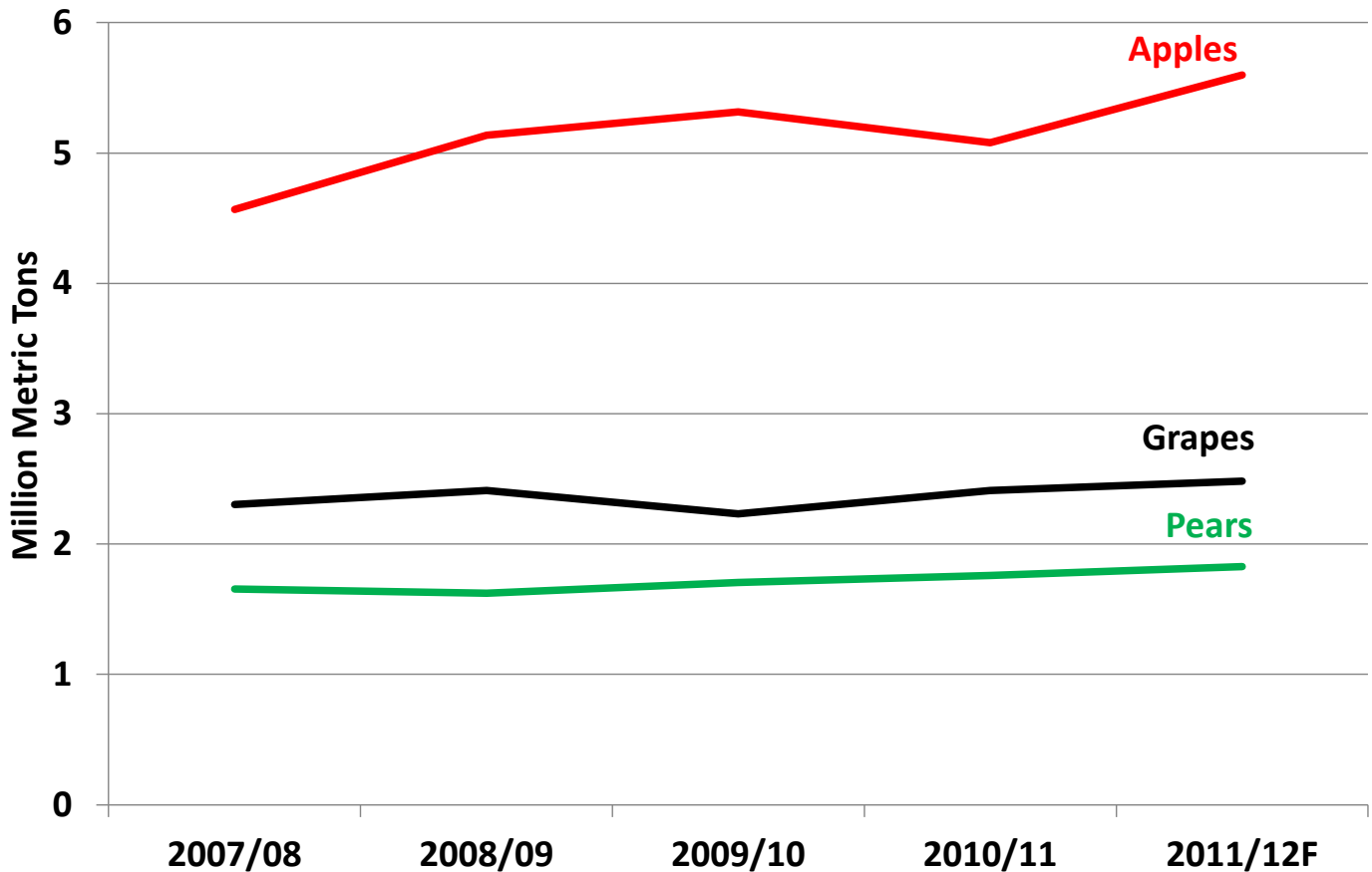

Fresh Deciduous Fruit (Apples, Grapes, & Pears): World Markets and Trade

Fresh Deciduous Fruit Exports at Record Levels



Global apple exports in 2011/12 are forecast to rebound 10 percent to a record 5.6 million metric tons (MT) primarily due to larger available supplies from the European Union and strong global demand. Additionally, global growth rates for both grapes and pears are forecast to expand slightly and are at record levels.

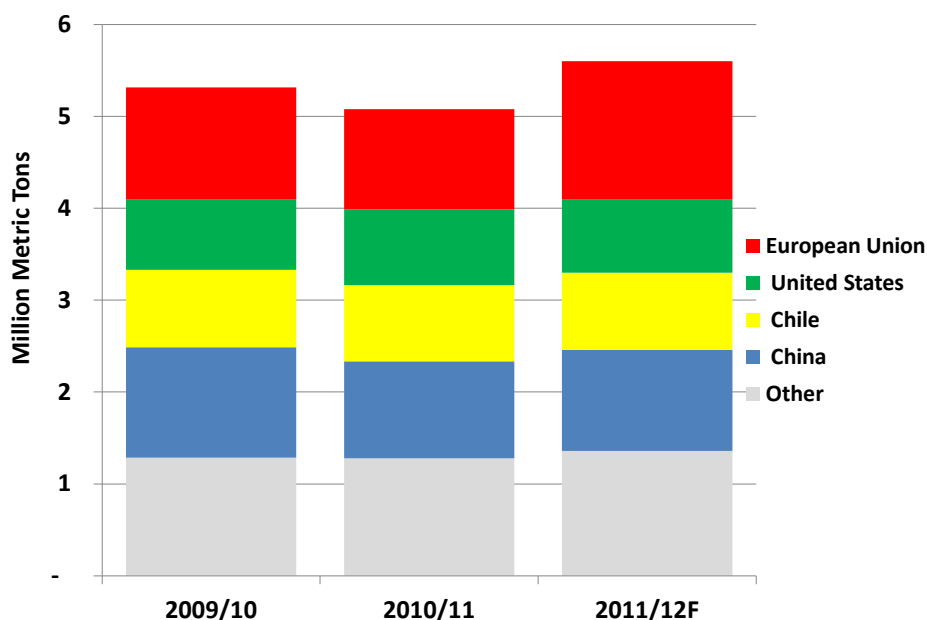
Apples

Global apple production for 2011/12 is forecast at a record 65.2 million metric tons (MT), up 4 percent from the previous year. China, which produces over half of the total, is forecast to rise 5 percent to a record 35.0 million MT. Although cool spring temperatures and excessive summer rains lowered expectations for Shandong and Shanxi, the second and fifth largest producing regions, gains in other provinces are forecast to more than offset these losses. The European Union is forecast nearly 10 percent higher as Poland rebounds from last year's dismal crop, with moderate gains expected in Italy and France. The United States is forecast up slightly as Michigan recovers from last year's spring frost.

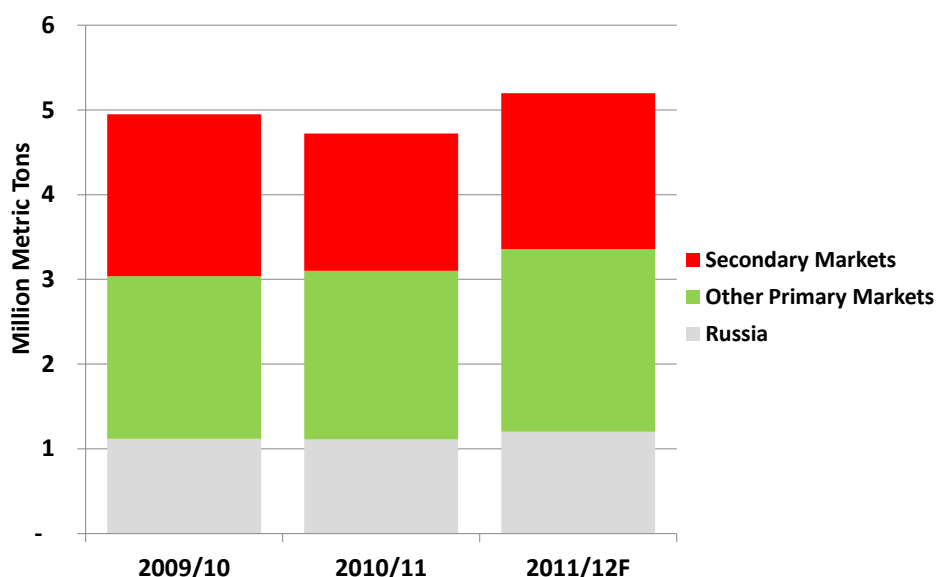
Global exports are forecast up 10 percent to a record 5.6 million MT. European Union shipments are expected to surge nearly 40 percent to 1.5 million MT on the strength of larger supplies, accounting for nearly all the global gain. China and Chile are expected to grow slightly on rising demand in Indonesia and Russia, while the United States is expected to contract modestly on reduced availability.

Russia is the largest importer and is expected to rise significantly as demand outpaces production gains. Nearly half of the global import growth is expected from secondary markets as more exportable supplies become available. Last year's short crop reduced imports for these markets.

Secondary Markets Boost Global Apple Imports

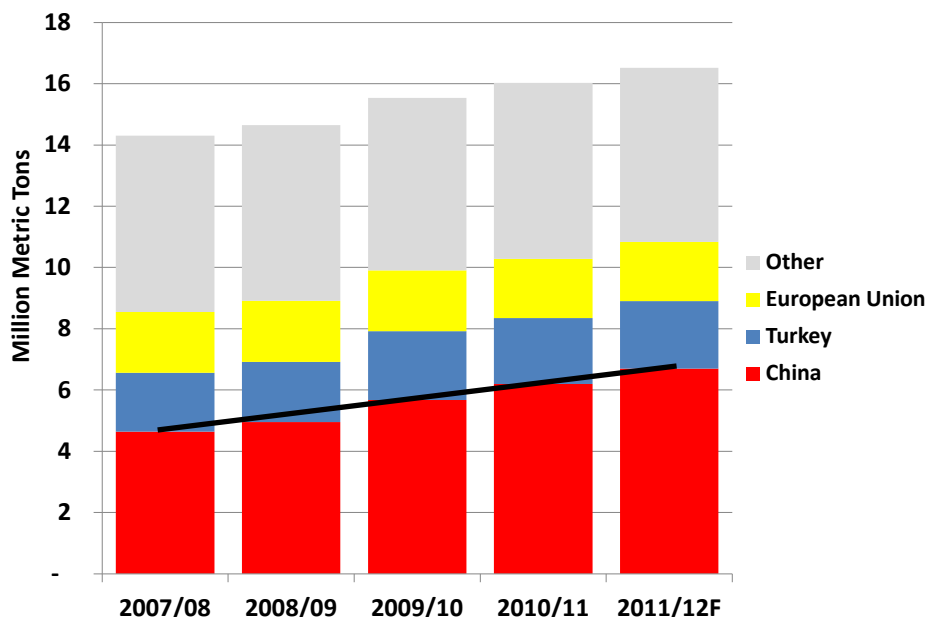

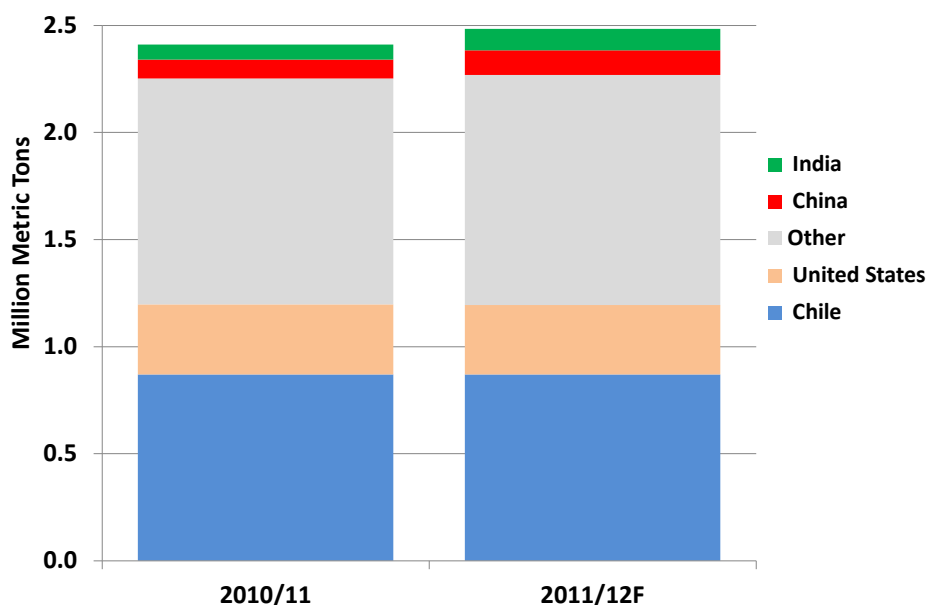
Grapes

Global grape production for 2011/12 is forecast at a record 16.5 million MT, up 3 percent from the previous year. China, which produces over 40 percent of the total, is forecast to rise 8 percent to a record 6.7 million MT, primarily on a continuation of increased plantings. Profitable market returns are driving area expansion, particularly in Xinjiang, Hebei, Zhejiang, Gansu, Shaanxi, and Guangxi provinces. Turkey is forecast 2 percent higher to 2.2 million MT on favorable growing conditions following last year's heavy rains. Brazil and Europe are expected flat, while the United States is forecast to decline 6 percent to 851,000 MT due to California's reduced crop.

Global exports are forecast up 3 percent to a record 2.5 million MT. China and India are expected to rise, while Chile and the United States are forecast flat on reduced exportable supplies.

Strong demand from the United States and China spur the growth in global imports.

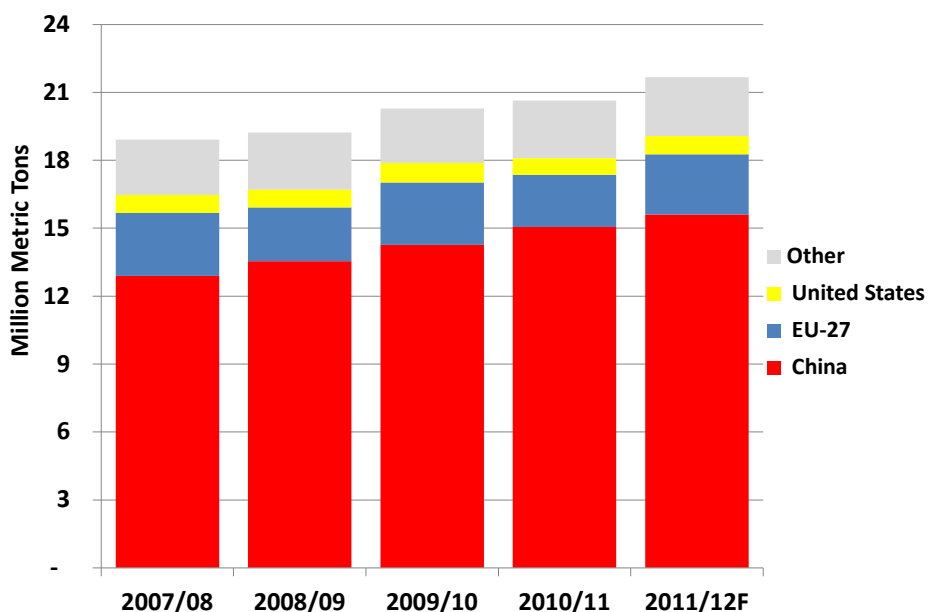
Pears

Global pear production for 2011/12 is forecast at a record 21.7 million MT, up 5 percent from the previous year. China, which produces over 70 percent of the total, is forecast to rise 4 percent to a record 15.6 million MT as a higher yield offsets a decline in area. Weak prices over the last several years have prompted some farmers to switch to other crops such as grapes, cherries or nectarines. The European Union is forecast to jump 15

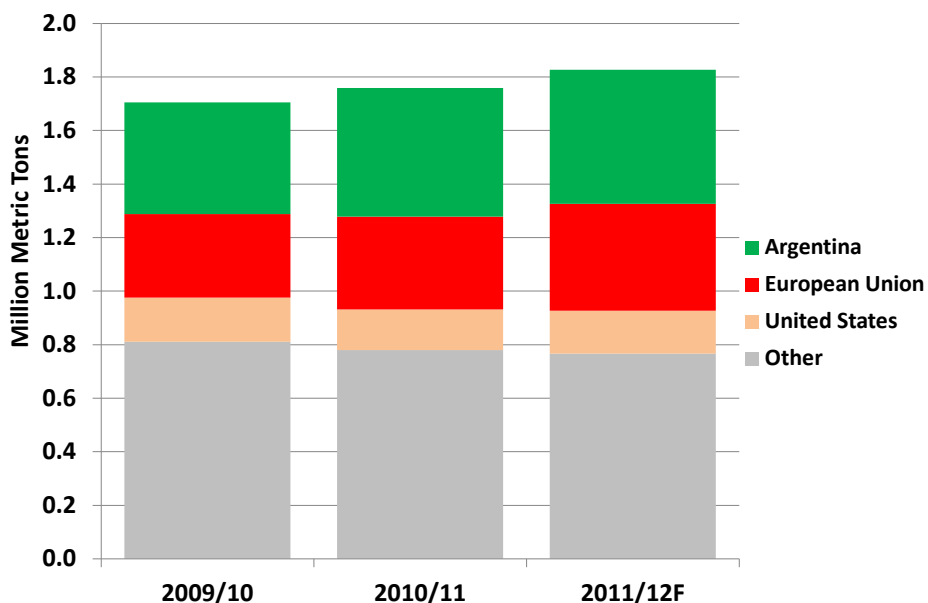
percent to 2.7 million MT on favorable weather following last year's damaging rains in Italy. The United States is forecast 9 percent higher to over 800,000 MT following a good bloom and fruit set in most growing regions.

Global exports are forecast up 4 percent at a record 1.8 million MT. With opposite seasons, Argentina and Europe are forecast to expand shipments, primarily to Brazil and Russia. China's exports are expected to decline 5 percent as a result of rising domestic consumption. U.S. exports are forecast 6 percent higher on stronger shipments to Canada and Mexico.
