

#### September 1 Hop Stocks Up 20 Percent Over A Year Ago

The inventory of hops held by growers, dealers, and brewers on September 1, 2002, totaled 65.0 million pounds, 20 percent above September 1, 2001, and 35 percent greater than September 1, 2000.

Stocks held by brewers, at 35.0 million pounds, were 8 percent less than September 1, 2001, and 7 percent below September 1, 2000. Stocks held by growers and dealers on September 1, 2002, were 30.0 million pounds, nearly double the stocks on hand last year, and nearly triple the hop stocks held two years ago.
