## Northeast Blueline Tilefish Fishery

**Emergency Management Measures** 

Effective date: June 4, 2015

We have implemented emergency measures for the Greater Atlantic Region's blueline tilefish fishery in response to a request from the Mid-Atlantic Fishery Management Council. These temporary measures are needed to constrain the expansion of the previously unregulated Greater Atlantic blueline tilefish fishery while the Mid-Atlantic and South Atlantic Councils develop long-term management plans. The emergency regulations apply to vessels fishing for blueline tilefish in Federal waters north of the latitude of the Virginia/North Carolina border (36° 33' 01.0" N. lat.). Here are the measures:

### For Charter/Party Vessels

- Now must hold a valid Greater Atlantic Region open access tilefish charter/party vessel permit to possess or land blueline tilefish, and must follow all recordkeeping and reporting requirements.
- The recreational possession limit for charter/party and private recreational anglers is **seven blueline tilefish per person, per trip**.

#### For Commercial Vessels

- Must hold a valid Greater Atlantic Region open access commercial tilefish vessel permit to possess or land blueline tilefish, and must follow all recordkeeping and reporting requirements.
- The commercial blueline tilefish possession limit is **300 lb whole weight per trip**.

### Additional Information

- None of these measures modify existing regulations for golden tilefish or any other fisheries.
