The following measure(s) were previously heard on Tuesday, January 31, 2017.

HB 223 Status	RELATING TO THE RESIDENTIAL LANDLORD-TENANT CODE.  Allows a landlord, when processing an application to rent residential property, to charge an application screening fee for the actual cost of screening the applicant. Requires landlords to refund any unused amount of the application screening fee and, upon request, provide a receipt of the fee and a copy of any report obtained via the screening process to the applicant. HB 396 Status	RELATING TO THE HAWAII PUBLIC HOUSING AUTHORITY. Allows the Hawaii Public Housing Authority to evict a tenant if the tenant is convicted of a misdemeanor or felony related to the Authority's property or funds.	HSG, JUD
HB 534 Status	RELATING TO THE HAWAII PUBLIC HOUSING AUTHORITY. Appropriates moneys for the HPHA to hire an additional security guard at Kalihi Valley homes.	HSG, FIN
HB 829 Status	RELATING TO PUBLIC HOUSING. Requires the Hawaii Public Housing Authority to document prohibited acts of smoking and retain all violations on a resident's record permanently.	HSG, JUD
HB 1009 Status	RELATING TO THE LANDLORD TENANT CODE.  Allows a landlord to restrict access to a dwelling unit for failure to pay rent or when the tenant quits the premises. Requires landlord to provide access to tenant for a period of one day to remove personal	HSG, JUD
