DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Fotheringay is a two-story brick structure with a projecting two-level provincial type portico on the west front. As originally built, the facade of the house was only three bays with the portico covering the front door in the southernmost bay. It was a traditional belief that the facade was intended to be symmetrical. However, the house stood in its original form until the late-1950's when the south end of the facade was extended for two more bays, thus making it symmetrical. It should be noted that all of the architectural details in the original portion of the house, such as the modillion and dentil cornice, Flemish bond brickwork, splayed stuccoed lintels with keystones, exterior end chimney and hipped roof were carefully reproduced in the new section.

At the same time, the deep two-story ell on the rear of the house was renovated, a later addition was removed from the rear of the ell, and the end rebuilt. The present pedimented gable end and large fan light window in the pediment date from the rebuilding. A two-level porch once located on the north side of the ell was removed earlier in the century.

The original interior woodwork in Fotheringay is most elaborate and very finely executed. The stairhall and drawing room feature Adamesque decoration, including modillion and dentil cornices, swags in the entablatures over the doorways, and reeded chair rails. The drawing room chimney-piece is unusually rich with its broken pediment overmantle flanked by carved scrolls. Original woodwork also survives in the upstairs hall and bedrooms. The trim in the dining room is largely modern but in the style of the house.

Fotheringay is dramatically situated on a steep knoll overlooking the bottom land of the south fork of the Roanoke River. Behind the knoll sharply rise the Blue Ridge Mountains, forming an impressive backdrop for the house. Against the base of the mountains and in view of the house stands the triangular-shaped stone tomb of Col. Hancock and several members of his family.

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

Fotheringay was probably built soon after 1796 when Colonel George Hancock bought the property from Colonel Joseph Kent who had acquired the land in 1793 from William Robinson whose home and tavern were located there. George Hancock (1754-1820) served as a Colonel of the Virginia Line in the Revolutionary War and was aide-de-camp to Count Kasimir Pulaski. He represented Botetourt County in the Virginia House of Delegates from 1784 until 1792 and was the first citizen of Botetourt County to serve in the United States Congress, being a member of the Third and Fourth United States Congress. Colonel Hancock's daughter, Julia, married General William Clark of the Lewis and Clark Expedition.

Fotheringay is one of the finest post-colonial plantation houses in southwestern Virginia. Its elaborate interior woodwork is unusually fine for both its time and location. Fotheringay further stands as a rare example where modern additions and alterations have significantly enhanced the appearance of a structure. However, it should be noted that the additions fulfilled what obviously must have been the intentions of the original builder.

Fotheringay's commanding location and associations with one of the leading citizens of the area make it one of the major historic landmarks of southwestern Virginia.

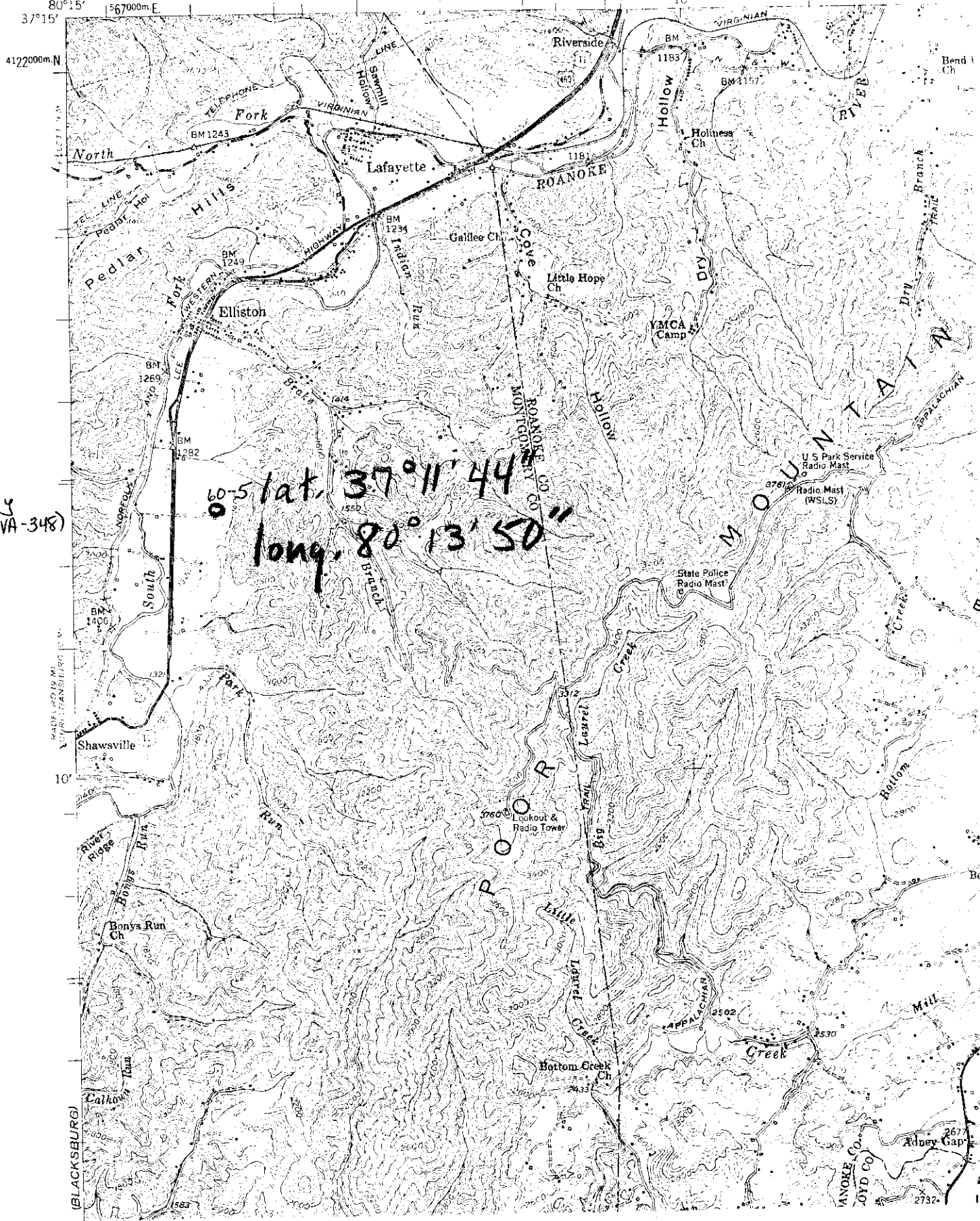
