

House Bill 570 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act to incorporate the City of Milton in Fulton County, Georgia, approved
2 March 29, 2006 (Ga. L. 2006, p. 3554), as amended, particularly by an Act approved May 7,
3 2013 (Ga. L. 2013, p. 4401), so as to change the description of the election districts; to
4 provide for related matters; to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 style="text-align:center">**SECTION 1.**

7 An Act to incorporate the City of Milton in Fulton County, Georgia, approved March 29,
8 2006 (Ga. L. 2006, p. 3554), as amended, particularly by an Act approved May 7, 2013
9 (Ga. L. 2013, p. 4401), is amended by revising paragraph (1) of subsection (c) of
10 Section 2.11 as follows:

11 "(c)(1) For the purpose of electing members of the council, the City of Milton shall
12 consist of three council districts which shall be and correspond to those three numbered
13 districts described in and attached to and made a part of this Act and further identified as
14 'Plan: miltoncc-2015-p1 Plan Type: Local Administrator: H047 User: Gina' which are
15 also described in Appendix B of this charter, which appendix is attached and incorporated
16 into this charter by reference. Each candidate for election to the council other than the
17 mayor must reside in the council district he or she seeks to represent, but such districts
18 shall be residency districts only and not voting districts. All elections for all
19 councilmembers shall be at-large by the voters of the entire city."
