## Representative District 109

(Encompasses the entirety of Clay, Edwards, Jasper, Richland, Wabash, Wayne and White Counties, and partially within Effingham and Lawrence Counties):

Representative District 109 shall include that part of Illinois

beginning at the intersection of N 1800<sup>th</sup> St and the Cumberland/Effingham County borders,

thence east along the Cumberland/Effingham County borders,

thence continuing east along the north borders of Effingham and Jasper Counties to the northeast corner of Jasper County,

thence south along the east border of Jasper County to Richland County,

thence east along the north border of Richland County and continuing east along the north border of Lawrence County to the northeast corner of Petty Twp,

thence south along the east border of Petty Twp to the southwest corner of Bond Twp,

thence east along the south border of Bond Twp to the Embarras River,

thence southeast along the Embarras River to the east border of Section 27, T4N, R12W (2<sup>nd</sup> principal meridian),

thence north along the east borders of Sections 27 and 22, T4N, R12W (2<sup>nd</sup> principal meridian) to 1320 N,

thence east along 1320 N to 1020 E,

thence south and southeast along 1020 E for approximately 1.35 miles,

thence south to the Embarras River,

thence southeast along the Embarras River to 1100 E,

thence south along 1100 E for approximately 2700 feet,

thence west for approximately 180 feet,

thence south for approximately 125 feet,

thence east for approximately 180 feet to 1100 E,

thence south along 1100 E to US-50,

thence southwest along US-50 to east border of Section 35, T4N, R12W (2<sup>nd</sup> principal meridian),

thence south along the east border of Section 35, T4N, R12W (2<sup>nd</sup> principal meridian), and continuing south along the east border of Section 2, T3N, R12W (2<sup>nd</sup> principal meridian) to Alt US-50,

thence northeast along Alt US-50 for approximately 400 feet,

thence southeast for approximately 275 feet,

thence southwest for approximately 1300 feet,

thence southeast for approximately 2175 feet to Old Porter Rd,

thence northeast along Old Porter Rd for approximately 450 feet,

thence southeast for approximately 2000 feet,

thence east for approximately 360 feet,

thence south for approximately 850 feet to Orchard St,

thence northeast approximately 620 feet along Orchard St,

thence east approximately 1100 feet to 13<sup>th</sup> St,

thence east along 13<sup>th</sup> St to 13<sup>th</sup> St (extended) to Crackel St,

thence continuing east approximately 420 feet to a point approximately 80 feet east of 11<sup>th</sup> St, thence north running parallel to 11<sup>th</sup> St and continuing north across the CSX rail line to Pine St (extended),

thence east for approximately 900 feet,

thence north for approximately 675 feet to a point approximately 40 feet south of Hickory St,

thence east for approximately 1530 feet,

thence north for approximately 40 feet,

thence east for approximately 1000 feet,

thence north for approximately 1300 feet,

thence east for approximately 1400 feet to Bus US-50,

thence southeast along Bus US-50 to 1330 E,

thence north on 1330 E to 1040 N,

thence east on 1040 N to 1340 E,

thence south along 1340 E to Bus US-50,

thence east along Bus US-50 to 1400E,

thence north along 1400E to Rt. 16,

thence east along Rt. 16 to the Allison Twp border,

thence north along the west border of Allison Twp to the northwest corner of Allison Twp,

thence east along the north border of Allison Twp to the west border of Section 19, T4N, R10W (2<sup>nd</sup> principal meridian),

thence south along the east border of Section 19, T4N, R10W (2<sup>nd</sup> principal meridian) to the north border of Section 30, T4N, R10W (2<sup>nd</sup> principal meridian),

thence east along the north border of Section 30, T4N, R10W (2<sup>nd</sup> principal meridian) to the southwest corner of Russell Twp,

thence east along the south border of Russell Twp to the Indiana border,

thence south along the Indiana border to the southeast corner of White County,

thence west along the south border of White County to the southeast corner of Hamilton County, thence north along the east border of Hamilton County to the northeast corner of Hamilton County, thence west along the north border of Hamilton County to the southwest corner of Wayne County, thence north along the west borders of Wayne and Clay Counties to the northwest corner of Clay County,

thence east along the north border of Clay County to the southwest corner of Union Twp in Effingham County,

thence north along the west border of Union and Watson Twps to the northwest corner of Watson Twp, thence east along the north border of Watson Twp to the southwest corner of St. Francis Twp,

thence north along the west border of St. Francis Twp to E. 1400<sup>th</sup> Av,

thence west along E 1400<sup>th</sup> Av for approximately 4000 feet,

thence north approximately 2610 feet to W. Southern Row,

thence southwest along W. Southern Row to S. Race St,

thence north along S. Race St to W. Water St,

thence east along W. Water St to N. Washington St,

thence south along N. Washington St to W. Walnut St,

thence east along W. Walnut St to N. Wall St,

thence north along N. Wall St to W. Water St,

thence east along W. Water St to N. Garrett St,

thence south along N. Garrett St to E. Walnut St,

thence east along E. Walnut St to N. John St,

thence north along N. John St to Salt Creek,

thence east along Salt Creek to N. 1800<sup>th</sup> St,

thence North along N. 1800<sup>th</sup> St to the point of beginning.
