FARM PRODUCTION AND INCOME, TURKEYS, 1939-40

Turkey production in 1940 was 33,052,000 birds, an increase of 2 percent over the 1939 production, 53 percent above the 10-year (1929-38) average and 37 percent above the 5-year (1934-38) average production. Increases over 1939 were noted in all sections of the country except the South Central and Western States, both of which show slight decreases. The largest gain was 11 percent in the East North Central States.

The proportions of the United States crop produced in the different areas totaled 32 percent in the West North Central States, 24 percent in the West, 19 percent in the South Central, 11 percent in the East North Central, 8 percent in the South Atlantic and 6 percent in the North Atlantic States.

Consumption by Producers Smaller: Turkey producers consumed 1,774,000 turkeys in their households in 1940, or 5 percent of the number produced. The consumption in producers' households was 7 percent below the record high consumption of last year, but 15 percent above the 10-year average and 12 percent above the 5-year average of such consumption. Of the total consumption of turkeys by producers in 1940, 29 percent was in the West North Central States, 27 percent in the South Central, 20 percent in the West, 10 percent in the South Atlantic, 9 percent in the East North Central and 5 percent in the North Atlantic States.

Turkey Sales Largest of Record: About 32,815,000 turkeys were sold from farms in 1940, the largest number ever sold in this country in a single year. Sales during 1940 were 16 percent above those in 1939, 65 percent above the 10-year average and 46 percent above the 5-year average sales. About 5 million of the birds sold in 1940 were late market birds carried over from 1939 and sold during the first few months of the year.

The average price of \$2.33 per head for turkeys sold from farms in 1940 was 1 percent below the 1939 price, 6 percent below the 10-year average and 9 percent below the 5-year average price. -- it was the lowest price since 1936 when turkeys sold at \$2.32 per head. However, the lowest prices of the year were those paid for the birds carried over from the 1939 crop and sold in the early months of 1940. These were sold at about 14 cents per pound. The prices for the new crop, beginning in September at 14.3 cents or 1.1 cents below corresponding 1939 levels, rose to 17 cents in October, 15.5 in November and 15.9 in December, when they stood 0.3 cents above December 1939 levels.

Cash Income Reaches Record High Point: Cash income from sales of turkeys in 1940 was \$76,345,000 compared with \$68,125,000 in 1939. Although the price per bird in 1940 was below the 1939 average price, the increase in number of birds sold was enough to bring cash income to a record high point, 58 percent above the 10-year average and 34 percent above the 5-year average cash income.

Gross income which is income from sales combined with the value of turkeys consumed in the households of farm turkey producers, also reached a record high in 1940. Gross income was \$80,370,000, which is 11 percent above the previous year, 21 percent above the 10-year average and 32 percent above the 5-year average gross income.

Per Capita Production: The per capita production of turkeys in the United

the 1939 per capita production, and exceeded the 10-year average by 55 percent and the 5-year average by 36 percent. The largest per capita production -- 11.33 pounds -- was in the West North Central States, which accounted for 32 percent of the total production. The West with the next highest per capita production of 8.95 pounds, produced 24 percent. The smallest per capita production of .89 pounds was in the North Atlantic States which produced only 6 percent of the United States turkeys.

Weight per Bird Increasing: Since 1929 there has been a gradual increase in the weight per turkey sold. In 1938 the weight averaged 14.9 pounds. Birds produced in 1939 were heavier, but so many of the heavier birds were carried over into 1940 that the average weight of birds sold in 1939 was the same as in 1938 or 14.9 pounds. In 1940 the weight per bird sold was 15.1 pounds. Part of this increase was due to the large supply of heavy birds carried over from 1939 and some of it resulted from the unusually large proportion of the heavy birds of 1940 that were marketed before the close of the year. The 10-year (1929-38) average weight was 14.1 pounds and the 5-year (1934-38) average was 14.6 pounds.

During 1939 the price differential between light and heavy-weight turkeys was not sufficient to provide a proper balance of sales of each, with the result that at the end of the year 65 percent of the holdings of frozen turkeys in cold storage consisted of birds weighing 16 pounds and over. In order to remove record-breaking stocks of 65,329,000 pounds of frozen turkeys in storage on February 1, 1940, an organized effort was made by the turkey industry, Federal and State agencies and retail distributors to expand the outlets for heavy-weight birds. By late summer, storage supplies had been reduced to a more normal seasonal level. By establishing price differentials between light and heavy-weight birds in 1940 more favorable to the sale of heavy birds, the trade was able to move a larger proportion of the heavy-weight birds than the light-weight birds during the main marketing season. A recent inquiry showed that on February 1, 1941 only about 41 percent of the non-eviscerated turkeys in cold storage were made up of birds weighing 16 pounds or over. Of the increasing supply of eviscerated turkeys in cold storage on February 1, 56 percent weighed 16 pounds and over, but these eviscerated birds made up only 13 percent of the total supply.

It is quite evident that while the family trade prefers a smaller bird at the same price per pound as for a heavier bird, a proper price differential will move many of the heavier birds through that channel.

Inventories Down 18 Percent: Turkeys on farms January 1, 1941 were estimated in February to number 7,030,000, which was 18 percent less than a year earlier, but 18 percent above the 10-year (1930-39) average January 1 holdings. On January 1, 1940 the 8,567,000 turkeys on hand included an unusually large farm carry-over of birds for January and later marketing. The big reduction in numbers on January 1, 1941 was the result of the much smaller carry-over of both market birds and breeders.

Turkeys on farms January 1, 1941 had an average value of \$2.30 per head compared with \$2.18 a year earlier and \$2.31 for the 10-year January 1 average. The total inventory value of turkeys on January 1 was \$16,178,000, which was 13 percent below the value of holdings a year earlier but 19 percent above the 10-year average and 10 percent above the 5-year (1935-39) average value.

Turkey numbers on January 1, 1941 were considerably below numbers on hand a year earlier in all parts of the country, due to the heavy carry-over of market birds into 1940 in contrast to a normal carry-over at the beginning of this year.
