The United Nations Temporary Authority in West Irian (UNTEA) was formed to administer West Irian, which is located on the island of New Guinea. In 1963 Dutch New Guinea became Irian Barat, which in 1973 changed its name to Irian Jaya and is currently administered by Indonesia.

UNTEA administered West Irian from October 1962 to May 1963. The administrator was Dialal Abdoh.

Scope and Content

Included are files of the Temporary Administrator, Djalal Abdoh; of the Deputy Administrator; of the Legal Advisor and the Principal Legal Advisor; and of UNTEA departments including Cultural Affairs, Social Affairs and Justice, Economic Affairs, Finance, Health, Traffic Power and Communications, Internal Affairs, and Public Affairs, 1962-1963.

These contain primarily correspondence and include cables, speeches, minutes, agendas, reports, staff lists, press releases, press clippings, directives, information circulars, decrees, agreements, contracts, claims, and other legal documents, all dealing with the UNTEA's task of administering West Irian.
