Professor Crawford has extensive practice in international law and international arbitration, appearing before the International Court of Justice (ICJ), and International Tribunal for the Law of the Sea, as well as investor-state arbitral tribunals composed under the International Centre for Settlement of Investment Disputes (ICSID) Convention or ad hoc under the United Nations Commission on International Trade Law rules. He has been an arbitrator in ICSID and ad hoc arbitrations as well as in interstate cases. He has held chairs in international law at Adelaide, Sydney, La Trobe and Cambridge Universities. He served on the Australian Law Reform Commission and the International Law Commission, where he was responsible for an early draft of the *Statute of the International Criminal Court*.
