## Broiler Eggs Set In 15 Selected States Up 4 Percent

Commercial hatcheries in the 15-State weekly program set in incubators 182 million eggs during the week ending March 27, 1999. This was up 4 percent from the eggs set the corresponding week a year earlier. Average hatchability for chicks hatched during the week was 82 percent. Average hatchability is calculated by dividing chicks hatched during the week by eggs set three weeks earlier.

## Broiler Chicks Placed Up 3 Percent

Broiler growers in the 15-State weekly program placed 146 million chicks for meat production during the week ending March 27, 1999. Placements were up 3 percent from the comparable week in 1998. Cumulative placements from January 3, 1999 through March 27, 1999 were 1.72 billion, up 3 percent from the same period a year ago.
