## Broiler Eggs Set In 15 Selected States <br> Down 2 Percent

Commercial hatcheries in the 15-State weekly program set in incubators 176 million eggs during the week ending November 18, 2000. This was down 2 percent from the eggs set the corresponding week a year earlier. Average hatchability for chicks hatched during the week was 82 percent. Average hatchability is calculated by dividing chicks hatched during the week by eggs set three weeks earlier.

## Broiler Chicks Placed Down 5 Percent

Broiler growers in the 15 -State weekly program placed 129 million chicks for meat production during the week ending November 18, 2000. Placements were down 5 percent from the comparable week in 1999. Cumulative placements from January 2, 2000, through November 18, 2000, were 6.62 billion, up 1 percent from the same period a year earlier.
