## Broiler-Type Eggs Set In 19 Selected States Down 1 Percent

Commercial hatcheries in the 19-State weekly program set 187 million eggs in incubators during the week ending October 17, 2009. This was down 1 percent from the eggs set the corresponding week a year earlier. Average hatchability for chicks hatched during the week was 84 percent. Average hatchability is calculated by dividing chicks hatched during the week by eggs set three weeks earlier.

## Broiler Chicks Placed Down 2 Percent

Broiler growers in the 19-State weekly program placed 160 million chicks for meat production during the week ending October 17, 2009. Placements were down 2 percent from the comparable week a year earlier. Cumulative placements from December 28, 2008 through October 17, 2009 were 7.02 billion, down 5 percent from the same period a year earlier.
