## Broiler-Type Eggs Set In 19 Selected States Down Slightly

Commercial hatcheries in the 19-State weekly program set 200 million eggs in incubators during the week ending December 5, 2009. This was down slightly from the eggs set the corresponding week a year earlier. Average hatchability for chicks hatched during the week was 84 percent. Average hatchability is calculated by dividing chicks hatched during the week by eggs set three weeks earlier.

## Broiler Chicks Placed Up Slightly

Broiler growers in the 19-State weekly program placed 166 million chicks for meat production during the week ending December 5, 2009. Placements were up slightly from the comparable week a year earlier. Cumulative placements from December 28, 2008 through December 5, 2009 were 8.12 billion, down 4 percent from the same period a year earlier.
