## Broiler-Type Eggs Set In 19 Selected States Down 2 Percent

Commercial hatcheries in the 19-State weekly program set 201 million eggs in incubators during the week ending January 16, 2010. This was down 2 percent from the eggs set the corresponding week a year earlier. Average hatchability for chicks hatched during the week was 83 percent. Average hatchability is calculated by dividing chicks hatched during the week by eggs set three weeks earlier.

## Broiler Chicks Placed Down Slightly

Broiler growers in the 19-State weekly program placed 167 million chicks for meat production during the week ending January 16, 2010. Placements were down slightly from the comparable week a year earlier. Cumulative placements from January 3, 2010 through January 16, 2010 were 334 million, down 1 percent from the same period a year earlier.
