## Broiler-Type Eggs Set In 19 Selected States Up 4 Percent

Commercial hatcheries in the 19-State weekly program set 208 million eggs in incubators during the week ending March 20, 2010. This was up 4 percent from the eggs set the corresponding week a year earlier. Average hatchability for chicks hatched during the week was 83 percent. Average hatchability is calculated by dividing chicks hatched during the week by eggs set three weeks earlier.

## Broiler Chicks Placed Down Slightly

Broiler growers in the 19-State weekly program placed 170 million chicks for meat production during the week ending March 20, 2010. Placements were down slightly from the comparable week a year earlier. Cumulative placements from January 3, 2010 through March 20, 2010 were 1.84 billion, down slightly from the same period a year earlier.
