| Situation:  | <ul> <li>and lake levels have dropped to 894' feet. After evaluating the erosion on the emergency spillway, a plan was put in place to prevent further erosion. Utilizing trucks and helicopters, crews moved large rocks and gravel to fill erosion on the emergency spillway. DWR staff continues to inspect and evaluate the emergency and primary spillways for further erosion.</li> <li>Total discharges from the reservoir remain consistent with flood control releases at this time of year under these weather conditions.
