Oregon Trail Interpretive Center at Flagstaff Hill brings to life aspects of the Oregon Trail experience

through living history demonstrations, interpretive programs, exhibitions, and special events. Part of the BLM's National Landscape Conservation System, this 500 acre interpretive site presents an experience that captures the American spirit and the essential fabric of the West.

The Center is located at 22267 Hwy 86, five (5) miles east of Baker City, Oregon. Easy access from I-84 and Hells Canyon Scenic Byway.

The Leo Adler Theater provides a venue for living history presentations, music, and educational programs. Permanent exhibit galleries transport visitors along the 2,000 mile journey of the Oregon Trail. Special exhibitions in the Flagstaff Gallery explore a variety of themes related to westward migration and settlement.

An outdoor pioneer wagon encampment comes to life for special events, and a replica stamp mill complements the historic gold mine located at Flagstaff Hill (summer only). One mile of Oregon Trail ruts carved by pioneer wagons are located onsite, and are part of a four mile interpretive hiking trail system. Trails and picnic areas at the Interpretive Center offer scenic vistas of the Blue Mountains, the Wallowa Mountains, and Baker Valley.

The National Historic Oregon Trail Interpretive Center (NHOTIC) is managed by the Department of the Interior, Bureau of Land Management in partnership with Trail Tenders, Inc. a not-for-profit volunteer organization.

## **Visitor Services**

All Interpretive Center facilities are fully accessible, with barrier-free parking and trail access and closed-captioned videos. Wheelchairs and strollers are available for guest use. We suggest that you allow at least one hour for a self-guided tour of the exhibits, and an additional one to three hours to enjoy an interpretive program or a stroll down to the historic Oregon Trail ruts. Trail maps are available at the information desk.

A covered picnic area and vending machines are available on site, and you will find many dining options in nearby Baker City. Please note that due to fire safety restrictions and frequent wind gusts, smoking is prohibited anywhere on the site, except in your enclosed vehicle.
