LOCAL GOVERNMENT ACT 1934 SECTIONS 7 AND 14: AMALGAMATION OF THE CORPORATION OF THE CITY OF KENSINGTON AND NORWOOD, THE CORPORATION OF THE TOWN OF ST. PETERS AND THE CORPORATION OF THE CITY OF PAYNEHAM

Proclamation By The Governor

(L.S.) E. J. NEAL

PURSUANT to sections 7 and 14 of the Local Government Act 1934 and with the advice and consent of the Executive Council, I—

- 1. Amalgamate the Corporation of the City of Kensington and Norwood, the Corporation of the Town of St. Peters and the Corporation of the City of Payneham to form a single council ("the new council").
- 2. Declare that the area of the new council will be the whole of the areas of the Corporation of the City of Kensington and Norwood, the Corporation of the Town of St. Peters and the Corporation of the City of Payneham as in existence immediately before the amalgamation.
- 3. Determine that the new council will be a municipal council.
- 4. Assign to the area of the new council the name "Norwood, Payneham and St. Peters".
- 5. Assign to the new council the name "The Corporation of the City of Norwood, Payneham and St. Peters".
- 6. Determine that the new council will have a mayor and 15 councillors
- 7. Determine that the area of the new council will be divided into seven wards, the names and boundaries of which are set out in schedules 1 to 7 (inclusive).
- 8. Determine that the number of councillors to be elected for each ward will be as follows:

East Adelaide and Hackney Ward
Stepney and Maylands Ward

Torrens Ward

Payneham Ward

Trinity Ward
Norwood/Kent Town Ward
Kensington Ward
2

- 9. Determine that the membership of the council is not to include aldermen.
- 10. Determine that the elections to determine the first members of the new council will be held on 1 November 1997.
- 11. Determine that, for the purposes of the elections to be held pursuant to clause 10-
 - (a) Nigel Saunders will be responsible for the preparation and maintenance of the voters roll, the voters roll must be prepared so as to differentiate the electors on the roll according to the wards referred to in the schedules and so as to reflect entitlements to enrolment as if the new council was in existence on the second Thursday of August in 1997, and a person whose name appears on that roll will be regarded as an elector for the new council; and

- (b) the Electoral Commissioner will be the returning officer and a person nominated by the Electoral Commissioner will be the deputy returning officer; and
- (c) the returning officer will appoint voting places and places for the counting of votes for the purposes of the election; and
- (d) the principal office of the council will be taken to be situated at the principal office of the Corporation of the City of Kensington and Norwood at Norwood; and
- (e) the elections will otherwise be conducted in accordance with the Local Government Act 1934.
- 12. Declare that the method of counting votes to apply at elections of the new council will be the method set out in section 121(4) of the *Local Government Act 1934*.
- 13. Declare that, for the period between 24 April 1997 and 31 October 1997 (inclusive), section 94 of the *Local Government Act 1934* applies to the Corporation of the City of Kensington and Norwood, the Corporation of the Town of St. Peters and the Corporation of the City of Payneham with the following modifications:
 - (a) subsection (1) of that section is struck out and the following subsections are substituted:
 - General elections to determine the membership of the council will not be held.
 - (1a) The terms of office of the members of the council holding office immediately before the first Saturday of May in 1997 are extended so as to expire on 31 October 1997.;
 - (b) subsection (2a) of that section is struck out and the following subsection is substituted:
 - (2a) If a casual vacancy in the office of a member of the council occurs between 24 April 1997 and 31 October 1997 (inclusive), the vacancy will not be filled.
- 14. Declare that a declaration under section 96(12) of the Local Government Act 1934 declaring elected a candidate standing for election to the Corporation of the City of Kensington and Norwood, the Corporation of the Town of St. Peters or the Corporation of the City of Payneham on the first Saturday of May in 1997 has no force or effect.
- 15. Declare that the method of assessing rateable land in the area of the new council will be the method based on the capital value of land.
 - 16. Declare that, until revoked by the new council-
 - (a) the by-laws of the Corporation of the City of Kensington and Norwood (as in force immediately before the amalgamation) will be taken to be by-laws of the new council applying in that part of its area that, immediately before the amalgamation, constituted the Corporation of the City of Kensington and Norwood; and
 - (b) the by-laws of the Corporation of the Town of St. Peters (as in force immediately before the amalgamation) will be taken to be by-laws of the new council applying in that part of its area that, immediately before the amalgamation, constituted the Corporation of the Town of St. Peters; and
 - (c) the by-laws of the Corporation of the City of Payneham (as in force immediately before the amalgamation) will be taken to be by-laws of the new council applying in that part of its area that, immediately before the amalgamation, constituted the Corporation of the City of Payneham.
- 17. Declare that, until otherwise determined by the new council, the new council will have the following corporate structure:
 - Chief Executive Officer's Office
 - Works and Technical Services
 - Corporate Services
 - Environmental Services
 - Community Services
 - Library Services
 - St. Peters Child Care Centre.

- 18. Appoint Mario Barone as the chief executive officer of the new council.
- 19. Appoint the following persons to the following positions on the staff of the new council:
 - (a) David John Williams—Manager Transition Programme;
 - (b) Pierino Perilli—Manager Works and Technical Services;
 - (c) John Clarence Reynolds-Manager Corporate Services;
 - (d) Annabel O'Connor—Manager, St. Peters Child Care Centre.

(subject to the qualification that an appointment will not take effect if a person appointed to an office under this clause is unavailable to take that office on 1 November 1997).

- 20. Declare that all other persons who are officers and employees of the Corporation of the City of Kensington and Norwood, the Corporation of the Town of St. Peters or the Corporation of the City of Payneham immediately before the amalgamation become officers and employees of the new council.
- 21. Declare that the transfers effected by clause 20 are without prejudice to any officer's or employee's salary, wage, superannuation benefits, accrued and accruing rights as to recreation leave, sick leave and long service leave and other conditions of employment (other than status).
- 22. Determine that, until otherwise determined by the new council—
 - (a) the principal office of the new council will be located at the premises that, as at the date of this proclamation, constitute the principal office of the Corporation of the City of Kensington and Norwood at The Parade, Norwood; and
 - (b) the new council will maintain other offices at premises of the Corporation of the Town of St. Peters (as constituted immediately before the amalgamation) at 101 Payneham Road, St. Peters and at premises of the Corporation of the City of Payneham (as constituted immediately before the amalgamation) at 196 O.G. Road, Felixstow.

23. Determine-

(a) that the new council will have three committees, one for each area that, immediately before the amalgamation, constituted the Corporation of the Town of St. Peters, the Corporation of the City of Kensington and Norwood and the Corporation of the City of Payneham, named "The St. Peters Local Area Development Committee", "The Kensington and Norwood Local Area Development Committee" and "The Payneham Local Area Development Committee", to undertake the responsibilities of the council under the Development Act 1993 and any other related legislation in respect of development undertaken (or to be undertaken) wholly within the area of the council in respect of which the committee is established;

(b) that-

- (i) The St. Peters Local Area Development Committee will be constituted by—
 - (A) the councillors elected for the East Adelaide and Hackney Ward and the Stepney and Maylands Ward (and one of these councillors will be appointed as the presiding member of the committee); and
 - (B) the presiding members of the other two committees; and
 - (C) the mayor of the new council; and
- (ii) The Kensington and Norwood Local Area Committee will be constituted by—
 - (A) the councillors elected for the Norwood/Kent Town Ward and the Kensington Ward (and one of these councillors will be appointed as the presiding member of the committee); and

- (B) the presiding members of the other two committees; and
- (C) the mayor of the new council; and
- (iii) The Payneham Local Area Development Committee will be constituted by—
 - (A) the councillors elected for the Torrens Ward, the Payneham Ward and the Trinity Ward (and one of these councillors will be appointed as presiding member of the committee); and
 - (B) the presiding members of the other two committees; and
 - (c) the mayor of the new council;
- (c) that the new council must delegate to each committee relevant and necessary powers and functions of the council in order to enable the committee to perform the functions referred to in paragraph (a);
- (d) that the new council may dissolve one or more of the committees after the first Saturday of May in 2000.

24. Determine-

- (a) that the new council must establish three community development committees, one for each area that, immediately before the amalgamation, constituted the Corporation of the City of Kensington and Norwood, the Corporation of the Town of St. Peters and the Corporation of the City of Payneham;
- (b) that the composition of the committees will be determined by the new council;
- (c) that the new council must take appropriate steps to delegate to the committees various functions and powers associated with the development of the areas of the council in respect of which the committees are established;
- (d) that the new council may dissolve one or more of the committees after the first Saturday of May in 2000.

25. Declare-

- (a) that the new council must maintain the libraries of the Corporation of the City of Kensington and Norwood at 110 The Parade, Norwood, the Corporation of the Town of St. Peters at 101 Payneham Road, St. Peters, and the Corporation of the City of Payneham at 196 O.G. Road, Felixstow, until at least 31 December 1998:
- (b) that the new council must, within a reasonable time after the commencement of this clause, establish a committee (constituted as the council thinks fit) to review the council's library services and to provide a report to the council by 31 October 1998.
- 26. Declare that the new council must maintain the St. Peters Town Hall for public use.

27. Declare-

- (a) that clauses 1 to 9 (inclusive), and 15 to 26 (inclusive), and schedules 1 to 7 (inclusive), will come into operation on 1 November 1997; and
- (b) that the remainder of this proclamation will come into operation on the day of the publication of the proclamation

SCHEDULE 1

East Adelaide and Hackney Ward: Comprising that portion of the Hundred of Adelaide, County of Adelaide, bounded as follows:

Commencing at a point on the western boundary of the municipality of The City of Norwood, Payneham and St. Peters (the western boundary of Hackney Road, Adelaide), being its intersection with the production south-westerly of the centre of North Terrace; thence north-easterly along the latter production and centre of North Terrace and the centre of Payneham Road, suburbs of Hackney, College Park and St. Peters to the intersection with the production south-easterly of the north-eastern boundary of section 280, Hundred of Adelaide; north-westerly along the latter production and boundary to the western boundary of the

municipality of The City of Norwood, Payneham and St. Peters (the centre of the River Torrens); thence generally southerly along the boundaries of the municipality of The City of Norwood, Payneham and St. Peters to the point of commencement and crossing all intervening roads and the Northeast Busway.

SCHEDULE 2

Stepney and Maylands Wards: Comprising that portion of the Hundred of Adelaide, County of Adelaide, bounded as follows:

Commencing at a south-eastern corner of the municipality of The City of Norwood, Payneham and St. Peters, being the intersection of the centre of Portrush Road and the centre of Magill Road, suburb of Maylands; thence northerly along the centre of Portrush Road to its intersection with the production easterly of the southern boundary of the land contained in Certificate of Title 1368/13, suburb of Payneham; westerly along the latter production and boundary and its production and continuing westerly and north-westerly along the centre of Llandower Avenue to the centre of Payneham Road, suburb of Evandale; south-westerly along the centre of Payneham Road to the centre of Magill Road, suburb of Stepney; thence easterly along the centre of Magill Road, suburbs of Stepney and Maylands to the point of commencement and crossing all intervening roads.

SCHEDULE 3

Torrens Ward: Comprising that portion of the Hundred of Adelaide, County of Adelaide, bounded as follows:

Commencing at a point on an eastern boundary of the municipality of The City of Norwood, Payneham and St. Peters, being its intersection with the centre of Payneham Road, suburb of Felixstow; thence south-westerly along the centre of Payneham Road, suburbs of Felixstow, Marden, Royston Park and Joslin to the intersection with the production south-easterly of the south-western boundary of section 281, Hundred of Adelaide; north-westerly along the latter production and boundary to the western boundary of the municipality of The City of Norwood, Payneham and St. Peters (the centre of the River Torrens); thence generally north-easterly, south-easterly and generally south-westerly along the boundaries of the municipality of The City of Norwood, Payneham and St. Peters to the point of commencement and crossing all intervening roads and the Northeast Busway.

SCHEDULE 4

Payneham Ward: Comprising that portion of the Hundred of Adelaide, County of Adelaide, bounded as follows:

Commencing at a point on an eastern boundary of the municipality of The City of Norwood, Payneham and St. Peters (the centre of Glynburn Road), being its intersection with the production easterly of the centre of Marian Road, suburb of Glynde; thence westerly along the latter production and centre of Marian Road to the centre of Ashbrook Avenue, suburb of Payneham South; southerly along the centre of Ashbrook Avenue to the centre of Luhrs Road; westerly along the centre of Luhrs Road; westerly along the centre of Portrush Road; northerly along the centre of Portrush Road; northerly along the centre of Portrush Road to its intersection with the production easterly of the southern boundary of the land contained in Certificate of Title 1368/13, suburb of Payneham; westerly along the latter production and boundary and its production and continuing westerly and north-westerly along the centre of Llandower Avenue to the centre of Payneham Road; north-easterly along the centre of Payneham Road, suburbs of Payneham and Glynde to an eastern boundary of the municipality of The City of Norwood, Payneham and St. Peters; thence southerly along the latter boundary to the point of commencement and crossing all intervening roads.

SCHEDULE 5

Trinity Ward: Comprising that portion of the Hundred of Adelaide, County of Adelaide, bounded as follows:

Commencing at a point on an eastern boundary of the municipality of The City of Norwood, Payneham and St. Peters (the centre of Glynburn Road), being its intersection with the production easterly of the centre of Marian Road, suburb of Firle; thence westerly along the latter production and centre of Marian Road to the centre of Ashbrook Avenue, suburb of Payneham South; southerly along the centre of Ashbrook Avenue to the centre of Luhrs Road; westerly along the centre of Luhrs Road to the centre of

Portrush Road; southerly along the centre of Portrush Road, suburbs of Payneham South and Trinity Gardens to a southern boundary (the centre of Magill Road) of the municipality of The City of Norwood, Payneham and St. Peters; thence easterly and northerly along the boundaries of the municipality of The City of Norwood, Payneham and St. Peters to the point of commencement and crossing all intervening roads.

SCHEDULE 6

Norwood/Kent Town Ward: Comprising that portion of the Hundred of Adelaide, County of Adelaide, bounded as follows:

Commencing at a point on the western boundary of the municipality of The City of Norwood, Payneham and St. Peters (the western boundary of Hackney Road, Adelaide), being its intersection with the production south-westerly of the centre of North Terrace; thence north-easterly along the latter production and centre of North Terrace, suburb of Kent Town and easterly along the centre of Edward Street, suburb of Norwood; southerly along the centre of Edward Street and its production to a southern boundary of the municipality of The City of Norwood, Payneham and St. Peters; thence westerly, north-westerly and northerly along the boundaries of the municipality of The City of Norwood, Payneham and St. Peters to the point of commencement and crossing all intervening roads.

SCHEDULE 7

Kensington Ward: Comprising that portion of the Hundred of Adelaide, County of Adelaide, bounded as follows:

Commencing at a point on a southern boundary of the municipality of The City of Norwood, Payneham and St. Peters, being its intersection with the production southerly of the centre of Edward Street, suburb of Norwood; thence easterly, southerly, generally easterly, generally northerly, westerly and northerly along the boundaries of the municipality of The City of Norwood, Payneham and St. Peters to the centre of Magill Road, suburb of Norwood; westerly along the centre of Magill Road to the centre of Edward Street; thence southerly along the centre of Edward Street and its production to the point of commencement and crossing all intervening roads.

Exemption from registration and insurance for golf carts and certain motorcycles

- **9A.** (1) Subject to the conditions set out in subregulation (4), a prescribed motor vehicle may be driven on a golf course without registration or insurance.
- (2) Subject to the conditions set out in subregulation (4), a prescribed motor vehicle may be driven on a road that does not form part of a golf course without registration or insurance in order to travel by the shortest available route from one part of a golf course to another part of the golf course.
- (3) Subregulations (1) and (2) only apply if the motor vehicle is being driven by the owner of the vehicle or by a person authorised by the owner of the vehicle.

- (4) The conditions referred to in subregulations (1) and (2) are as follows:
- (a) the vehicle must not be used, either wholly or partly, for the purpose of hiring it to another person for fee or reward; and
- (b) a policy of public liability insurance indemnifying the owner and any authorised driver of the vehicle in an amount of at least ten million dollars in relation to death or bodily injury caused by, or arising out of, the use of the vehicle must be in force.

"golf cart" means a motor vehicle designed for the purpose of transporting a person or persons who are playing golf around a golf course;

"golf course" includes—

- (a) land (including land used for car parking) used for the purposes of, or in conjunction with, a golf course; and

"prescribed motor vehicle" means-

- (a) a golf cart;
- (b) a motor cycle that—
 - (i) has a mass not exceeding 65 kilograms; and

- (4) However, a fee is not payable under subregulation (2) unless the determination of the Board under subregulation (1) is made on the application, or with the concurrence, of the holder of the taxi licence.
