#### Notes

#### 1. Accounting policies

The accounting polices applied in preparing this news release are materially the same as those applied in preparing the statutory accounts for the year ended 31 December 2011. The Hong Kong Institute of Certified Public Accountants has issued a number of amendments to Hong Kong Financial Reporting Standards that became effective in 2012. However, none of these amendments has had a material effect on this news release.

#### 2. Statutory accounts

Certain financial information in this news release is extracted from the statutory accounts for the year ended 31 December 2012 which were approved by the Board of Directors on the 5 March 2013 and will be delivered to the Companies Registry and the Hong Kong Monetary Authority. The auditor expressed an unqualified opinion on those statutory accounts in the independent auditor's report dated 5 March 2013.

### 1. 會計政策
