Subjects include but are not limited to the following: border dispute in Kashmir; demilitarization of the state of Jammu and Kashmir; Kashmiri cease-fire negotiation; Tashkent Declaration; United Nations Military Observer Group in India and Pakistan (UNMOGIP); death of General Nimmo of UNMOGIP; Rann of Kutch dispute; United Nations India/Pakistan Observer Mission (UNIPOM); appeals to member states for observers for UNIPOM; independence of East Pakistan/Bangladesh; refugees in East Pakistan; Indian/Pakistani fighting in East Pakistan: United Nations East Pakistan Relief Operation (UNEPRO): appeals to member states for monetary donations to UNEPRO; WHO and UNICEF aid to UNEPRO; and evacuation of United Nations and international personnel from Dacca.
