III. COMPETITION DETAILS AND REGULATIONS

GENERAL RULES	The competition is organized in accordance with the General Competition Regulations and with the specific regulations of the MetLife BWF World Superseries. The Tournament will be run strictly in accordance with the MetLife BWF World Superseries regulations.
ONLINE ENTRIES	Member Associations are advised to log on to Yonex French Open 2016 at: http://bwf.tournamentsoftware.com/sport/tournament.aspx?id=3462A843-4C3C-4CFD-A417-E905A95CE661 and submit the entries online. You will require a username and password to submit your entries and this can be obtained from the BWF: please contact S. Ramachandran: s.ramachandran@bwfbadminton.org. The online entry page will close immediately on the entries closing date September 13th at 23:59 hours BWF Headquarters time and you are required to submit the entries on time. Late entries will not be accepted. No entry forms are required by Member Associations. When the entries are sent using the BWF Online Entry System, after the closing

	date, the BWF Online Entry System will send an Entry Confirmation to all participating Member Associations confirming the receipt of final entries. This confirmation is the conclusive evidence of receipt of entries before the deadline. The Member Associations shall contact BWF immediately if such confirmation is not received by Wednesday by noon BWF Headquarters time following close of entries. Any objection to the entries should be notified to BWF. Following the close of entries if no objection is received by BWF by Thursday 23.59 hours BWF Headquarters time the entries shall deemed to be correct. No complaints / objections shall be entertained thereafter.

	Any notification of withdrawals with appropriate certification must be given immediately to the Tournament Organizers by email.
WITHDRAWALS	Withdrawals made after Sunday 2nd of October for whatever reason shall be subject to a penalty as mentioned in the Metlife BWF World Superseries regulation.
SEEDING AND DRAWS	Seeding of players shall be done by BWF on Thursday 29th of September and published on Friday 30th of September .
SEEDING AND DRAWS	The draws will be conducted in accordance with the MetLife BWF World Superseries regulations on Tuesday 4 th of September .
SCORING SYSTEM	Rally Point System = 3 * 21 points
COMPETITION REQUIREMENTS AND WARM-UP TIME	All events will be on a strict timetable system. Competitors should be ready to play 30 minutes before their scheduled time. Competitors who are not ready to play at their scheduled time will be disqualified. On the court, before a game, warm-up time is limited to 2 minutes.

	Advertising for tobacco and alcohol companies is completely forbidden by the French law.		
NAMES AND COLOURS	BWF Competition Regulations 19 to 23 and any subsequent regulations will apply. The BWF Regulations require players' names to be on the back of their shirts and give the option of also having their country and/or advertising		

	beneath the name. This Regulation also applies to the Qualifying Rounds.
	We remind you that as of 1 July 2016, referees and umpires are required to enforce the regulation that the name on the back of the player shirt must match the Last Name/Family Name as entered by the Member Association in the BWF Player Database
	It is mandatory that, in the main draw onwards, the opposing pairs in each match wear significantly different colours from each other.
	In Doubles: It is mandatory for doubles partners to wear same colour from main draw onwards.
	In the event that the opposing players/pairs involved in a match wish to wear the same coloured clothing, the player/pair ranked lower (using the BWF World Ranking used to produce the Main & Qualifying (M & Q) Report will be required to wear clothing of a different colour.
