**1. ANNOUNCEMENT:**

The Mildura Motor Cycle Club, hereafter called the PROMOTER, will conduct 2016 / 2017 Open Speedway for Senior National and Junior National License holders at Olympic Park Speedway, on the above listed dates.

**2. JURISDICTION:**

2.1. The abovementioned meeting has been authorized by Motorcycling Victoria which has issued the Motorcycling Australia *Permit Number, as granted* and is open to holders of current Motorcycling Australia Senior National and Junior National Licenses. Licensees from other Federations are also eligible to compete providing they have clearances from their Federation. The Promoter must obtain an IMN if licensees are from federations other than Australia and New Zealand.

2.2. The meeting will be held in accordance with the current General Competition Rules (GCRs), these Supplementary Regulations, and any Final Instructions approved by Motorcycling Victoria..

**BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.**

**3. ENTRIES:**

3.1. Entries open forthwith and close 10 DAYS BEFORE THE MEETING DATE.

3.2. In the case of postponement or abandonment of the meeting, all riders will be notified.

3.3. Only entries received through the Nomination contacts (listed above) will be accepted.

3.4. **NOTE: LATE ENTRIES WILL NOT BE ACCEPTED.**

**4. INSURANCE:**

4.1. National Personal Accident Scheme provides basic cover for death and permanent disability.

4.2. Ambulance Insurance is compulsory for licensees.

4.3. **IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE CONSIDERATION TO TAKING OUT WEEKLY BENEFITS INSURANCE.**

**5. MEDICAL SERVICES:**

Ambulance Victoria is in attendance at all Open meetings

**6. ENTRY FEE: (if applicable) Nil**

6.1. Riders will pay a contribution towards the cost of Ambulance Victoria and the MV Rider Levy at Sign-on.

6.2. Cheques and Money Orders are to be made payable to the Mildura Motor Cycle Club Inc..

- 7. ENTRY PASS:**  
Rider and 1 mechanic (for Solo). Rider, passenger and 2 mechanics (for Championship meetings only..
- 8. AWARDS AND PRIZEMONEY:**  
Prizemoney will be paid in the Clubrooms (Social event) after the meeting.
- 9. RIDERS BRIEFING:**  
A Riders Briefing will be held prior to the commencement of racing and ALL Competitors MUST attend the Riders Briefing.
- 10. DRUG AND OR ALCOHOL TESTING:**
- 10.1** All competitors and officials are advised that as part of the MA drug education program, drug testing may take place at any competition in accordance with the Australian Sports Drug Agency policy.
- 10.2** If any doubts exist over banned substances it is recommended competitors telephone the Drugs in Sport Hotline 1800 020 506. When drug testing takes place, the payment of prizemoney may be delayed at the RCB's discretion until the results of the tests are known.
- 10.3** For the purpose of drug & alcohol testing, the commencement of the meeting will be deemed to be 4:00pm on Race day, with the completion of the meeting for the participant being when the participant vacates the venue.
- 11. CODE OF CONDUCT**  
All Competitors, Officials and Parents are reminded of the Motorcycling Australia By-Law – CODE OF CONDUCT (as stipulated in the GCRs) which is a guide to appropriate behaviour at all Motorcycle Race Meetings. This CODE OF CONDUCT applies to this Meeting and will be enforced.
- 12. TIMETABLE**  
Sign-on and Scrutineering from 4:00pm  
Riders Briefing at 6:00pm at the foot of the Referee box stairs.  
**Practice will ONLY be available for riders who have NOT ridden the track before.**
- 13. CIRCUIT DESCRIPTION:**  
**Circuit is composed of "Crusher Dust" and River Sand, watered and rolled.**  
**Track is 300 metres in length, measured 1 metre in from the Pole line.**  
**Track Width is 11.5 metres in the straights and 14.0 metres in the corners.**  
**The Fence is a suspended Rubber Conveyor Belt on which an Kinetic Energy Absorbing AirFence is suspended in each corner.**  
**Solo direction: Anti clockwise**  
**Sidecar Direction: Clockwise.**
- 14. GST:**  
The Goods and Services Tax affects the payment of prize money. If you do not provide an ABN or declare the sport is a hobby, the Promoter must withhold 48.5% of prize money over \$50.00 which is otherwise payable to you. Please tick one of the boxes on the entry form and if appropriate provide your ABN to ensure the full amount of prize money is paid to you.

**HEREBY AGREE** with the persons, organizations and bodies corporate whose names appear in Schedule 1 (hereinafter collectively called "the organisers") that I am by this agreement entitled to participate in the motorcycle meeting listed in Schedule 2 (hereinafter called "the meeting") at the venue listed in Schedule 3 (hereafter called "the venue") on the terms and conditions set out in this document.

**ACKNOWLEDGEMENT OF RISKS, DANGERS AND OBLIGATIONS**

2. **I ACKNOWLEDGE** that the sport of motorcycle racing is dangerous and that by engaging in the sport and participating in the race meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
- a) that I may be injured, physically or mentally, and may be killed;
  - b) that my machinery or equipment may be damaged, lost or destroyed;
  - c) that other competitors may ride dangerously or with lack of skill;
  - d) that track or event conditions may be hazardous and may vary without warning or predictability;
  - e) that the organizers, officials, landowners/track operators and any agent or representatives of those in charge of race meetings are frequently obliged to make decisions under pressure of time and/or events;
  - f) that any policy of insurance of or in respect of my life or physical or mental health may be voided;
  - g) that there may be no or inadequate facilities for treatment or transport of me if I am injured;
  - h) that I have an obligation to myself and others to compete safely and within the rules of competition.

**INDEMNITY GIVEN TO ORGANISERS**

3. **IN CONSIDERATION** of the acceptance of me as a competitor in the meeting **I AGREE TO INDEMNIFY** the organisers and each of them in the following manner:
- a) that I participate in the race meeting at my sole risk and responsibility;
  - b) that I accept the venue as it stands with all or any defect hidden or exposed;
  - c) that I indemnify and hold harmless the organisers, their respective servants, agents or officials against any actions or claims which may be made by me or on my behalf or by other parties for or in respect of or a rising out of my death or any injury, loss or damage caused to me or to my machine or equipment whether caused by negligence, breach of contract or in any manner whatsoever.
