1. Announcement

Motorcycling Australia and the Motorcycling Victoria Enduro Committee, Dandenong MCC, Kooweerup & District MCC, Diamond Valley MCC & Mansfield Junior MCC hereafter called the Promoter will conduct the 2016 Australian 4 Day Enduro (A4DE) incorporating the Australian Enduro Individual and Teams Championships and 2016 Intercontinental Enduro Challenge for Senior Solo Motorcycles at Merrijig in Victoria from Monday 14th November to Saturday 19th November 2016.

2. Jurisdiction

- 2.1 The above mentioned meeting has been authorized by Motorcycling Australia which has issued the Motorcycling Australia Permit Number **MA 1700** and is open to holders of current Motorcycling Australia Senior National Competition Licenses and MNZ Licence holders who hold start permission from MNZ and proof of Insurance to FIM Standard. If International competitors other than NZ enter, ALL international competitors (including NZ competitors) must hold an FIM Licence issued by their respective FMN, in addition to a start permission to compete which certifies that they hold current insurance to FIM standard.
- 2.2 The meeting will be held in accordance with the current General Competition Rules (GCRs) contained in the 2016 Manual of Motorcycle of Sport (MoMS), these Supplementary Regulations and any final instructions approved by Motorcycling Australia. By entering this meeting all parties agree to comply with these rules, regulations, by-laws and instructions.

4 Entries

- 4.1 Entries are now open and close on Friday 28th October 2016. Late entries may be accepted at the discretion of the promoter. Late entry fee will be \$150. Contact Race Secretary at denise.hore@bigpond.com. The minimum number of entries will be 150 and the maximum will be 350. If there are less than 150 entries the event may be cancelled with the approval of MA.
- 4.2 In the case of postponement or abandonment of the meeting a refund policy will apply. See 7.4
- 4.3 Entry **ONLINE ONLY** at www.a4de.com.au. Entrants must have a valid email address to successfully enter on-line. NOTE: You can use someone else's email address BUT remember to check their email for confirmation of entry and Final Instructions
- 4.4 Entrants can pay by direct debit (Bank transfer) or credit card.

NB: If paying by bank transfer

- please use rider surname & MA Licence number as reference.
- Riders must notify the Race Secretary, in writing, in order to be entitled to any refund. THE RETURN OF ENTRY FEES FOR ANY RIDER WITHDRAWING FROM THE MEETING IS OUTLINED IN THE REFUND POLICY – see 7.4.

6 Entry Fees

6.1 Individual Entry Fees

- 6.2. **REGISTRATION:** Motorcycles must have road registration to compete in this event. Competitors who DO NOT HAVE FULL road registration (or Victorian Rec Reg for Vic riders only) for their motorcycle will need to obtain a Victorian Unregistered Vehicle Permit. Motorcycles must comply with the standards for Enduro as described in the Manual of Motorcycle Sport Rule Section 14E and conditions in these Supplementary Regulations. ADR Compliance plate is not necessary. Riders must indicate their need for this registration on the on-line entry form by October 13th and will be charged a \$75.00 fee. Please make sure that you have the description of vehicle, frame number & engine number correct on the Entry Form. If the details are incorrect the registration permit will not be valid.
 - 6.3 **Team Entries:** No entry fee for Intercontinental and State Trophy, Junior Trophy and Womens Cup Teams. **Trade Team** Entry Fee of \$60.00, **Club Team** Entry Fee of \$30. Details of team requirements can be found in 2016 Manual of Motorcycle Sport MoMS Section 14.26.3 and 14.26.4. Closing date for Team entries is 29th October 2016. Late Trade and Club team entries will be accepted up until close of rider sign-on. There will be a late fee of \$20.00. Total fee including late fee Club Team- \$50.00. or Trade Team \$80.00.(These late teams will not be in the event program) For late entries of teams a completed team details form and payment in correct cash to be made to Race Secretary only up to close of rider sign-on.

6.4 **REFUNDS**:

- a) Riders withdrawing in writing before October 29th 2016 (close of standard entries) will be entitled to a refund, less a \$50 administration fee.
- b) Riders withdrawing in writing after close of standard entries, 30th October 2016, and prior to 5pm on Saturday 1st November 2016 will receive a refund, less \$100 administration fee.
- c) Riders withdrawing from the event after 5pm on the 7th November 2016 will not be entitled to any refund.
- d) Should the event be cancelled by the Jury President due to "force majeure" (eg inclement weather) then the following shall apply: Riders who did not ride or enter the track will receive

- their entry fee, less 30% administration fee. Riders who competed (including Prologue) will not be entitled to any refund.
- e) All withdrawal requests MUST be in writing to the Race Secretary.
- 6.5 PAYG Withholding affects the payment of prizemoney. If you do not provide an ABN or declare the sport is a hobby, please tick one of the boxes on the entry form and if appropriate provide your ABN to ensure the full amount of prize money is paid to you.
- 6.6 Final Instructions & Rider List will be placed on www.a4de.com.au.

7 Classes of Competition

Trophy Team and Junior Trophy Team

- 7.1 Each Australian State, the ACT, the Northern Territory and New Zealand may nominate, through its RCB, one Trophy Team and one Junior Trophy Team. Team entries must be consistent with 2016 MA MoMS
- 7.2 Trophy Teams and Junior Trophy Team entries are to be submitted separately by the RCB by the October 29th 2016 and must be endorsed by the Enduro Committee of the RCB.

Intercontinental Challenge

7.3 MA and MNZ will each nominate one 6-person team to compete for the Intercontinental Teams Challenge. Intercontinental Teams rules will be consistent with Trophy Team rules. These teams must be submitted at the first Jury Meeting.

Trade Teams

- 7.4 Trade Team is a competition in which any Trader within the motorcycle trade may enter a team consisting of three (3) riders.
- 7.5 A competitor may not be a member of more than one Trade team. A competitor in a Club Team is ineligible for this competition.
- 7.6 The three (3) best teams will receive special awards.

Club Teams

- 7.7 A club may enter teams of three (3) riders who have their competition Licence issued by the nominated club and are current members of that club.
- 7.8 Club must be affiliated with the SCB. No competitor may be a member of more than one club team.
- 7.9 The three (3) best teams will receive special awards. <u>PLEASE NOTE:</u> Competitors in the Trophy, Junior Trophy, Women's Cup or Trade team are ineligible for this competition.

Women's Cup Teams

- 7.10 Each Australian State, the ACT, the Northern Territory and New Zealand may nominate, through its RCB, one Women's Cup Team.
- 7.11 Women's Team entries must consist of three riders who have their MA Senior Competition Licence issued by the state they are representing. A competitor in a Club Team is ineligible for this competition.

Team Managers

- 7.12 Each team may have a Team Manager whose name and address must be nominated by the close of entries.
- 7.13 The Race Secretary will accept any changes to Team Managers up to close of rider sign-on. No Team Manager can be a Jury member.

8 Awards

- 8.1 The outright individual winner of the A4DE will be awarded the **John Hall Perpetual Trophy**Named in honor of the mastermind and original organizer of the first A4DE in 1978.
- 8.2 MA Australian Championship medallions and trophies will be awarded to first, second and third in each individual Australian Championship class. All competitors will be eligible for the Australian Championship Awards.
- 8.3 The winning Trophy Team will be awarded the "Interstate Challenge Trophy" which was donated by the Cessnock Motorcycle Club. Each member of the winning, second and third placed teams will receive a trophy.
- 8.4 The winning Junior Trophy Team will be awarded the Perpetual Cup, which was donated, by the Trail and Enduro Motorcycle Club of WA in 1993. Each member of the winning team, second and third placed teams will receive a trophy.
- 8.5 Each member of the winning Women's Cup Team competition will receive a trophy.
- 8.6 The winning team in the Intercontinental Challenge will be presented with the "Intercontinental Teams Trophy" which was donated by the Cambridge Motorcycle Club in 2001.
- 8.7 The winning Club Team and Trade Team will receive a trophy. Each member of the winning, second and third placed teams will receive an award.
- 8.8 The Stefan Merriman Award will be awarded to the highest placed rider who is under 19 years of age as at 1st January 2016.
- 8.9 Further awards will be presented as per 2016 MoMS.

9 Entries to constitute a class

- 9.1 To constitute a class for the purpose of gaining Championship status, the number of contestants entered and competing in each class, except Women's, must be at least ten (10). The numbers of entries to constitute a Championship Class for the Women must be at least six (6).
- 9.2 Should there be insufficient entries in any class of competition, the class will be cancelled and competitors will compete for trophies only. No Australian Championship will be awarded. Except, if the women's class is cancelled the competitors will be included in the appropriate capacity class and therefore be eligible for those Championship awards.

10 Race Format

- 10.1 The riders will leave in groups of threes at no less than one (1) minute intervals.
- 10.2 All riders will be competing against the clock.
- 10.3 Except for the final test, there will be no mass starts.
- 10.4 Time Cards will be used and scored as per the MA Enduro rules.
- 10.5 Motorcycles will be impounded overnight.
- 10.6 Trail times are to the minute.
- 10.7 Special Tests will consist of Enduro and Cross tests as per 2016 MA MoMS.
- 10.8 Test Timing will be to 1/100th of a second by transponders. See 2016 MA MoMS.
- 10.9 **Special Test Starts** Riders will be self starting at intervals as determined by the Clerk of Course. Riders must cross the start line within 5 seconds of being directed by the start signal. Riders who refuse to start on their allocated time will incur a penalty.

Tailgating off the start line will incur a penalty as determined by the Clerk of Course.

- 10.10 There will be a Prologue for all riders on Tuesday 15th November. The Prologue is for the purposes of seeding riders for Day 1 start order. The top 20 from 2015 will be the top 20 for 2016 start order based on Prologue times. The result of the Prologue WILL NOT be included in overall results. Riders who do not complete the Prologue will be seeded at the rear of their respective group.
- 10.11 Trophy and Junior Trophy Teams and specially seeded riders will start at the front of the field on each of the first three (3) days.
- *** The Clerk of Course reserves the right to seed any riders at any time during the event for safety purposes.

- 11 Rider Sign-on & Scrutineering
- 11.1 Rider Sign-on will be from 9:00am 3:00pm Monday 14th November 2016.

 RIDERS MUST REPORT TO RIDER SIGN-ON <u>BEFORE</u> YOUR MOTORCYCLE CAN BE SCRUTINEERED.
- 11.2 Riders are required to hold and produce a current MA Senior National Licence, current MNZ or FIM Senior Competition Licence. **NB**: Trophy, Junior Trophy and Women's Cup team members must have a competition Licence issued in their state. ACT Team Members must be a licensed member of an ACT Club.
- 11.3 Riders must hold current civil Motor Drivers' Licence of a class suitable for use with the motorcycle they intend to ride. **NB**: It is the rider's responsibility to ensure they comply with their licence conditions and licensing restrictions of their state traffic authority.
- 11.4 Motorcycles are required to be registered, unless you have ordered a Victorian Unregistered Vehicle Permit which must be done and paid for prior to **October 13th 2016** (Victorian Riders with Recreational Registration can compete) Prearranged permits will be given to riders at Sign-on see point 7.2.
- 11.5 Riding numbers and backgrounds will be provided for all riders and issued at sign-on.
- 11.6 Riders will be required to sign, at sign-on, the Motorcycling Australia Indemnity Form for this event
- 11.7 RIDERS NEED TO BRING TO SIGN-ON:
 - a) MA Riders Licence Senior National
 - b) Civil Riders Licence (eg RMS, Vic Roads, Qld Roads etc etc)
 - c) Motorcycle Registration Papers (NB a number plate is NOT proof of rego)
 - d) International Riders are required to show travel insurance as proof of ambulance cover.

SCRUTINEERING:

- 11.8 Scrutineering will be from 9.30am 3.30pm Monday 14th 2016.
- 11.9 Mechanics / Service crew can take the bike to scrutineering on the rider's behalf.
- 11.10 Motorcycles must be registered for use on public roads. The number plate must be affixed to the rear of the motorcycle in a safe, secure and visible manner. Riders must indicate their need for a Victorian Unregistered Vehicle Permit on the entry form (see section 7.2). The Victorian Unregistered Vehicle Permit must be carried on the bike or with the rider throughout the event.
- 11.11 MACHINES All machines entered must comply with the 2016 MoMs Enduro and Reliability Trails and Australian 4 Day Enduro Championships and these Supplementary Regulations. They must have: -
 - Working commercially available headlight and tail light (Permanently wired to illuminate or able to be switched on or off by a single switch mounted on the handlebar or headlight assembly).
 - Working Brake Light operated by brake pedal or handlebar brake lever.
 - Handlebars must be plugged and equipped with a protection pad on the cross bar (handlebars without a cross member must be equipped with a protection pad located in the middle of the handlebars, covering the handlebar clamps).
 - Hand guards are permitted. All motorcycles must be fitted with an extended style Enduro rear mudguard.
 - A effective rear vision mirror must be fitted on the right hand side
 - An appropriate horn or warning device must be fitted.
 - A chain guard that protects the rider from the front chain sprocket must be fitted.
 - No motorcycle may enter the A4DE Parc Fermé without a fixed stand approved at machine examination.
- 11.12 Sound testing will occur, and may take place at any time at the discretion of the Scrutineer or Clerk of Course. Refer to MoMs 14.15 for all sound control information

11.13 MUST BRING TO SCRUTINEERING:

- a) Motorcycle compliant to the rules see above
- b) Paper work issued at sign on
- c) Registration Papers or Victorian Unregistered Vehicle Permit
- d) Helmet must be clean, undamaged and have approved safety standard.
- e) Numbers with backgrounds provided at sign on must be attached to all 3 plates on the motorcycle
- 11.14 Machines entered in the competition must have successfully passed the event machine examination prior to taking part in the event. An MA decal will be placed on the front number plate to indicate that it has passed scrutineering.

12 Riders Briefing

12.1 All riders **MUST** attend the Riders Briefing.

• Monday 15th November at 6pm. Final Instructions will show location.

This is the ONLY Rider's Briefing and riders must sign the Registration Sheet so we know that you attended. Riders who do not attend and/or do not sign the Registration Form may not be permitted to start.

12.2 A riders instruction sheet will be issued to all riders. It is conditional upon acceptance of entry signed by the rider that he/she fully understands that it is the sole responsibility of the rider who signed the entry to read the riders instruction sheet and to bring to the attention of the Clerk of Course, anything contained in the instruction sheet that they do not understand or are concerned with for clarification.

13 Anti – Doping Policy

- 13.1 All competitors and officials are advised that drug testing may take place in accordance with MA's Anti-Doping Policy, as carried out by the Australian Sports Anti-Doping Authority. Refer to www.ma.org.au (home/About MA/Policies/Anti-Doping, Alcohol and Drug Policy)
- 13.2 If any doubts exist over banned substances it is recommended competitors contact the Drugs in Sport Hotline on 1800 020 506. When drug testing takes place, the awarding of prizes may be delayed at Motorcycling Australia's discretion until the results of the tests are known.

14 **Drug and Alcohol Testing**

All competitors and officials are advised that random drug and alcohol testing may take place during the competition. Refer to MA website for details on the Safety Policy – Drug and Alcohol testing.

For the purposes of drug and alcohol testing, the commencement of the meeting will be deemed to be 8.00am (Monday & Tuesday) and 7.00am (Wednesday to Saturday) with the completion of the meeting for the participant being when the participant has vacated the venue at the end of each day.

15 **Smoking**

Smoking is strictly prohibited in any fuel control areas (where refueling is permitted), paddock/pit area, start area, work area or parc fermé. Riders are liable for exclusion from an event for failing to adhere to this regulation and are responsible for the actions of their mechanics and support persons – as described 2016 MoMS

16 Code of Behaviour

All Competitors, officials, parents and support persons are reminded of MA's Code of Behavior contained within MA's Member Protection Policy, found at www.ma.org.au or Appendix C of the 2016 MoMS, which is a guide to appropriate behavior at all Motorcycle race meetings. This Code of Conduct applies to this Meeting and will be enforced.

NOTE: The Prologue is for the purposes of seeding riders for Day 1 start order. The result of the Prologue **WILL NOT** be included in overall results.

Riders will leave the parc ferme with a 10min Work Period and travel to the prologue test via timed sections. They will race the prologue test and return to the parc ferme control then enter a final 15min work period prior to impounding their bike. This could be a one (1) hour riding day with a service control. {NOTE: times and start order will be posted on the Information board and on the Website by 6.00pm Monday night.}

Riders will travel from the parc ferme via a service control to the final moto. This may be up to 1.5 hrs riding. They will then enter their work period and impound their bike ready for the final moto. The riders will have a look lap immediately prior to the commencement of the final moto. The final moto track will be available to walk at least 24 hours prior to the test.

18 Course Description

The course will consist of trails and tracks suitable for all levels of riders, with a total of approximately 250k of riding each of the first three days. The course will be marked with numbered arrows signifying each day.

19 Start Order

- 19.1 On Day 1 the start order will be set such that the Top 20 riders from 2015 will start first(as seeded by prologue times) followed by Trophy and Junior Trophy riders and specially seeded riders, (seeded as per Prologue times) followed by all other riders seeded as per the Prologue times.
- 19.2 Days 2 & 3 start order will be established with Trophy and Junior Trophy and specially seeded riders starting first, seeded using the previous days' Special Test results, followed by all other

riders seeded as per the previous days' Special Test results.

- **The Clerk of Course reserves the right to seed riders at any time before or during the event for safety reasons
- 19.3 Day 4 Start Order will be Class by class as per provisional outright position in class. Class order will be: Masters; Veterans; Women; E1; E2; E3.
- 19.4 Restarters: A competitor who retires or is excluded from the event may, once only, restart on the following day at the end of the field. To restart the competitor must apply to the Race Secretary before the end of the day for a re-start and then comply with 2016 MOMS. Re-start riders will not be eligible for awards or finishers medals.
- **NOTE:** Start list and schedule will be available from the secretary's office and on-line by 7:00pm the evening before each day's leg. In the event of unforeseen problems with meeting this deadline the Clerk of Course reserves the right to use the previous day's start order.

20 HIGHWAY CODE FOR OPERATION ON PUBLIC HIGHWAYS AND PRIVATE ROADS

All participants in the contest must respect the traffic code for operation on all public and private roads and road crossings. They must conform to all instructions that are given by the marshals and management. **STOP** signs are at all road crossings - riders MUST STOP at all STOP signs and give way to traffic. Riders failing to observe this instruction may be disqualified from the contest or face other penalties.

21 Events Rules

21.1 The event will be run in accordance with 2016 MA MoMS - in particular but not limited to: Enduro and Reliability Trails and Australian 4 Day Enduro, these supplementary regulations, final instructions, rider instruction sheet and bulletins. These documents give details about general organisation; starting procedures, re-start rule, assistance allowable, operation of time checks, penalties and other useful information. It is the rider's responsibility to be familiar with these rules and all information that is provided.

22 **Penalties**

- 22.1 A **YELLOW** card system for <u>minor</u> infringements will be used during the event A YELLOW card may, at the discretion of the Clerk of Course, be issued to a rider as a warning of rule infringement. The issue of a yellow card does not replace any other penalties (such as fines or time penalties) that may be issued for the same offence by the Clerk of Course.
- 22.2 Other penalties as per 2016 MA MoMS.
- 22.3 **OUTSIDE ASSISTANCE**: Rules regarding outside assistance will be strictly enforced.

NOTE 1: Riders being accompanied on the course by "Ghost Riders" risk exclusion from the event. NOTE 2: No person other than the rider can handle a competitor's "Bum" Bag as this will be interpreted as outside assistance.(except in the service areas) See 2016 MA MoMS Rule: 14.14.11.1 d). The rider is allowed to change any unmarked parts anywhere on the course but may receive spare parts and tools only in the servicing areas. Tyres may only be changed in the morning and afternoon work periods.

23 **Environment**

- 23.1 Environmental Guidelines will be issued to all riders. It is responsibility of each rider to ensure both they and their service crews, mechanics and support persons are familiar with and adhere to the guidelines.
- 23.2 Each competitor will be issued one (1) environment mats. As of 2016 environmats must be 1 metre x 1.6 metres and will be available for purchase at the Secretaries office. All service crews and mechanics and riders will be required to use an environment mat when replenishing all fuels, oils and chemicals (including the oiling of chains) in order to stop ground contamination. (Carpet, plastic, cloth etc is not sufficient to stop ground contamination should spillage occur.) COST \$15.00 each
- 23.3 WASTE OIL facilities will be available at parc ferme in the paddock area
- 23.4 Each service crew MUST clean up their service area at all fuel / service controls. No rubbish

whatsoever is to be left on the ground. If bins are full rubbish must be taken with you.

- 23.5 NO TYRES are allowed to be disposed of in any bins
- 23.6 Riders are reminded that the use of "TEAROFFS" is not permitted.
- 23.7 DUE to ENVIRONMENTAL concerns, at ALL remote refuelling areas, fuel containers MUST NOT exceed ten (10) litres and are to be fitted with a suitable pouring spout a 20 litre container half full is NOT acceptable.
- 23.8 All refuelling must be carried out within the designated refuelling areas. (In the morning work area or at service time checks between the white and yellow flags Riders must be off the bike and the bike must NOT be running.
- 23.9 Sound testing may take place at any time at the discretion of the Chief Scrutineer or the Clerk of Course. All machines must comply with the requirement of the 2016 MoMs. Refer to MoMs 14.15 for all sound control information.

23.10 Environmental Penalties:

- a) Failure to use Environmental Mat First offence Yellow Card Warning second and subsequent offences \$50.00 or penalties up to exclusion.
- b) Failure to clean up service area First Offence \$50.00 fine second and subsequent offences \$150.00 or penalties up to exclusion.
- c) Use of Tearoffs First offence \$50 penalty.

Second and subsequent offences - penalties up to exclusion.

- d) Twenty (20) litre fuel drums present at remote fuel controls- First offence \$50.00 fine second and subsequent offences \$150.00 or penalties up to exclusion.
- e) Refuelling outside the designated fuel control areas Exclusion
- f) Disposal of tyres in waste facilities \$150.00 or penalties up to exclusion
- g) Sound as detailed in the 2016 MoMs 14.15

24 Fire Extinguishers

During the refuelling, each team must have at least one (1) portable fire extinguisher of minimum 1 kg in the proximity of the refuelling point (max 5m distance). The extinguisher must be visible and available to riders and crew at all times during refuelling.

25 Bulletins

Numbered and dated bulletins may be issued concerning any cases not provided for in the Supplementary Regulations. These bulletins will be posted on the official notice board at the event headquarters. It is the rider's responsibility to check the Notice Board each day for decisions from the Jury and any changes that may affect the format of the event and results.

26 **Presentations**

Presentation will be held on Saturday night at the Mansfield Basketball Stadium. Food, alcoholic and non-alcoholic drinks will be available for purchase. **NO BYO** alcoholic drinks allowed.

- (a) statutory guarantee that those services will be rendered with due care and skill; and
- (b) statutory guarantee that those services, and any product resulting from those services, will be reasonably fit for the purpose for which the services are being acquired (as long as that purpose is made known to the supplier); and
- (c) a statutory guarantee that those services, and any product resulting from those services, will be of such a nature, and quality, state or condition, that they might reasonably be expected to achieve the result that the consumer wishes to achieve (as long as that wish is made known to the supplier or a person with whom negotiations have been conducted in relation to the acquisition of the services).

 Excluding, restricting or modifying your rights: Under section 42 of the Fair Trading Act 1987 (SA), the supplier of recreational services is entitled to ask you to agree to exclude, restrict or modify his or her

Excluding, restricting or modifying your rights: Under section 42 of the Fair Trading Act 1997 (SA), the supplier of recreational services is entitled to ask you to agree to exclude, restrict or modify the supplier's liability suffered by you or another person for whom or on whose behalf you are acquiring the services (a third party consumer). If you sign this form, you will be agreeing to exclude, restrict or modify the supplier's liability with the result that compensation may not be payable if you or the third party consumer suffer personal injury.

Important: You do not have to agree to exclude, restrict or modify your rights by signing this form. Even if you sign this form, you may still have further legal rights against the supplier. A child under the age of 18 cannot legally agree to exclude, restrict or modify his or her rights. A parent or guardian of a child who acquires recreational services for the child cannot legally agree to exclude, restrict or modify his or her rights. A parent or guardian of a child who acquires recreational services for the child cannot legally agree to exclude, restrict or modify the child's rights.

Agreement to exclude, restrict or modify your rights: I agree that the liability of MA, the Motorcycling Organisations and the Indemnitees for any personal injury that may result from the supply of the recreational services that may be suffered by me (or a person for whom or on whose behalf I am acquiring the services) is excluded.

Definitions

- (a) Recreational services are services that consist of participation in • sporting activity or similar leisure-time pursuit; or any other activity that involves a significant degree of physical exertion or risk and is undertaken for the purposes of recreation, enjoyment or leisure.
- (b) Personal injury is bodily injury and includes mental and nervous shock and death.
