1 Briefly describe the organization's mission

Each and every day, Mothers Against Drunk Driving (MADD) is working to stop drunk driving from our roads, serving victims of drunk and drugged driving crashes, and protecting youth from the dangers of underage drinking. These are the driving forces behind everything we do. The Campaign to Eliminate Drunk Driving continued to make great progress in 2013. Two states, Tennessee and Maine, passed laws requiring all convicted drunk drivers to use an ignition interlock device. This brought the total to 20 states that require convicted drunk drivers to use an ignition interlock. States with this type of lifesaving legislation, such as Arizona and Oregon, have reduced drunk driving fatalities by 43 and 42 percent respectively. MADD, in a cooperative agreement with the National Highway Traffic Safety Administration (NHTSA), executed three Ignition Interlock Institutes in 2013, bringing together professionals from different states and various organizations and agencies who are involved with some
