## DE SALES TO INTRODUCE NEW ONLINE COMMUNITY



THIS FALL, DE SALES UNIVERSITY WILL OFFER ITS CRIMINAL JUSTICE AND HOMELAND SECURITY MAJORS THE OPPORTUNITY TO ATTEND THE MUNICIPAL POLICE OFFICERS' EDUCATION AND TRAINING COMMISSION BASIC TRAINING PROGRAM (MPOETC) at the Allentown Police Academy in Allentown, Pa., as part of its degree program.

If DeSales students are accepted into the MPOETC program, the cost of the training is included in the student's undergraduate DeSales tuition. The MPOETC course, as prescribed by Pennsylvania ACT 120, not only provides the skills necessary to become a police officer, it is also required training for all Pennsylvania municipal police officers.

"We're grateful to Chief Morris and the Allentown Police Academy staff for working with DeSales to give our students this opportunity," said David Seip, instructor of criminal justice and ACT 120 coordinator at DeSales. "Graduating with a four-year degree and ACT 120 certification will be a big benefit to our students. More departments are requiring their applicants to have their ACT 120 certification before applying for the openings in their departments."

"Even in departments that are not requiring their applicants to be certified, our students will still have the advantage," Seip continued. "They will be able to begin work immediately, while an applicant without the certification would be required to attend an academy at the hiring department's expense before they would be able to begin working."

In addition to being a full-time criminal justice or homeland security major, students who wish to enroll in the ACT 120 training program must complete required criminal justice courses at DeSales, maintain a certain grade point average, have no DeSales University disciplinary or criminal violations, and pass a physical test administered by DeSales and a physical and mental test administered by the Allentown Police Academy. Qualified students will spend the spring semester of their senior year attending the Allentown Police Academy for ACT 120 training, which will also satisfy the degree requirements for a bachelor's degree from DeSales.

"The Allentown Police Department and the Gerald M. Monahan Sr. Allentown Police Academy are proud to partner with DeSales University on this initiative," said Keith A. Morris, Allentown's chief of police. "Criminal Justice programs that offer ACT 120 trainings as part of the curriculum give the student a distinct advantage in pursuing a law enforcement career as it makes them marketable to a larger group of police departments immediately upon graduation. This partnership is the first of its kind at the Allentown Police Academy and it is our hope that in the long run there will be a direct impact on hiring for the Allentown Police Department."

## DE SALES RECRUITS LARGEST FRESHMAN CLASS IN HISTORY

Overall applications to the University increased 5 percent to more than 2,800. AS DE SALES UNIVERSITY CLOSES ITS 50TH ANNIVERSARY YEAR, highlighted by special celebrations, including a lecture from Timothy Cardinal Dolan, archbishop of New York, another milestone was reached.

DeSales has received 505 deposits for its 2016-17 freshman class, an 11 percent increase over the University's previous record of 448 deposits.

The number does not include transfer students, which brings the total number of new students to 560 for the upcoming academic year.

University administration credit a number of reasons for the record number, including faculty involvement in the recruitment and yield process, capital improvements, including new athletic fields and a new laboratory for criminal justice and psychology, creation of the Exploratory Studies program for undeclared students, and an expansion of marketing into previously untapped locations and media.

"It's a lot of different things," says Dr.

Gerard Joyce, vice president of student life. "The enrollment staff engaged students to look further into being a member of the DSU community, and the student development staff introduced a tangible out-of-the classroom experience. Also, the facilities staff makes sure that the campus looks great everyday for visitors."

Overall applications to the University increased 5 percent to more than 2,800.

When the school opened in 1965, 165 male students began classes that September and 9 majors were offered. Today, total enrollment, including ACCESS, the undergraduate adult evening program, and 8 graduate programs, is more than 3,100 students.


"When I think back to our humble beginnings—the open land where for the first few years only two buildings stood—I realize how far we've come with the support of all of our students, alumni, parents, and the people of the Lehigh Valley," said Fr. Bernard F. O'Connor, OSFS, president of DeSales University. "Five hundred students in our 50th year. God is good."

## ACCESS AND MBA PROGRAMS MARK MILESTONES

DE SALES UNIVERSITY IS MARKING TWO MORE MILESTONES IN 2016. The University just celebrated its 50th Anniversary year, and now it is marking the 40th anniversary of ACCESS, the adult education program, and the 25th anniversary of the Master of Business Administration (MBA) program.

ACCESS is an accelerated bachelor's degree program that gives adult learners the opportunity to begin or complete their college education in a short amount of time. Students can take courses in traditional classrooms, online, or a hybrid of both. Bachelor's degrees, certificates, or courses for personal enrichment are all offered on the Center Valley, Bethlehem-Area, and Lansdale-Area campuses. Programs of study include business administration, criminal justice, and nursing. The DeSales University MBA program is offered online and at multiple locations, including the Center Valley campus, Lehigh Valley Hospital, Pocono Medical Center, and Immaculata University. Courses focus on the skills required for success in multiple business settings—from corporate management, to health-care leaders, to individual entrepreneurs. The program has a strong emphasis on executive skills development in key areas, including leadership, communications, and decision making.

According to Lehigh Valley Business, DeSales has the second largest MBA program in Pennsylvania. Last year, U.S. News and World Report ranked the Online MBA program 136th in the nation and the Online ACCESS program 184th. The ACCESS program was also named a Leader in Adult Education for the 2016 Who's Who in Business, Lehigh Valley.

# GRADUATION COMES A NEW CHAPTER

FOR ACCESS STUDENT AND CENTER CITY ALLENTOWN REVITALIZATION SCHOLARSHIP RECIPIENT MIRIAM ARROYO, A DIPLOMA MEANS A FRESH START FOR HER AND HER SON

IT'S TWO NIGHTS BEFORE COMMENCEMENT AND MIRIAM ARROYO IS MAKING CHANGES TO THE LINEUP OF HER SON'S ALLENTOWN CITY LEAGUE BASEBALL TEAM. Well, maybe not in the strict sense of the action-after all, she's not the manager. Regardless, she's made one thing clear: the team's first baseman-her sevenyear-old son, Curtis-isn't playing.

"I'm benching him," she says. "He committed to play so he has to be here, but he's not playing because that's a privilege...He was acting up at school today."

It's small, lesson-learning moments of tough love like this that make it easy to see how much Arroyo cares for her son and his well-being. But get to know Arroyo on a deeper level and it's evident that her devotion to supporting her son drives her every endeavor, her every decision, her life.

He's the one who inspired Arroyo, who graduated with a nursing degree this May, to take a leap of faith and return to school as a 26-year-old single mother. Near rock bottom at the time, earning \$12 an hour as a technician at Safelite AutoGlass and receiving welfare checks to help her get by, she enrolled as an ACCESS student at DeSales. A nursing degree was her way out. It was their way out.

And so it began—the three-year journey of long nights attending classes and clinicals and studying after work, all while getting her son to and from school and practice. She struggled. She forewent sleep. But day by day, she was making it through.

Then the unthinkable happened. This past December, with one semester remaining before she earned her degree, her journey seemed it would come to a premature end: No one would co-sign the student loan she needed to take out, and she had already taken on too much debt to be able to take a loan out herself. A few months from graduation, it looked like the end of the road. Desperate, she went to the office of financial aid and asked for help. That's when she found out about the Center City Allentown Revitalization Scholarship, an award available to residents of Allentown's Neighborhood Improvement Zone (NIZ) and funded by the Harry C. Trexler Trust and the City Center Investment Corporation.

"I would not have finished if I didn't get that scholarship," she says. "It was a weight lifted off my shoulders because I really didn't have any other answers or any other options...My well was dry."

To win the scholarship, which was created in part to help NIZ residents who have jobs but wish to earn a degree, Arroyo had to write about how she would use her education to have a positive impact on the Allentown community, particularly in its NIZ. The Allentown native wrote about improving the city's school system, which she came through as a child and adolescent, and which her son is now a part of. "Allentown is really sufferingthe kids are lost, and there's a lack of parenting," she says.

Arroyo, who plans to seek employment at Good Shepherd Rehabilitation, has had help along the path to her diploma. Out of the classroom, she credits her sister, parents, grandparents, and son for showing her financial, logistical, and emotional support. Institutionally, she's most grateful to her advisor and mentor, Jennifer Gambal, a nursing instructor and the director of the evening and weekend program.

"I can't tell you how many times she watched me cry in her office," Arroyo says of Gambal. "She told me that I could do it. She knew I could do it."

Gambal knows the difficulties that come with returning to school while raising a family and working. It's people in this situation who fill her classes each semester. Even still, Arroyo stood out to her. "I think as an advisor to adult students, I have to be aware of what's happening in their lives," Gambal says. "She's very dedicated in raising her son...Miriam has this very caring personality—she's got a unique quality to her."

She's right. It's a unique quality that's a combination of resolve, resilience, and prioritization, and one that's undoubtedly fueled by her son. As such, it's a quality, too, of knowing what's best, and of using experience to lead by example and set others up for success—like a baseball manager.

"Education is the most important thing in the world. I really hope that that's something I'm showing him."





# KELLY GALLAGHER '03 GIVING BACK, TOGETHER

OCCASIONALLY, A BEAUTIFUL THING IS BORN OF TERRIBLE CIRCUMSTANCE. In June 2014, 8 weeks before her due date, Kelly Gallagher gave birth to her two sons Connor and Curran. Before she ever had a chance to hold them for the first time, they were taken away and hooked up to machines. As Kelly gathered the courage to be strong for her husband, herself, and her four children, she learned the pain of more than 800,000 mothers and fathers who struggle with preterm births in the US every year.

Up until the day her twins were born, Kelly was fortunate to have had little direct exposure to despair and disarray.

"I never had to beg God for anything until that happened," Kelly says as she reflects on the person she was two years ago. "I had been very blessed in my life. Literally, I had not even been to my first funeral until this year, and I'm 34." But she hadn't exactly had an easy life either. Kelly was the oldest of four, and willingly accepted a position of responsibility from the time she was ten, when her youngest sibling was born. She carried the qualities of a leader with her into her career at DeSales. Her propensity for teamwork and leadership played a significant role in her decision to attend, as she was recruited by the women's soccer coach to play there, eventually captaining the team as a senior.

"I remember my parents telling me the day they dropped me off, 'you're going to meet really good people here."

As it turns out, Kelly's experience at DeSales is what taught her "the importance of who you surround yourself with." Her ability to build and inspire a team is what helped her overcome the most trying obstacle she ever had to face.

In a triumph of the human spirit, Kelly and her twin boys overcame their nightmarish situation. Not only that, but something else was born within her. A revitalized appreciation for the impact people can have when they work together was instilled in her by her family, friends, and community.

"At first, I was just learning how to navigate through each day," Kelly says, thinking back to the first few months she spent with Connor and Curran in the comfort of her own home. Though she pulled through, she knew she hadn't done it alone. She held sincere gratitude for the support of her family as well as the others in her situation at the Holy Redeemer CHOP Care Neonatal Intensive Care Unit (NICU), and was eager to find a way to give back.

In an article posted on the Holy Redeemer HealthLink blog, Kelly states, "Accepting help also enabled me to have the strength to believe in the power of giving back. I spent a few months pondering how I could help a few families who have to spend their first holiday in the unit where we spent their first summer. By Christmas, I had gathered enough donations from family and friends to deliver fifteen baskets filled with gift cards, crocheted hats, snacks, journals, sanitizer, and love."

That was the first expression of Kelly's desire to "give back" to the community of families and healthcare professionals who helped her through the most difficult time of her life.

"At first, it was almost an expression of grief, something selfish," says Kelly when talking about her philanthropic efforts. The sense of duty she developed as she tapped into her compassion overcame her. Not only did she find strength in her time of weakness, but she learned how to access that strength in a way that allowed her to share it and instill it in others.

Six months after Kelly's twin boys were discharged from the Holy Redeemer CHOP Care NICU, Kelly put in the work necessary to legitimize her operation. She founded The Superhero Project Inc., a 501(c) (3) taxexempt organization that specializes in supporting families who have babies in the Neonatal Intensive Care Unit.

"I remember the doctor telling me that a premature baby surviving is like telling someone who doesn't run they have to do a marathon," says Kelly "and I was like, wow, they're like superheroes, and that's how I thought of the name."

It wasn't long after the founding of The Superhero Project when Kelly started to receive a flood of support and well wishes for her cause. The first initiative of her team, which was originally comprised of ten people, was to raise money to install AngelEye Cameras in the Holy Redeemer NICU. These cameras, once installed, would allow the parents of preemie children to visually interact with their children without commuting to the hospital. After experiencing the fatigue of traveling to and from the hospital for months on end, Kelly recognized this as a real, substantial solution to the anguish associated with that process.

"I kept saying to myself - what was the one thing that would have changed my life while I was going through this? There are tons of things out there used for therapy like bracelets, preemie cards, and swaddling clothes, which are great. But what I was missing when I got home was Connor and Curran. I knew AngelEye would bridge that gap."

Kelly swiftly received overwhelming support for her program. With donations coming from friends, family, strangers, and even doctors and nurses, she was able to raise \$17,000 in just one year. The money went toward three NICU photography sessions, more than 100 baskets for families, and six new cameras for the unit.

With the momentum of her nonprofit in full swing, Kelly has her sights set on exciting new initiatives. In a piece done by Preemieworld. com, Kelly explains, "Our current project is designing a room for families who are experiencing infant loss. The room will have many of the comforts of a home nursery as well as memory making opportunities that are often forgotten in times of stress: a washing station, a beautiful bookshelf, a camera with flash drives readily available as well as beautiful handmade gowns for the babies. In addition, the purchase of a Cuddle Cot will also add comfort and allow more time for the families to love their baby. Our room will be called, 'The Gift of Time Suite."

As of today, Kelly leads a team of more than 700 people. As she sets new goals for her group, she hopes to continue the growth of her organization and impact families in at least one new hospital every year. As she has familiarized herself with the non-profit industry and the world of charitable giving, she has found new ways to raise money for the cause. Recently, Kelly orchestrated fundraisers such as a Beef and Beer event that raised more than \$13,500 and a gala called "The Superhero Ball" planned for January 2017 in Center City Philadelphia. The ball will include notable public figures and media personalities such as Brian Taff from 6abc as well as Jen Posner from the John DeBella Show on 102.9 WMGK. They will be speaking for the cause and helping to raise money for The Superhero Project.

Kelly and her team remain dedicated to touching the lives of hundreds of other families through their efforts. After seeing the impact of her compassion, she considers her leadership of The Superhero Project a sort of calling. Thanks to her ability to reflect on the optimism she receives from her team and her community, Kelly is able to look back on her traumatic experience through a lens of positivity and hope. Her mission is to gift that strength back to the thousands of families going through the same struggle.

Kelly has a mantra, a set of questions she asks herself before she pursues any



new initiative. "Is it innovative, will it help people heal, and will it change someone's life?" Though she is unsure where The Superhero Project will end up, Kelly is furthering her cause one opportunity at a time, staying true to her message, her goals, and her promise to herself to give back. "Quite frankly, my wife Kathy and I were not contemplating a major gift to the University at this point in time," said Weiland. "When we learned the details of the plan for the Compardo Athletic Compound, things started to gel in our minds."

The 500-seat stadium will be built around the existing baseball field and will feature a modern press box. It will enhance the University's academic programs and allow it to host many local and regional baseball events.

"It is our hope that John's generosity will serve as an example to other alumni to give back to the best of their ability," said Thomas Campbell, vice president of institutional advancement. "Not everyone can give \$1 million, but every donation helps immensely."

Weiland graduated with a bachelor's degree in biology and a minor in business. He currently serves as the vice chairman, president, and chief operating officer of C.R. Bard, Inc. He credits his mentors at DeSales with playing an important role in his life. "I cannot tell you how profound an influence they have had, and continue to have, on my personal and professional development."


