ANNUAL REPORT FOR 1952-53

I. GENERAL

During the year under review, the six research departments, the library, the workshop and the administrative office continued to function actively for the second year in the new research laboratory building of the Association at Jadavpur. Dr. M. N. Saha, F.R.S. joined the Association as its first whole-time salaried Director on January 1, 1953 in succession to Prof. P. Ray, M.A., F.N.I., who had been acting as Director of the Association in an honorary capacity since 1947. The Council of the Association put on record their thanks to Prof. P. Ray for the conspicuous services he rendered as Honorary Director during the last six years. The Association has also gained Prof. Ray as its first Professor in Inorganic Chemistry and hopes that the new department will flourish under his able guidance.

The difficulties which the Association experienced last year on account of the delay in the supply of transformer, rectifier and switchgear equipments and therefore of the absence of D. C. supply were removed during the year under review. The transformer, rectifier and switchgear equipments arrived in various stages between January 1951 and May 1952 and were installed and put to service by the end of July 1952. Since then the Association has been receiving electric supply at high pressure (6 K.V.) and using it for both A.C. and D.C. power for its various research needs.

During the year under review, the furnishing of the Assembly Hall was undertaken. The Hall was provided with sitting arrangements with Celotex ceiling to improve its acoustics. The Council approved of the purchase and installation of an electric passenger lift, and of the construction of part of the front portion of the first floor in the main building for use as Registrar's quarters and staff canteen. Messrs. F. & C. Osler (India) Ltd. supplied the electric passenger lift manufactured by Messrs. Maryat & Scott Ltd. and

Messrs. Chatterjee Bros. were entrusted with the work of construction of part of the first floor of the main building on the basis of competitive tenders.

The Deed of Conveyance from the Trustees of the Association to the Governor of the State of West Bengal in respect of the sale of the Association's property at 210 Bowbazar Street to the Govt. of West Bengal was duly executed on 20-8-52 and registered on 8-10-52. This Deed of Conveyance and the original Deed between the Secretary of State for India in Council and Maharaja Jatindra Mohun Tagore Bahadur and others were both submitted to the Govt. of West Bengal, Education Department. The Govt. of West Bengal, on the other hand, paid the Association the sum of Rs. 1,00,000, being the balance of the consideration money, in fulfilment of the terms of the Deed. With this the final stage in the matters of disposal of the Association's old buildings at 210 Bowbazar Street to the Govt. of West Bengal was concluded.

During the year under review, the Title Suit No. 68 of 1950 between Umapada Sarkar and the State of West Bengal in respect of the acquisition of 9.64 acres of land at Jadavpur for the Association was heard before the Court of the Second Additional Sub-Judge Alipore and dismissed with cost. Following the decision, the Association received possession of the remaining portion of land measuring 0.75 of an acre, without the structure, on 22-8-52. In the same year, the L.A. (valuation) cases filed at the instance of a number of referring claimants for determination of valuation of land acquired by the L.A. Collector for and on behalf of the Association, came up for hearing and decision before the Court of the Special Land Acquisition Judge, Alipore. It is a matter of great anxiety and concern to the Association that the Special L. A. Judge decided on a much higher compensation rate ranging from Rs. 1.000;- to Rs. 1,500;- per katha than what the Collector had awarded, that is, Rs. 700 - per katha. The question of taking further action in the matter is now under consideration.

During the year under review, the Association had the proud privilege of having its research laboratories visited by Hon'ble the Education Minister of the Govt. of India, Maulana Abul Kalam Azad, Hon'ble the Education Minister of West Bengal, Sri Pannalal Bose, Dr. S. S. Bhatnagar, Secretary, Ministry of Education and Natural Resources and Scientific Research, Dr. D. M. Sen, Secretary, Education Department, West Bengal, and by Lady Ranu Mookerjee. Other distinguished visitors included the celebrated organic chemist Prof. A. R. Todd, of the University of Cambridge, U. K.

Council Election, Deaths, Resignations and Enrolment of Members

The annual election of Ordinary Members of the Council was held as usual during the months of April and May, 1952, and the result announced at the Annual General Meeting held on July 28, 1952. Prof. S. K. Mitra, Prof. N. R. Sen, Dr. Atmaram, Dr. B. C. Guha and Dr. Triguna Sen were elected Ordinary Members of the Council. Dr. S. K. Banerji, tendered resignation of his membership of the Council and Sri J. M. Sen was appointed in his place till the next election. The National Institute of Sciences of India nominated Dr. B. B. Dey and Dr. D. S. Kothari and the Govt. of India Sri M. S. Bhatnagar, Jt. Secretary to the Govt. of India, Ministry of Finance, on the

Council of the Association for 1952-53. Prof. S. C. Sirkar was appointed Professor-Member of the Council.

Hon'ble Sri C. C. Biswas resigned his Trusteeship and Membership of the Council on account of his continuous absence from Calcutta. Prof. M. N. Saha resigned his Trusteeship and Vice-Presidentship of the Association on assumption of duties as Director.

During the year under review, death was reported of Sri Nalini Ranjan Sarkar, a Life-Member of the Association, who passed away on January 25, 1953, and of Sri Nirmal Chunder Chunder, a Trustee and Member of the Council, who passed away on March 1, 1953. The Council, at its meeting held on March 3, 1953, condoled the death of Sri Sarkar and Sri Chunder and remembered the conspicuous services Sri Sarkar rendered to the cause of advancement of scientific and technological education and of the economic development of the country in general and the invaluable services Sri Chunder rendered to the cause of the Association. Copies of resolutions expressing deep sense of sorrow and loss at their death were conveyed to the members of their bereaved families.

Thirteen gentlemen were elected and four were admitted as Ordinary Members of the Association. One gentleman was admitted as a Life Member. During the same period four gentlemen ceased to be Ordinary Members for non-payment of subscription within the stipulated period and three voluntarily resigned their membership.

Election of Fellow and the Appointment of Trustees

S. R. Bose and Dr. K. R. Ramanathan were elected Ordinary Fellows of the Association at the last Annual General Meeting. Dr. P. N. Brahmachari and Prof. S. K. Mitra were appointed Trustees of the Association in place of Hon'ble Sri C. C. Biswas and Prof M. N. Saha respectively whose resignations have been reported earlier, at a General Meeting of the Association held on February 5, 1953.

Meetings of the Council and Committees

During the year under review, besides the Annual General Meeting and two Special General Meetings, six meetings of the Council, three of the Finance Committee, six of the Staff Committee and six of the Construction Committee were held.

Research Departments, Appointments etc.

The Departments of X-rays and Magnetism, Optics, Physical Chemistry, Organic Chemistry, and Theoretical Physics continued their research activities with full personnel. As reported earlier, Prof. P. Ray took charge of the Department of Inorganic Chemistry from the beginning of January 1953, and appointments to posts which previously remained vacant were made. At present the Department is functioning with full personnel.

Regarding leave and new appointments, Prof. K. Banerjee, MLS Professor of Physics, went on leave to join the Allahabad University as Professor of Physics. Dr. S. M. Mukherjee, Reader in Organic Chemistry, who went on

leave last year to join the East Punjab University as Professor of Chemistry, resigned his post, and in his place Dr. Phanindra Chandra Dutta was appointed Reader in Organic Chemistry. Dr. Dutta joined on March 4, 1953. Dr. Jyotirindra Nath Sen who was appointed Research Officer in Physical Chemistry in the leave vacancy of Dr. Sadhan Basu, was awarded a post doctoral research fellowship of the Iowa State College, U. S. A. and he left for the States in June 1952. Dr. Mihir Nath Das was temporarily appointed Research Officer in the leave vacancy of Dr. Basu. Sri Amal Kumar Ray Chaudhuri joined the Department of Theoretical Physics as Research Officer on September 15, 1952.

Research Schemes

C.S.I.R.—During the year under review, the Council of Scientific and Industrial Research sanctioned the following schemes:—(1) Construction of Osmometers suitable for High Polymer Research; (2) Construction of Light Scattering Apparatus for measurement of size, shape, and molecular weight of High Polymers; and (3) Studies on Thermodynamic Properties of High Polymer Solutions. The first two schemes were continued from the previous year.

Development Scheme for Research Training Facilities under the Scientific Man Power Committee.—This scheme initiated by the Ministry of Natural Resources and Scientific Research was continued from the previous year, 8 senior and 6 junior research scholars worked under the scheme in the following Departments: 2 senior and 2 junior scholars in the Department of X-rays and Magnetism; 1 senior and 2 junior scholars under the Department of Optics; 1 senior and 2 junior scholars under the Department of Physical Chemistry, and 4 senior scholars under the Department of Organic Chemistry.

Doctorate Degrees received during the year

During the year under review, Dr. Girija Bhusan Mitra, of the Department of X-rays and Magnetism, and Dr. Vedantam Venkateswarlu, of the Department of Physical Chemistry, were admitted to the degree or Doctor of Philosophy (Science) of the Calcutta University for researches on 'X-ray Diffraction Study of Coal', and 'Studies on Solubilization of water in non-polar solvents by cationic detergents' respectively.

Lectures

Dr. N. K. Bose, Director, River Research Institute, West Bengal, delivered a course of four lectures on 'Fluid Dynamics—Theory and Practice' as Ripon Professor of the Association for 1947, on August 30, and September, 15, 16 and 17, 1952. Prof. K. Venkataraman, D.Sc., F.I.G., A.M.I. Chem. E., Modi Professor and Director, Department of Chemical Technology, University of Bombay, delivered a course of three lectures on 'Constitutional Problems concerning vat dyes' as Coochbehar Professor of the Association for 1948, on March 5, 6 and 7, 1953. Dr. K. Biswas, M.A., D.Sc., (Edin), F.R.S.E., F.N.I., F.B.S., Superintendent, Indian Botanic Garden, delivered the Memorial Lecture on 'The vegetation of the Eastern Sikkim Himalayas', illustrated with

technicolour 16 mm film, on the occasion of the 49th death anniversary of late Dr. Mahendra Lal Sirear, the Founder of the Association.

Twenty-fifty Anniversary of the Discovery of Raman Effect

A meeting of the members of the Association was held on March 7, 1953 to celebrate the 25th anniversary of the discovery of Raman Effect. The sequence of events leading to the discovery of Raman Effect on February 28, 1928, was narrated briefly by Prof. S. C. Sirkar, with experimental demonstration. Prof. M. N. Saha, Chairman of the meeting, observed that the discovery was one of the most important discoveries in science of this century and that not only the Association but the whole country took pride in the fact that the discovery was made in the laboratories of this Association. This meeting and later on the Council of the Association adopted resolutions expressing sincerest felicitations to Prof. C. V. Raman on the occasion of the 25th anniversary of the discovery now bearing his name, which was also conveyed to Prof. Raman.

Library

During the year 163 volumes were added to the Library stock of books. The Association subscribed to 69 journals and in addition received 87 periodicals in exchange of the Indian Journal of Physics and Proceedings of the Indian Association for the Cultivation of Science and issues of 28 periodicals and Bulletins as complimentary copies. A list of these books and periodicals will be found in the Appendix to this Report.

Indian Journal of Physics and Proceedings of the Indian Association for the Cultivation of Science

During the period April 1952—March 1953, 12 issues of Vol. 26 of the journal were printed. The report of the lectures delivered in the Association by Prof. E. Amaldi in January, 1951, was also printed during this period and it was included in the December 1952 issue of the journal as Proceedings of the Indian Association for the Cultivation of Science.

The year of the journal continued to be the calendar year. During 1952, 110 papers were received for publication as against 79 during the previous year. Of these 79 papers were accepted for publication after editorial revision and one after modification. 63 papers and one article as Proceedings of the Indian Association for the Cultivation of Science were published in 1952 volume (15 of which were brought forward from the preceding year). These comprised 683 pages and 40 plates as against 622 pages and 33 plates published in the preceding year. The remaining 31 papers are being published in 1953 volume.

The number of subscribers in 1952 was 150 through the Indian Physical Society (at concessional rate), 68 others in India and 200 abroad. The corresponding figures in the previous year were 110, 65 and 187 respectively. The number of copies sent in exchange of other journals, was 102; and 148 copies were sent to members of the Association and to various well known institutions as presentation copies.

The Board of Editors consisted of the following members: Prof. K. Banerjee, Dr. D. M. Bose, Prof. S. N. Bose, Dr. K. R. Dixit, Prof. S. K. Mitra, Prof. P. Ray, Prof. K. R. Rao, Prof. M. N. Saha and Prof. S. C. Sirkar (Secretary).

Donations and Grants-in-aid

We gratefully acknowledge the receipt of the following grants-in-aid, capital, recurring and on account of the various research schemes:

II. RESEARCH WORK CARRIED OUT IN THE DEPARTMENTS DURING THE FINANCIAL YEAR 1952-53.

A. DEPARTMENT OF X-RAYS AND MAGNETISM

The following programme of work has been undertaken during the present year :-

(1) Crystal magnetism;

- Electrical and magnetic properties of semi-metals and semiconductors;
- (3) Cryogenics;
- (4) X-ray crystallography;
- (5) Study of low angle scattering of X-rays;
- (6) Study of extra-Laue-spots;
- (7) X-ray study of glass;
- (8) X-ray study of coal.

Crystal magnetism

In the paramagnetic salts of the iron group of elements the permanent magnetic moments of the ions are considerably modified by the action of the crystalline electric fields. A. Bose and S. C. Mitra have shown that the mean magnetic moment at room temperature for a given paramagnetic ion does not change very appreciably in a series of similarly constituted salts, apparently indicating that the crystalline electric field, either of the short range or long range type, in these salts are not very different. Exception occurs in the case of the salts of V***, Fe** and Co** ions in which the orbital contributions to the moments are high, and also in passing from the solid salt to the solution state in which long range fields vanish. In most cases, however, a critical study by Bose and Mitra, of the temperature variations of the moments, show that the long range fields and sometimes even the short range fields may change with temperature as also from salt to salt of the same ion, not observable for various reasons from room temperature data.

It has been further suggested that the Jahn-Teller conditions of stability of the nearest cluster of diamagnetic ions and dipoles about the paramagnetic ion may have repercussions throughout the crystal lattice and thereby cause most of the anisotropy of the long range fields.

The long range fields being mainly asymmetric in nature, the magnetic anisotropies in a series of isomorphous salts should serve as an indication of the changes of the long range structure and the electric field from salt to salt and with temperature. S. C. Mitra's measurements of the magnetic anisotropy of the crystal of some Cu⁺⁺ and Ni⁺⁺ salts over a range of 80°K to about 340°K have been uniquely correlated with the anisotropy of the Cu⁺⁺ and Ni⁺⁺ ions in these salts with the help of available X-ray and paramagnetic resonance data. Interesting conclusions regarding the long range fields in these salts are drawn.

A systematic accurate re-measurement of the magnetic behaviours of many of the salts of the iron group measured earlier, have been undertaken and

completed by S. K. Dutta, in view of the great interest created by the effect of the long range fields in the iron group of salts as mentioned. In course of this, he has very accurately determined the torsion constant of quartz fibres and the magnetic field and taken special precautions for making crystals of the highest purity and perfection.

- S. K. Dutta, S. K. Dutta Roy and A. K. Dutta have undertaken to develop a new electrodynamic method for measuring the magnetic field.
- S. K. Dutta Rov has undertaken and completed the magnetic study at room temperature of a large number of alums of Cr*** with different alkali cations with a view to studying the effect of long range fields. For this purpose he has set up a modified form of Curie balance with high sensitive and stability. He has now taken up the construction of a cryostat for extending the measurements down to 55°K.
- A. Chaudhury has undertaken a complete investigation of the magnetic behaviour of salts in solution to estimate the magnitude of the long range field effect in these salts.

Magnetic and electric behaviours of semimetals and semiconductors

- A. K. Dutta has completed measuring the anisotropic electric conductivity of graphite crystals over the range 80°K to 500°K and its dependence on crystal dimensions, magnetic field, etc. It has been shown by him that the earlier assumption of a three-election or one election Brillouin zone in graphite must be replaced by one of a four-election zone, which is consistent with the magnetic and the electric properties of graphite. It follows from these that graphite behaves like a semi-metal with regard to its properties in the basal plane and as a semi-conductor in the normal direction.
- A. Choudhury has undertaken to develop a new and interesting method of measuring the electrical conductivity for highly anisotropic substances like graphite, from the observed damping of the oscillations in a magnetic field, owing to the generation of eddy currents.

Cryogenics

After overcoming many initial technical and other difficulties, the boiling point of hydrogen, 20°K, has been reached by a single adiabatic expansion of the H₂ gas precooled to 60°K, obtained by the rapid boiling of liquid O₂ under reduced pressure. But the quantity of gas liquefied was not more than a few e.e. and further the arrangement was not suitable for accurate measurement of temperature and other physical properties in the liquid H₂ range. Modifications are being made to improve production and facilitate physical measurements with the apparatus. Another liquefier for continuous production of liquid H₂ is nearing completion. The work with our turbo-expansion air liquefier scheme has not progressed much owing to lack of finance and helping hands.

X-ray determination of crystalline structure
Limonite was regarded as an amorphous substance by the geologists for

a very long time. From the x-ray powder diffraction photograph it has been established definitely by D. R. Dasgupta that it is a crystalline substance. The interpretation of the powder diffracion pattern by the Hesse's method reveals that it belongs to the tetragonal class of crystal having the cell dimensions, a=b=6.985 A.U., c=12.59 A.U., and 8 molecules per unit cell. The determination of its space group is in progress.

The Patterson synthesis for the direct determination of interatomic vectors for benzil, carried out by S. C. Chakravarty, did not show clearly any peak. So, the method of trial and error is being tried for the determination of an approximate structure. In choosing the trial structure it has been necessary to take into account that the magnetic data given by Krishnan et al for this crystal are found by the present worker to be largely in error. The accurate atomic coordinates will next be determined by the double Fourier synthesis. He is also studying the structure of fluoranthene crystals for which magnetic data are available.

From the single crystal rotation photographs of pthallic acid, its cell dimensions have been measured by D. M. Chakrabarty. The axial length along the symmetry axis have been found to to be double of the value reported earlier by Becker and Janke. Normal beam and equi-inclination Weissenberg photographs are being taken for the determination of space-group and the structure of the crystal. From the studies on the long range crystalline electric field in paramagnetic salts, certain interesting results such as variations in principal magnetic axes and magnetic anisotropies with temperatures and from salt to salt have been observed, which can only be fully explained with the help of accurate x-ray structure of these salts. This work on some single and double sulphates of Cu⁺⁺ and Ni⁺⁺ has also been started by S. C. Chakravarty and D. M. Chakravarty.

The three dimensional Fourier analysis of the anthraquinone structure is being continued by B. V. Ramanmurthy.

Low angle scattering

The study of the low angle x-ray scattering by the method of Dr. K. Banerjee and J. C. Maitra of some high polymers like rubber and gutta percha have been undertaken by Dr. G. B. Mitra.

The general problem of Fraunhofer scattering by a three dimensional continuous and transparent medium has been mathematically solved and its physical applications have been discussed by N. N. Gupta. It is found that within certain angular limits of the scattering angles some maxima and minima occurred in the intensity pattern, gradually shifting towards smaller angles with the increase of the particle size of the scattering media. It is also seen that scattering of the medium at low angles is identical with the well-known phenomenon of x-ray low angle scattering.

Extra-laue-reflections

The studies on the nature of the scattering domains and the determination of elastic constants of crystals from extra-Laue reflections at room temperature and various low temperatures are being continued by R. K. Sen. The abso-

lute intensities of the extra reflections of benzil at room temperature have been measured from Laue photographs by comparing the relative intensities of the spots with the absolute intensites of the reflection from NaClO₂ crystal.

X-ray studies of coal and carbon black

Identification and quantitative estimation of minerals in different samples of coal have been continued by Dr. G. B. Mitra. Detailed investigations regarding the mineral contents of coal samples from different seams in Jharia fields, Barakar series, revealed that each seam contained a particular mineral assemblage characteristic of the seam, so that a seam may be identified by means of its mineral assemblage. This solves a persisting problem of coal geology.

X-ray diffraction study of carbon blacks obtained from benzene, toluene and xylene by Dr. (i. B. Mitra has revealed the presence of a diffraction band corresponding to a spacing of 7.11 A.U. in addition to the usual graphite spacings. The diffraction photographs of pure carbon obtained by carbonising pure sucrose under vacuum did not reveal any such band. It is suggested that the presence of hydrogen and oxygen atoms in the lattice has deformed it causing the appearance of the 7.11 A.U. band.

Radial distribution pattern of carbon atoms in a few high pressure carbonised organic substances has been studied by the application of Fourier technique on the intensity curves of x-ray diffraction pattern of these samples by N. N. Gupta. The result shows a pattern different from that of diamond and graphite.

X-ray diffraction studies of glass

Dr. B. K. Banerjee continued the work on x-ray diffraction studies of colloidal coloured glass. The nature of the dispersed phase, the relation between the size of the dispersoid with concentration as well as heat treatment and the influence of the dispersoid on the structure of the original glass base have been studied. Studies on phase transformations due to temperature and catalytic effect of the silicates and aluminium phosphates are in progress.

Technical inventions and improvements

Several improvements in the existing Hadding tubes for accurate focussinfluence of the dispersoid on the structure of the original glass base have been made. As our recording microphotometer purchased under C.S.I.R. scheme had to be returned, we have started converting our original nonrecording microphotometer into a recording one.

B. DEPARTMENT OF OPTICS.

The investigations carried out in the Department during the year 1952-53 can be classified under the following headings:

- Ultraviolet absorption spectra of organic substances in the solid state at low temperatures;
- (2) Raman spectra of some organic compounds in solid state at low temperatures;
 - (3) Raman spectra of solutions of organic compounds;
- (4) Depolarisation of Rayleigh scattering in polar and non-polar molecules at different temperatures;
 - (5) Absorption of Ultra High Frequency radio waves in organic liquids;

- (6) Structure of resonance line of sodium filtered through sodium vapour at different pressures;
 - (7) Ultraviolet absorption spectra and fluorescence of diamond.

Ultraviolet absorption spectra of organic substances in the solid state at low temperatures

In continuation of his previous work H. N. Swamy studied the ultraviolet absorption spectra of ortho-and paradichlorobenzene and paradibromobenzene in the solid state at different temperatures, besides those of many other substituted benzenes. He observed that in the case of the ortho compound the absorption bands given by the liquid is split up into three bands in the case of the crystal. No such splitting was observed in the case of the para compounds. The bands due to the latter two compounds in the solid state at room temperature have almost the same width as that in the case of the liquid state, but they become much narrower when the temperature of the crystals is lowered to -180°C. The broadening has been assumed to be produced by fluctuation of intermolecular field due to angular oscillations of the molecules in the lattice at room temperature and the sharpening temperatures to be due cessation of such oscillations low temperatures. In the case of o-, m- and p- chlorotoluene that the bands shift towards longer wavelengths with liquefaction of vapours. In the case of o- and m-chlorotoluene the again shift towards shorter wavelengths with solidification and also the principal bands are accompanied by fainter satellites. He has concluded that these changes indicate formation of virtual bonds between neighbouring molecules. In the case of ortho- and parachlorophenol and parabromotoluene also he observed similar shifts of the bands with change of state, and in these cases also, the results indicate formation of virtual bonds between neighbouring molecules in the solid state.

A. R. Deb has studied the ultraviolet absorption spectra of dibenzyl, diphenyl methane, ethyl benzoate and biphenyl in the solid state at -180°C and has compared them with those of the substances in the liquid and vapour states. He has observed that the absorption bands are very broad in the case of these substances in the liquid state and except in the case of ethlybenzoate they become sharper when the substances are solidified and cooled to -180°C. In the case of biphenyl a very broad band is given by the liquid and this band splits up into two groups of bands when the substance is solidified and cooled to -180°C.

Raman spectra of some organic compounds in the solid state at low temperatures

The Raman spectra of 1,3-dibromopropane and 1, 2, 3-trichloropropane in the solid state at low temperatures were studied by B. M. Bishui who observed that some of the Raman lines disappear when 1, 3-dibromopropane is solidified, while in the other case all the lines persist after solidification, although presence of rotational isomers is equally probable in both the cases.

Sirkar and Roy studied the Raman spectrum of monomeric methylmethacrylate in the solid state at -180°C and observed that the intensity of the line 1638 cm⁻¹ due C=C valence oscillation diminishes considerably with the solidification of the monomer.

This shows that as in the case of the polymer, in the case of solidified monomer also bonds are formed between neighbouring molecules at the expense of C=C bond. Roy has further studied the Raman spectrum of the polymer at -180°C and has observed shifts in the position of some of the lines.

The Raman spectra of solutions of organic compounds

The Raman spectra of solutions of some organic liquids in different solvents were studied by T. A. Hariharan to find the influence of intermolecular field on the intensities and positions of the lines. In the case of 1, 2, 3-tri-chloropropane he observed that when the liquid is dissolved in dioxane the intensity of the linne 872 cm⁻¹ diminishes considerably.

Depolarisation of Rayleigh scattering in polar and non-polar molecules at different temperatures

The factors of depolarization of the Rayleigh scattering in ortho- and para crosol, ortho- and para chlorotoluene and carbon tetrachloride have been measured by the method of photographic spectrophotometry for different temperatures of the liquid by Majumder and the values of isothermal compressibilities of the first two liquids have also been determined. The values of anisotropy of the molecule calculated from these results show that due to the association of the polar molecules at room temperature in the ortho compounds the anisotropy at the room temperature is less than that at higher temperatures, while in the para compounds no such change is observed.

Absorption of ultrahigh frequency radiowaves in organic liquids

In continuation of the previous work in this line done in this laboratory by other workers D. K. Ghosh has studied the absorption of U. H. F. radio waves of frequencies ranging from 250-920 Mc|sec. in chlorobenzene, bromobenzene, o-xylene and m-xylene. Absorption peaks due to single molecules and dimers have been observed at different temperatures in the case of the first two compounds. In the case of the other two compounds peaks due to dimers have been observed at low temperatures.

Ultraviolet absorption spectra and fluorescence of diamond

In continuation of his previous work on structure of resonance line of mercury filtered through mercury vapour G. S. Kastha has investigated the structure of D lines of sodium filtered through sodium vapour at different pressures, using a 12 ft. concave grating, in its third order. He has observed that during transmission through the vapour a small fraction of the incident intensity is re-emitted with modified frequency so that the absorbing vapour never absorbs the resonance line completely. A qualitative explanation of the phenomenon has been offered by him.

Structure of resonance line of sodium filtered through sodium vapour at different temperatures

In continuation of his work on origin of fluorescence of diamond B. M. Bishui studied the ultraviolet absorption spectra of eight specimens of diamond of different types and also measured the intensities of the fluorescence band at 4156Å, taking the intensity of the Raman line 1332 cm⁻¹ as the standard. He observed that the fluorescence band is strong in the case of crystals showing two obsorption bands at 2360 and 2363.5 Å due to presence of some impurity which does not produce any other absorption bands on the longer wavelength side. He also found that other impurities produce continuous absorption on the shorter wavelength side, but the intensity of the fluorescence band 4156 Å is smaller in these cases. He further observed that the purest variety of diamond does not show any fluorescence or absorption band on the longer wavelength side of 2240 Å, and he concluded from the results that such a diamond should be classified under Type II.

C. DEPARTMENT OF THEORETICAL PHYSICS

The investigations in the Department have been mainly in the following lines:

- (1) Meson Field Theories and Nuclear scattering;
- (2) General Theory of Relativity;
- (3) α-decay Phenomenon.

Meson field theories and nuclear scattering

In the previous report it was mentioned that the present trends of the expérimental results would indicate that the meson is to be described by the pseudoscalar field equations. In continuation of that idea, the cross section for the production of mesons in neutron—proton collision, a third order process, has been calculated by D. Basu on the basis of the charged pseudoscalar theory with pseudoscalar coupling. If the recoil of the nucleon initially at at rest is neglected, the cross section vanishes. Taking the value of the coupling constant to be 0.3, the numerical value of the cross section is of the order of 10⁻²⁶ cm₂ and the total cross section varies as log Ep₀, Ep₀ being the energy of the incident nucleon. The validity of the results for high energies is only restricted by the fact that radiation damping has been neglected.

In quantum mechanics, the equations which include radiation damping often do not admit easy solutions, as such recourse to approximate methods of solution has to be taken; whereas treatment of similar problems in classical mechanics includes radiative reaction exactly but neglects quantum effects. The problem of the scattering of charged pseudoscalar meson by nucleon has been approached quantum mechanically by S. N. Biswas and classically by N. C. Sil. Following the semivariational method of Hsüch and Ma, S. N. Biswas has investigated the reaction of radiation on the scattering of charged pseudoscalar meson (pseudoscalar coupling) by nucleons. It is shown that the scattering cross section reaches the maximum value round about the energy value of 250 Mev; further the scattering by proton of positive meson is greater than that of negative meson which result is in agreement with the experimental finding. In a second paper the well-known Heitler's integral equation for the problem of the scattering by proton of scalar meson has been solved by the newly developed variational technique of Goldberger which is an improvement over that of Hsüch and Ma. Recently the investigations are in progress with a method, due to C. Wagner, which is based on numerical solution of integral equation by means of iterative process. N. C. Sil has solved

classically the equations of motion, the radiation reaction being included, of the nucleon in interaction with the charged scalar meson field. Taking the values of the coupling constant to be the same as determined in M.—R. interaction, the cross sections for the scattering of positive and negative meson by proton reach their maximum values near about 250 Mev.

The high energy proton-proton scattering shows an angular isotropy. None of the mesonic interactions as derived from field theoretical considerations can explain this phenomenon. C. C. Banerji has studied the relative importance of the different components of the pseudoscalar interaction in relation to their contributions to the value of the differential cross sections. His results, which will appear soon, indicate that it is not possible to explain in a simple manner the angular isotropy of the p-p scattering at high energies. He is now working to find further consequences of the 'hard core model' of Jastrow and 'tensor force model' of Christian and Noyce.

General theory of relativity

An investigation of solutions of Einstein gravitational equations, representing a spherically symmetric field of pure radiation in an otherwise empty space, was undertaken by A. K. Raychaudhuri. It has been found that there does not exist any such solution which is regular everywhere. This result has been interpreted as indicating that, subject to the restriction of spherical symmetry, a complete conversion of isolated matter in bulk into radiation is not permissible (such a conversion being considered as a combination of very large number of elementary conversions).

As is well known, there are two great difficulties with the generally accepted isotropic cosmological models of general relativity. Firstly, the molels start from a singular state, and secondly, the time scale is very short. To have an idea as to the modifications which may make the models free from these defects, if indeed it is at all possible within the structure of general relativity, the temporal behaviour of a gravitating system is being investigated under general conditions. The preliminary results show that a simple change over to anisotropic models would not remove the difficulties. However, if there be a nonvanishing spin relative to the compass of inertia, then under certain circumstances there is an oscillatory behaviour between two regular states and the time scale is also sufficiently large. The implications of this type of cosmological models in the theory of origin and abundance of nuclear species are now being studied.

a-decay phenomena

The investigations of M. L. Chaudhury were concerned with the spectral aspect of α -decay phenomena. A new correlation has been found in λ vs. E. relation and the interesting point of it is that the existence of anti-Geiger-Nuttal trend is really as frequent as the well known Geiger-Nuttal trend in α -spectra which further reveals a discrepancy of the order of 10^{13} in some cases with the α -decay theory of Gamow.

D. DEPARTMENT OF PHYSICAL CHEMISTRY

The following are the chief problems on which work has been under active progress in the laboratory during the year under review.

High polymer chemistry

- (1) Chain transfer in vinyl polymerization;
- Kinetics and Chain transfer studies in hydrogen peroxides initiated polymerization;
- (3) Synthesis of substituted dibenzyol peroxide and their use in polymerization;
- (4) Vinyl polymerization with metallic soaps;
- (5) Fractionation and distribution of polymers;
- (6) Polyelectrolytes;
- (7) Cellulose Chemistry.

General physical chemistry

- (8) Studies on co-solvency;
- (9) Dielectric constant and dipole moment measurements;
- (10) Determination of partial molal volume by refractive index;
- (11) Viscosity—Molecular weight relation of homologous liquids and high polymer;
- (12) Kinetics of decomposition of peroxides;
- (13) Alkalimetric determination of mercury;
- (14) Estimation of unsaturated organic compounds.

Chain transfer in vinyl polymerization

Our study on chain transfer has been continued by S. K. Das. Work on vinyl acetate with 8 hydrocarbons, 2 ketones and 4 alcohols has been completed. In this connection chain transfer of different catalysts like benzoyl peroxide, hydrogen peroxide and 2-2' azobis-isobutyronitrile has been determined, and it has been observed that a catalyst at low concentration does not undergo any transfer with vinyl acetate.

Further the temperature coefficient of transfer in 14 solvents has been determine with the monomers styrene and methyl methacrylate. Previous work on halogenated solvent has been extended.

Kinetics and chain transfer studies in hydrogen peroxide initiated polymerization

The study on the kinetics and chain transfer of vinyl polymerization of methyl methacrylate initiated by hydrogen peroxide has been carried out by Umasankar Nandi. Catalyst has been found to have no detectable inhibition period but is highly sensitive towards inhibitors. The rate of polymerization follows the square root relation and the initation mechanism has been found out to be bimolecular. It has been further observed that the solvent monomer transfer constant remains fairly unaffected, being independent of the catalyst concentration within a limit of 125.0×10^{-4} gm mol/litre. The work is in progress.

Synthesis of substituted dibenzoyl peroxides and their use in polymerization

The synthesis of 16 different substituted dibenzoyl peroxides has been carried out by N. G. Saha. Rates of initiation, kinetics, and chain transfer with these peroxides have been studied both in bulk and solvent polymerization of methyl methacrylate, methyl acrylate, styrene, and vinyl acetate at different temperatures. A number of solvents have been studied in the case of solvent polymerization and the work is in further progress.

The preparation of the azo nitriles has been undertaken and polymerization of methyl methacrylate in bulk and solvents with some of them, has been completed.

Vinyl polymerization with metallic soaps

A. K. Chowdhury has been able to confirm our previous observation that ferrric laurate has got pronounced catalytic effect and has found out that oxygen has strong retarding effect and causes irreproducible results.

S. Sarkar has completed preliminary work on vinyl polymerization catalyzed by cobalt soaps. It is intended to apply the tracer technique by using radioactive cobalt to establish the mechanism of the initiation process.

Fractionation and distribution of polymers

Following a new mathematical technique, recently developed by Tompa and Melville, a distribution equation in polymerization with solvent transfer has been deduced. Fractionation experiments are being conducted to compare the equation with experimental data.

Polyelectrolytes

Synthetic copolymers of maleic anhydride with some of the vinyl compounds like styrene, vinyl acetate etc., have been prepared and their properties are being studied. The results obtained so far essentially confirm the theory of the behaviour of polyelectrolytes which was originally advanced by Fuoss. In this connection the kinetics of hydration of maleie anhydride—vinyl acetate copolymers have been measured.

B. B. Mukherjee and M. N. Das have undertaken a study of the polyelectrolytic properties of poly- 2- vinyl pyridine in glacial acetic acid medium and in acetic acid-nitromethane mixtures. It is intended to investigate the behaviour of polyelectrolytes in solvents of very low dielectric constants.

Physico-chemical studies on cellulosic compounds

D. K. Roy Choudhury has prepared various cellulosic compounds such as benzyl edifas, diphenyl methyl edifas and diphenyl methyl cellulose. Their physical properties such as viscometric and osmometric studies have been made.

Moreover several types of osmometers have been designed and constructed under a C.S.I.R. scheme and they are giving very good results in osmotic pressure measurements with these compounds as well as other polymers.

Studies on co-solvency

Studies on enhanced solubility in solvent mixtures have been continued by G. R. Somayajulu. Anomalous enhanced solubility of anthracene in the mix-solvent system: benzene and ethyl iodide, has been recorded. This result is quite unexpected on the basis of the theory of regular solutions as developed by Hilderbrand. Work is now extended to analogous systems to throw some light on the phenomenon.

Dielectric constant and dipole moment measurement

Polarization of water solubilized in benzene and similar solvents by detergents is being studied by S. K. Sen.

Determination of partial molal volume

A method for the determination of partial molal volume from refractive index measurements has been proposed. The equation.

$$(V_2)_0 = \frac{1}{r_1} \left\{ v_1 R_2 - 6 M_2 r_0 \left(\frac{v_1}{v_1^2 + 2} \right)^2 \right\}$$

has been deduced and the calculated values of (V_2) obtained from this equation with a few recent data of n and d are found to be in quite good agreement with the observed ones. It is intended to test the equation more thoroughly from precise data to be obtained by using an interferometer.

Viscosity-molecular weight relation of homologous liquids and high polymers

Using Telang's absolute viscosity equation deduced from Eyring's rate theory of viscosity, Palit has deduced the following relationship for the viscosity variation of homologous liquids (25°C):

$$\log \eta M = 0.16 \times 10^{-2} \text{y} (M/d)^{2/3} + k_2$$

where n, M, y, d and k_2 are viscosity, molecular weights, surface tension density and a small constant respectively. In other words, log molar viscosity plotted against molar surface energy for members of a homologous series gives a straight line of slope of almost one-sixth of one per cent. This equation has been found to be remarkably true from published data for hydrocarbons, alcohols, and esters. Work is in progress to test its validity for other compounds, and mixtures of homologoues.

For high polymers this equation can be transformed to the very simple form

 $100 \rho_0 [\eta] + \ln M = k_1 M^{\eta/3} + k_2$

where ρ_0 is the density of the solvent, in which $[\eta]$ is the intrinsic viscosity of the polymer and k, is a constant whose value is near about 10^{-2} , the value increasing with the polarity of the compound. The equation has been found to be in agreement with all dependable published data.

Kinetics of the decomposition of peroxides

U. S. Nandi and N. G. Saha have undertaken the study on the kinetics of the decomposition of different peroxides. Hydrogen peroxide, cinnamoyl peroxide and benzoyl peroxide have been studied in various types of typical solvents, pure monomers and nonomer-solvent mixture at 80 and 60°C. The kinetics of both induced and direct decomposition have been studied and the work will be continued with other substituted dibenzoyl peroxides and fatty acid peroxides.

Alkalimetric determination of mercury

M. N. Das has developed a method for alkalimetric determination of mereuric mercury by utilizing the solubility of mercuric oxide in aqueous acetone and the reaction of iodide or thiosulphate on the mercuric oxide-acetone complex which results in the liberation of two moles of alkali per mole of mercury. Estimation of mercury as well as its separation from other heavy metals has been effected by hydrolytic precipitation of the interfering metal ions in aqueous acetone.

Estimation of unsaturated organic compounds

M. N. Das has developed a method for determination of unsaturated organic compounds by making use of the addition of mercuric acetate to carbon—carbon double bonds in methanol as solvent. A known excess of mercuric acetate is allowed to react with the unsaturated compound, and after the reaction is over, the unreacted mercuric acetate is estimated by non-aqueous titration with HCl in propylene glycol—chloroform using thymol blue as indicator. The method has been successfully used for determination of styrene, vinyl acetate, allyl acetate, cyclohexene and similar unsaturated compounds.

E. DEPARTMENT OF ORGANIC CHEMISTRY

During the year under review the Organic Chemistry laboratories have been fitted up moderately with new equipments. Some of the research schemes initiated previously have been completed and some are being actively pursued. New research schemes have been started on the synthesis of Sesquiterpenes, Azulenes and Steroids. Dr. N. Kundu, a scholar under the Development Scheme for Research Training Facilities proceeded to Evanston, Illinois, U.S.A. with a Post-Doctoral Fellowship, offered by the North Western University.

Polycyclic hydrocarbons

B. K. Ganguly has made interesting contribution to the chemistry of polyphenyls. N. Saha has completed a new synthesis of pyrene which could be easily extended to the synthesis of carcinogens.

Resin acids

- P. N. Rao has successfully concluded a synthesis of a tribasic acid C₁₂H₁₈O₆ structurally identical with the C₁₂-acid obtained from abietic acid. He has also made some interesting observations about the stereochemistry of resin acids.
- N. Saha has developed a new method for the synthesis of important tricyclic degradation products of resin acids. He is also engaged in the development of methods of converting these intermediates to dehydro-resin acids.

Terpenes, sesquiterpenes and azulenes

- P. B. Talukdar has completed an unambiguous syntheses of camphononic acid and homoapocamphoric acid.
- P. K. Dutta and A. K. Das Gupta have undertaken a synthesis of dihydroclovene. B. K. Ganguly has started work on the synthesis of selinenes and its degradation products.

F. DEPARTMENT OF INORGANIC CHEMISTRY

Only one scholar, Sri Debahrata Bandopadhyaya, was working in this department till the end of February 1953. A short account of the work carried out by him during the year under review is given below.

A study on the "Complex Salts of Benzamidoxine with Metals" has been completed and a paper has already been published. (D. Bandopadhyaya, J. 1. C, 8., 30, 119, (1953).

At present work is going on the analytical application of Salicylamidoxine. The reaction of metallic ions on Salicylamidoxine has already been investigated and the pH of incipient precipitation determined. Procedures for the gravimetric estimation of several metals have been established. Further work on the application of this reagent for the separation and colorimetric estimation of metals is in progress.
