#### **CAMPBELL**

#### OF ARDKINGLASS

**SIR COLIN CAMPBELL OF ARDKINGLASS,** was a younger son of Sir Colin Campbell of Lochawe, and obtained the lands of Ardkinglass at the head of Loch Fyne. He *m*. Christina, daughter of Robert Lamont of Inneryne, (Papal Dispensation dated in 1399), and was father of:

**SIR JOHN CAMPBELL OF ARDKINGLASS**, was witness to a mortification by Sir Duncan Campbell of Lochawe to the Collegiate church of Kilmun dated 4 August 1442,<sup>1</sup> and afterwards to an obligation by Sir Colin Campbell of Lochawe, to Cristine, son of Finlay, son of Eugene of Ardlamont, dated 21 May 1454.<sup>2</sup> He *d.* by 17 December 1470, and was father of:

**COLIN CAMPBELL OF ARDKINGLASS,** succeeded to the lands of Ardkinglass by 17 December 1470, when he was witness to a charter by Colin, Earl of Argyll, granting the lands of Barcaldine and numerous others in the Lordship of Lorn, to Sir Colin Campbell of Glenorchy.<sup>3</sup> He *d.* by February 1481, and was father of:

**JOHN CAMPBELL OF ARDKINGLASS,** succeeded and was included in the remainder in a charter under the Great Seal granting the lands of Knapdale and the custody of the castle of Castleton, in the sheriffdom of Perth, to Colin, Earl of Argyll, on 26 February 1480-81.<sup>4</sup> He was included in the remainder of a charter under the Great Seal granting the lands of Dollar to Archibald, Earl of Argyll, on 11 May 1497,<sup>5</sup> and was either identical to or else had been succeeded by:

**JOHN CAMPBELL OF ARDKINGLASS,** succeeded to the lands of Ardkinglass by 1 February 1509, when he was witness to a charter by Matthew Stewart, Earl of Lennox, granting the lands of Gairlochead to Archibald, Earl of Argyll, and made a mortification of his lands of Knockenbaynocht to the parish church of Lochgoil which passed through the Privy Seal on 31 August 1512. He *d.* between then and 16 June 1524, possibly with his Chief and a large number of his kinsmen at the battle of Flodden in September 1513, and was father of:

- 1. COLIN CAMPBELL OF ARDKINGLASS, is styled as son and heir to John Campbell of Ardkinglass when witness to a charter by Archibald, Earl of Argyll, granting the lands and castle of Skipinch to his son, Archibald Campbell, on 30 July 1511, 3 and had succeeded his father in Ardkinglass when he was witness to a transumpt of a charter by John Lamont of Ardlamont dated 16 June 1524. He was one of the arbiters at a court held in Perth on 26 June 1532, to determine the assyment due for the slaughter of Donald MacGibbon, and is named in a charter dated 3 November 1540, and in a decreet arbital dated 10 May 1548. He granted a reversion to Sir John Lamont of Inveryne for the lands of Little Tolart on 10 September 1548. He had the ward of Gilbert MacNaughton of Dunderawe and in which capacity he gave his consent to the marriage contract of this Gilbertand Geilis, daughter of Sir John Lamont of Inveryne on 27 September 1548, and in this capacity he is included in a summons raised by Alexander MacNaughton, brother and heir to this Gilbert, for the production of writs pertaining to the infetment of Geils Lamont, Gilbert's widow, in the lands of Auchentray and others, on 12 June 1554. He m. Matilda Montgomery, d. prior to 13 July 1566, when he had been succeeded by his nephew and heir male, James Campbell, and was father of:
  - 1a} Mary Campbell, m. John Campbell of Lochnell.
  - 1a) John Campbell, had a charter from Duncan Lamont, fiar of Inveryne, for the lands of Toward dated 8 December 1562, and in which he is styled as natural son to Colin Campbell of Ardkinglass,<sup>5</sup> which he afterwards disponed to Donald Campbell of Auchawhillan on 16 August 1577.

- 2. Archibald Campbell, witness with his brother Colin Campbell of Ardkinglass to a charter dated 24 September 1523, and to a transumpt dated 16 June 1524.
- 3. Dougald Campbell, of Blairwerk, (see below).
- 4. Duncan Campbell of Drumfad, to whom the deceased Dougal Campbell was styled as "brother and next person" in an action raised byJames Stirling of Keir against James Campbell, eldest son to Dougal, Janet Graham, his relict, and Colin Campbell of Ardkinglass, for not renouncing a wadset of the lands of Dronky and others on 22 June 1557. He m. by 29 April 1536, to Marjory Campbell, (she was widow of Walter Graham, 1st of Boquhapple, by whom she had issue), when they had a wadset of the lands of Drongy and others, in Menteith, from James Stirling of Keir, and had dsp by 4 March 1553, when his brother's son, James Campbell, son of Dougal Campbell, was cognised his heir and successor in the lands of Calzemuk.<sup>3</sup>
- 5. Patrick Campbell,
- 6. Robert glas Campbell, of whom little is known other than he was father of :
  - 6a} Donald Campbell of Drongy, is styled as "Robert glas-son" and brother's son to the deceased Colin Campbell of Ardkinglass in an action raised against him and John Campbell of Ardkinglass, Colin's heir, by Robert Sempill of Corrith and the town council of Dumbarton on 23 January 1592-3. He *m.* in 1564, to Mariote, daughter of Sir John Campbell, 5<sup>th</sup> of Glenorchy, (she was widow of Alexander Home of Argaty and Lundies), was living on 6 March 1612, and had *d.* by 28 November 1623. He was father of:
    - 6b} John Campbell of Raheavin, to whom his parents assigned their lands by contract dated 6 March 1612, on the condition that he grant a feu charter for the lands of Drongy to his brother Robert; pay 500 merks to his brother Donald on the death of their father; to provide a liferent to their mother Marion Campbell, and maintain and pay the tochers of his sisters Margaret and Janet.<sup>5</sup> He is styled as eldest son to the deceased Donald Campbell alias Robertglassone of Drongy when he and his brother Robert disponed their lands of Dronky to William Stirling of Auchyle by Disposition dated 28 November 1623.<sup>6</sup>

- 6b} Robert Campbell of Drongy, to whom his brother onveyed the lands of Drongy which he afterwards sold to William Stiring of Auchyle. He m. Agnes, daughter of Henry Forrester of Corstorphine, (c/m 3 March 1614 $^1$ ).
- 6b} Dougal Campbell, concerning whom, on 6 March 1612, his father bound his eldest brother John to pay 500 merks on his death.
- 6b} Duncan Campbell, witness with his brother John Campbell, fiar of Dronghy, and Dougal to an action rasied by Ewen Campbell of Dergachie against John Campbell of Clachan, dated 20 November 1616.<sup>2</sup>
- 6b} Fingwall Campbell, m. John Lamont of Ascog, (c/m 10 June 1604).
- 6a} John Campbell,
- 6a) Robert Campbell, both of whom were witnesses to a contract by their brother Donald Campbell of Drongy and his eldest son, John Campbell, anent provisions to Donald's children dated 6 March 1612.
- 7. Matilde Campbell, m. Alexander MacNaughton of Dunderave, and had issue.

**DOUGALD CAMPBELL OF BLAIRWERK,** m. Janet, daughter of Patrick Graham, 1<sup>st</sup> of Inchbraikie, (she survived him and m. secondly, by 22 June 1557, to Robert Buchanan of Leny,<sup>3</sup> and d. in August of 1575<sup>4</sup>), and d. after April of 1545, and prior to 15 June 1555. He was father of:

- 1. Sir James Campbell of Ardkinglass, (see below).
- 2. Alexander Campbell, was appointed Bishop of Brechin and *m*. after 18 October 1579, to Helen, daughter of George Clephane of Carselogie, (she ws widow of Robert Arbutnott of Arbuthnott, by whom she had issue). He was father of:
  - 2a} Jean Campbell, *m*. by 2 November 1605, Sir John Hamilton of Letterick, when they had a charter from James Bonar of Rossie for the lands of Kinclaven.<sup>5</sup>
  - 2a} Marjory Campbell, m. Alexander Menzies of that Ilk,  $(c/m 20 \text{ March } 1604^6)$ .
- Colin Campbell, resided at Falkland and is styled as brother german to the deceased Sir James
  Campbell of Ardkinglass when he raised an action against George Lawson, son of Mr.

Alexander Lawson, Writer, on 31 January 1624, for payment of a Bond dated 15 February 1620.<sup>1</sup>

4. Elizabeth Campbell, m. Charles Campbell of Strachur, (c/m 21 February 1562<sup>2</sup>).

**SIR JAMES CAMPBELL OF ARDKINGLASS,** who, following the death of his father, entered into a contract with the Earl of Argyll, dated 15 June 1555, by which he and his mother were to be infeft in the lands of Blairwerck, in the Earldom of Menteith.<sup>3</sup> He had succeeded his uncle Colin Campbell of Ardkinglass in the lands of Ardkinglass by 31 March 1568, when he resigned certain of his lands into the hands of Archibald, Earl of Argyll, as superior, for new infeftment.<sup>4</sup> He d. was alive on 5 January 1591, when he was cautioner to a Bond by Alexander Drummond of Medhope,<sup>5</sup> and d. by 11 June following, when he had been succeeded by his son John, having m. Elizabeth, daughter of James Campbell of Lawers, (c/m 12 September 1564<sup>6</sup>), by whom he was father of:

- 1. Sir John Campbell of Ardkinglass, (see below).
- 2. Colin Campbell, styled as brother to Sir John Campbell of Ardkinglass when he granted a Bond to Allan Cathcart, Sabler in Edinburgh, for £12 on 1 August 1611.<sup>7</sup>
- 3. Mr. Dougal Campbell, was appointed to the Deanery of Brechin on 30 November 1581,<sup>8</sup> and is styled as brother to Sir John Campbell of Ardkinglass when witness to a charter in favour of his neice Marjory Campbell, by which her husband Alexander Menzies infeft her in a liferent of certain of his lands, dated 17 April 1604.<sup>9</sup> He is again styled as brother to Sir John Campbell of Ardkinglass when he granted a Bond to David Chirnside, Burgess of Glasgow, for £500 on 28 February 1612, <sup>10</sup> and was father of:

- 3a} Dougal Campbell, styled as son of Mr. Dougal Campbell, Dean of Brechin, when witness to a Discharge by Mr. Gavin Justice, in Stirling, to John Campbell, fiar of Cawdor, for 777 merks Scots, dated 28 November 1634.<sup>1</sup>
- 3a} Margaret Campbell, m. James MacKen, son of James MacKen, burgess of Montrose, (c/m at Brechin on 5 January 1609<sup>2</sup>).
- 4. Duncan Campbell,

**SIR JOHN CAMPBELL OF ARDKINGLASS,** succeeded his father by 5 June 1591, when Donald MacCarlich renounced his rights to the lands of Donard in his favour, and d. after 12 May 1610, and prior to 10 March 1618. He m. first, when under fourteen years of age, to m. Anna, daughter of Colin Campbell of Glenorchy, (c/m 23 July 1571 $^3$  & 21 June 1583 $^4$ ), and by her he was father of :

1. Colin Campbell of Ardkinglass, (see below).

He *m*. secondly, to Jean, daughter of John, Lord Hamilton, (she was widow of Sir Humphrey Colquboun of Luss, who had been *ksp* in July 1592),<sup>5</sup> and had further issue :

- 2. John Campbell, named in a contract with his parents dated 20 May 1603,<sup>6</sup> and had *d*. without apparent issue by 4 December 1618, when his brother Mr. James is styled as eldest son of his father by Jean Hamilton.<sup>7</sup>
- 3. Mr. James Campbell, *m*. Anna Brisbane and with whom he had a Bond from John Cunningham of Drumquhassell for 1000 merks Scots, dated 18 July 1629, in which he is styled as son of the deceased Sir John Campbell of Ardkinglass.<sup>8</sup>
- 4. Mr. Patrick Campbell, is styled as son to the deceased Sir John Campbell of Ardkinglass when witness to a contract of marriage between Ewen Campbell of Dergachie, taking burden for his sister, Élizabeth, on the one part, and Patrick MacManis, Cooper and Burgess of Dumbarton,

dated 26 May 1619.<sup>1</sup> He was witness to a Disposition by Archibald, Lord Lorne, to Archibald Campbell, Captain of Dunstaffnage, for the lands of Ardconneill, Sondochan and others, on 12 September 1634,<sup>2</sup> and was joint executor with his brother Mr. James to their mother.

5. Dougall Campbell,

**SIR COLIN CAMPBELL OF ARDKINGLASS,** succeeded his father by 10 March 1618, when Mr. Patrick Stewart, son of John Stewart of Roslind, raised an action against him for fulfillment of a Bond granted by his late father.<sup>3</sup> He *m*. Mary, daughter of Sir James Sempill of Beltrees, and was father of:

- 1. James Campbell of Ardkinglass, (see below).
- 2. Margaret Campbell, *m*. on 7 April 1634, to James Lamont, eldest son and heir of Sir Coll Lamont of Inveryne, (*c/m* 2 May 1634<sup>4</sup>).
- 3. Anne Campbell, *m*. firstly, to Hector MacNeil of Taynish and secondly, to Colin Campbell of Lochnell, (he *d*. in March of 1671).
- 4. Jean Campbell, *m*. firstly, to William Campbell of Glenfalloch, (*c/m* 12 & 22 May 1645<sup>5</sup>), and had issue; and secondly, to Francis Sempill, eldest son and heir of Robert Sempill of Beltrees, (*c/m* 4 April 1655).

**SIR JAMES CAMPBELL OF ARDKINGLASS,** succeeded his father and m. in January of 1635, Isabella, daughter of Sir Robert Campbell of Glenorchy,  $(c/m\ 19\ \text{August}\ 1636^6)$ . He was father of.

- 1. Sir Colin Campbell of Ardkinglass, (see below).
- 2. Robert Campbell of Orchard, styled as brother german to sir Colin Campbell of Ardkinglass in a Sasine dated 22 May 1683. He was father of:
  - 2a] John Campbell of Orchard, was serve heir general to his father on 3 March 1705, and dsp.

**SIR COLIN CAMPBELL, 1**<sup>ST</sup> **BARONET, OF ARDKINGLASS,** succeeded his father and was created a Baronet on 23 March 1679. He *m.* in 1673, Helen, daughter of Sir Patrick Maxwell of Newark, *d.* in April of 1709, and was father of:

- 1. Sir James Campbell of Ardkinglass, (see below).
- 2. Jean Campbell, m. on 1 August 1694, Robert Campbell, son of Sir John Campbell of Carrick.

**SIR JAMES CAMPBELL, 2**<sup>ND</sup> **BARONET, OF ARDKINGLASS,** *bap.* at Dumbarton on 26 May 1667, and is styled as only son when he was co-signatory with his father to a Discharge in fvour of Archibald Campbell, youngest son of the deceased Donald Campbell of Craigish, dated 27 August 1706. He succeeded his father in the lands of Ardkinglass and Baronetcy on his death in 1709 and to whom he was served heir on 2 February 1711. He *d.* at Gargunnock on Sunday 5 July 1752, having *m.* first, Margaret, daughter and coheiress of Mr. Adam Campbell of Gargunnock, (c/m 14 December 1696), with whom he acquired these lands and by whom he had issue:

- 1. Colin Campbell, d. on 12 March 1729.
- 2. Adam Campbell, b. on 23 September 1707, and d. young.
- 3. John Campbell, b. on 9 May 1709, and d. young.

He *m*. on 18 June 1752, to Catherine, daughter of Walter Campbell, Collector of Customs, *d*. on 21 November 1788, and was father of:
