BALFOUR

OF DENMILN

JAMES BALFOUR OF DENMILN, descended from Balfour of Montquhannie, acquired the lands of Denmiln and is said to have been *k*. at the seige of Roxburgh in 1460. He was father of :

PATRICK BALFOUR OF DENMILN, was entered in the lands of Mill of Den on 15 April 1490,¹ and *d*. by 5 April 1502, when his son John was next entered. He was father of :

JOHN BALFOUR OF DENMILN, succeeded his father in the lands of Mill of Den in which he was first entered on 5 April 1502,² then on 7 May 1505,³ and in which he was set in feu on 1 May 1508.⁴ He was k. at the battle of Flodden in September of 1513,⁵ having m. Christian Sibbald, said to be a daughter of Sibbald of Rankeilour, who is styled as his widow when she had a liferent of the lands of Denmiln confirmed to her on 2 January 1516,⁶ and was father of :

- 1. Patrick Balfour of Denmiln, (see below).
- 2. Michael Balfour, was appointed a Canon of the Cathedral Church of Dunkeld and Commendator of Melrose Abbey.

PATRICK BALFOUR OF DENMILN, is styled as a Herald when he received payment for his services in 1501,⁷ and was entered in the lands of Mill of Den on 9 November 1513,

as heir to his deceased father "qui obiit in campo de Flowdon."¹ He had a charter under the Great Seal for the lands of Denmiln as heir to his deceased father on 29 September, 1541, *m*. Janet Ballingall and *d*. in 1542² being father of :

ALEXANDER BALFOUR OF DENMILN, succeeded his father and had Sasine for the lands of Denmiln on 2 July 1546, which had lapsed and been in the King's hands for the space four years.³ He had the gift of the escheat of James Hepburn, Earl of Bothwell, on 3 March, 1568,⁴ and *d*. in August of 1587 having *m*. firstly by 18 January, 1566, to Marion Balfour when they had a charter for the lands of Fardelschaw, in the barony of Dunkeld, from his uncle Michael Balfour, Commendator of Melrose, by whom he had issue :

1. Elizabeth Balfour, m. Robert Balfour, (c/m 1 June 1584⁵).

He *m*. secondly to Janet Hay and was father of :

2. Sir Michael Balfour of Denmiln, (see below).

SIR MICHAEL BALFOUR OF DENMILN, *b. bap.* 1579/80, succeeded his father and, with his mother Janet Hay, he had a Tack of the teinds of the lands of Denmiln on 10 February, 1597.⁶ He was appointed Comptroller to the Household of King Charles I., obtained the lands of Glentarkie from the heirs of Andrew Balvaird of Glentarkie on 30 April, 1647, and *m.* Jean, daughter of James Durham of Pitkerro, (she *d.* at Denmiln on 8 November 1640). He *d.* at Denmiln on 4 February, 1652,⁷ and was father of :

 SIR JAMES BALFOUR, OF KINNAIRD AND 1ST BARONET OF DENMILN, appointed Lord Lyon, King of Arms, and was created a Baronet of Nova Scotia on 22 December, 1633, with remainder

to his heirs male whatsoever. He *m*. firstly, on 21 October, 1630, Ann, daughter of Andrew Aytoun of that Ilk, (she *d*. at Falkland on 26 August 1644), whom he infeft in a liferent of the lands of Kinnaird on 29 January 1631, and by whom he had issue ; secondly, in 1645, Jean, daughter of Sir James Durham of Pitkerro, (she was widow of James Smeaton, son of Sir John Smeaton of Stevenston, and *d*. on 19 July, 1645¹), and thirdly, Margaret, daughter of Sir James Arnot, 2^{nd} of Fernie, (she *d*. at Denmiln in December of 1653^2). He *m*. fourthly, in June of 1654, Janet, daughter of Sir William Auchinleck of Balmanno,³ *d*. at Denmiln on 13 February, 1657, aged fifty-three years, and was buried at Abdie,⁴ and was father of :

- 2. Sir Alexander Balfour, Minister of Abdie and 3rd Baronet of Denmiln, (see below).
- 3. Michael Balfour of Pitmeddan and Randerston, obtained the lands of Randerston in 1663, and *m*. firstly, Katherine, daughter of John Lepar, Provost of St. Andrews, (she *d*. in 1652). He *m*. secondly, Marie, daughter of Peter Hay of Leys, (*c/m* 9 & 11 February 1653). He entailed his lands of Randerston upon his nephew, James Balfour, and other male relatives on 23 October, 1677, and *dsp* soon after.
- 4. Sir David Balfour of Glentarkie and Forret, *bap.* at Abdie on 12 September, 1623, and to whom his father assigned the lands of Glentarkie and Pittenbrog on 24 January, 1652.¹ He was admitted an Advocate on 29 January, 1650, was Knighted in 1674 and nominated a judge in the Court of Session, and took his seat on the bench with the title of Lord Forret on 2 June 1674. The following year he was appointed a judge of the court of justiciary. In 1685 he was elected a commissioner for the county of Fife to the parliament which met that year, was chosen one of the lords of the articles, and appointed a commissioner for the plantation of kirks. He *m.* firstly, a woman whose name has not yet been ascertained, and secondly, after June of 1669, to Ann, daughter of John Forrester of Strathenry, (she was widow of William Aytoun of Feddinch, who had *dsp* on 22 June, 1669²). He was father of :
 - 4a} Michael Balfour, 2nd of Forret, succeeded his father and was served his heir on 1 November, 1707. He had his lands forfeited for his support of the Jacobite cause in 1715, and was father of :
 - 4b} James Balfour 3^{rd} of Forret, succeeded his father and disponed the lands of Forret, becoming a merchant in Edinburgh. He *m*. Christian, daughter of Sir John Carstairs of Kilconquhar, *d*, in 1763³ and was father of :
 - 4c} Ann Balfour, *m*. at Edinburgh on 20 June, 1773, to Andrew Simpson, younger of Pendreich.⁴
 - 4c} Alison Balfour, who, with her sister Ann, was retoured heir to their grandfather Robert Rutherford of Fairnlee, and their uncle, John Rutherford of Faldonside, on 16 March, 1764.

- 5a} Michael Balfour of Northbank, bap. at Edinburgh on 10 May, 1672, is named, in 1677, as one of the substitute heirs to his uncle Michael Balfour in his lands of Randerston and was witness with his father to an Instrument of Sasine for an annualrent from the lands of Mugdrum in favour of Margaret Graham, wife of Henry Cheap, fiar of Rossie, on 27 July, 1691. He was retoured heir to his father in certain lands around St. Andrews on 28 May 1696, and m. on 31 December 1694, to Christian, daughter of John Barclay and sister of Stans John Barclay of Collernie.² He was father of,
 - 5b} John Balfour, *bap.* at Dunbog on 3 September 1697.
 - 5b} Elizabeth Balfour, *bap.* at Dunbog on 3 September, 1696.

SIR ALEXANDER BALFOUR, 3RD BARONET OF DENMILN, was appointed Minister of Abdie and succeeded his nephew Sir Robert Balfour, 2nd Baronet of Denmiln, in the lands of Denmiln and to whom he was retoured heir on 29 July, 1674.³ He d. by 22 July 1675, when his eldest son Michael was retoured his heir, having *m*. first, Euphemia Carstairs, (she *d*. in August of 1634^4), by whom he was father of :

SIR MICHAEL BALFOUR, 4TH BARONET OF DENMILN, succeeded his father and was retoured his heir in the lands of Denmiln on 22 July, 1675.¹ He m. Jean, daughter of Sir John Aytoun of that Ilk, d. in February of 1698^2 and was father of :

- 2. John Balfour, bap. at Abdie on 17 December 1677.

SIR MICHAEL BALFOUR, 5^{TH} **BARONET OF DENMILN,** *bap.* at Abdie on 30 November, 1676, and succeeded his father on his death in 1698. He *m*. Marjory, daughter of George Moncreiff of Readie, (she *d*. at Cupar on 22 August 1762, in her 86th year²), *d*. in 1709 and was father of :

- 1. Sir Michael Balfour, 6th Baronet of Denmiln, (see below).
- 2. George Balfour, bap. at Abdie on 28 December, 1705.
- 3. Alexander Balfour, *bap.* at Abdie on 29 March, 1707.

- 5. Catherine Balfour, *bap.* at Abdie on 15 October, 1704, and *m.* Mr. James Stewart, Minister of Tealing. She *d.* at Dundee on 20 July 1784.¹
- 6. Helen Balfour, m. John Riddell, second son of Walter Riddell of Grange, and had issue.
- 7. Jean Balfour, *bap.* at Abdie in September of 1708, and *m.* on 16 June, 1743, Mr. Hugh Glas, Minister of Kettle,² (he was widow of Elizabeth, daughter of William Arnot of Dalginch, by whom he had issue). She *d.* on 4 March, 1777, and had issue.

SIR MICHAEL BALFOUR, 6TH BARONET OF DENMILN, succeeded his father and was served heir to his grandfather in the lands of Denmiln on 12 May 1730. His estate being burdened with debt, it was exposed for sale in 1749 and it is said that to escape his creditors, he rode off one day in 1750, never to return. He *m.* at Abdie on 5 July 1723, Jane, daughter John Ross, 3^{rd} of Innerneathie, and was father of :

- 1. SIR MICHAEL BALFOUR, 7TH BARONET, *bap.* at Abdie on 5 May 1725, and *d.* unmarried in 1759.
- 2. SIR JOHN BALFOUR, 8TH BARONET, *bap.* at Abdie on 25 June 1728, and *d.* unmarried in 1772.³
- 3. **SIR PATRICK BALFOUR, 9TH BARONET**, was served heir to his brother Sir John Balfour, 8th Baronet of Denmiln, on 20 October 1779, and *dsp* in 1793.
- 4. Grisel Balfour, *bap.* at Abdie on 10 April,1724, and *m.* Patrick Duff, W.S. She *d.* prior to 20 October 1779, when her brother Sir Patrick Balfour was served her heir.
- 5. Susan Balfour, *m*. at Edinburgh on 1 February 1764, to Robert Hamilton of Wishaw,⁴ and *dsp*. Her brother Sir Patrick Balfour was served heir on 20 October 1779.
- 6. Helen Balfour, d. at Edinburgh on 20 February 1814.⁵
