

01 PROTECTING EU SAFEGUARDS

02 MAINTENANCE OF TENEMENT COMMUNAL PROPERTY

Conference recognises that a significant proportion of people in Scotland live in tenement buildings; Conference acknowledges that the maintenance of communal property, or Scheme Property, within tenements is essential to the upkeep of the buildings and the standard of living for tenants: Conference notes with concern that Scheme Property in many tenements in Scotland is in a state of disrepair or degradation; Conference maintains that the Tenement (Scotland) Act 2004 is not consistently fulfilling its stated intention to encourage owners to establish effective arrangements for managing communal repairs and undertaking maintenance of tenements: Conference calls on the Scottish Government to review this situation and consider any legislative changes or new initiatives that could facilitate improved upkeep of tenement Scheme Property, for the wellbeing of tenants and to sustain and enhance Scotland's urban infrastructure and environments.

03 RAISING THE MINIMUM AGE OF MILITARY RECRUITMENT TO 18

Conference notes that the UK is the only European & NATO country to recruit 16-year-olds into the armed forces, in conflict with the internationally recognised UN Rights of the Child.

Conference notes that those who join the armed forces under the age of 18 are more likely to be killed or injured in service, suffer from alcohol abuse and mental health issues than standard entry recruits.

Conference further notes that over threequarters of UK citizens support an increase in the armed forces recruitment age to 18 and that such an increase in the recruitment age is supported by a range of organisations including the Children & Young Person's Commissioner of Scotland, the Educational Institute of Scotland, Children in Scotland and the Church of Scotland.

Conference calls upon the UK Government to work towards raising the minimum armed forces recruitment age from 16 to 18 for all roles that require combat training in line with international standards and affirms that this will form a part of the SNP's Defence Policy for an independent Scotland.

04 END PUBLIC SECTOR PAY RESTRAINT

Conference welcomes the announcement by the Scottish Government to end the Public Sector pay cap and that the Scottish Government will work with trade unions and staff to implement fair and appropriate future pays awards.

Conference also notes that the pay of many public sector workers in Scotland is decided at a UK level and therefore calls upon the UK Government to follow the example of the Scottish Government and end the pay restraint on public sector wages.

05 COHABITING COUPLES WITH DEPENDENT CHILDREN

Conference notes that under section 19 of the Matrimonial Homes (Family Protection) (Scotland) 1981 Act, spouses or civil partners who co-own a property can ask the court to refuse or postpone the division and sale of that property, ensuring they are not forcibly made homeless.

Conference also notes that this protection is not extended to co-owners living as cohabitants, even if they have children together.

Conference believes it is wrong that children can potentially be made homeless simply because their parents did not get married before splitting up.

Conference calls for the Matrimonial Homes (Family Protection) (Scotland) Act to be amended to cover situations where cohabitants have children together, so that the co-owner with main custody of the children can, acting reasonably, ask the courts to refuse or postpone the division and sale of the property.

Conference condemns the rollout of the Conservative Government's Universal Credit benefit which is having a detrimental impact on households; is concerned the in-built six week delay in receiving the first payment is having a harmful impact on people and leading them into rent arrears, increased debt and a reliance on crisis services including the Scottish Government's Scottish Welfare Fund and foodbanks; notes this is a reserved benefit but the damage it causes to households means there is a financial burden shifted to local authorities and services in supporting people impacted; calls on the UK Government to halt the rollout immediately until the system is reformed and is fit for purpose of adequately supporting families and individuals; welcomes the Scottish Government using its very limited powers over flexibilities of Universal Credit to ensure there is a choice over direct payment to landlords and twice monthly payments; recognises that once again Scotland rejected a Conservative Government at Westminster and calls on the

15 PROHIBITION OF NUCLEAR WEAPONS

Conference welcomes and supports the recent UN treaty on the Prohibition of Nuclear Weapons and calls for international cooperation under UN auspices to find agreed means to decommission nuclear weapons and their delivery systems so that vulnerable communities do not become hosts to nuclear dumps and that safe decommissioning practices can be shared.

Conference also urges the UK Government to implement a policy of no first use of nuclear weapons, as a first step towards compliance with international law.

16 AUTOMATIC VOTER REGISTRATION

Conference believes we should be seeking to boost democratic participation in elections, utilising practices used elsewhere in Europe, such as the automatic enrolment on the electoral register and holding elections on weekends.

Conference notes that the Sovereign Grant Act 2011 changed the way the Royal Household is supported financially by the state, scrapping the previous Civil List and Grants-in-Aid system with a method that pays the Royal Household a proportion of Crown Estate profits, including a guarantee that this Sovereign Grant will not fall from the previous year and is rounded up to the nearest £100.000.

Conference further notes that this has resulted in the Royal Household receiving a significantly larger income year on year from the state, from the initial Sovereign Grant of £31 million in 2012-13 to £76.1 million in 2017-18.

Conference believes that profits from the Crown Estate, which is a public asset, should be spent on the wider public good.

Conference therefore resolves to support the repeal of the Sovereign Grant Act 2011.

19 MENTAL HEALTH IN THE WORKPLACE

Conference supports World Mental Health Day on 10th October, which this year promotes good mental health and wellbeing in the workplace. While most people are at least aware of the actions they should take to improve their physical health, many are unaware of 'keep fit' for good mental health. Conference acknowledges that mental health is often neglected as a key aspect of employees' overall health, yet depression now heads the list of causes of illness and disability worldwide.

Conference notes the Mental Health Foundation's research that around half of employees with a mental health problem choose not to disclose it to an employer for fear of discrimination, and affirms that mental health stigma has no place either in the workplace or anywhere else in society.

Conference welcomes the Scottish Government's new mental health strategy and the specific commitment within it to work with employers to protect and improve mental health in the workplace, and support employees experiencing poor mental health. Conference further welcomes the Scottish Government's commitment to helping people with severe and enduring mental health problems find suitable work through its new employment support service, Fair Start.



A life in Limbo - reducing the use of unsuitable temporary accommodation for homeless people

The event will outline the problem of homeless people being left for long periods of time in unsuitable temporary accommodation such as unsupported hostels or B&Bs. While the legislation is changing to ensure families and pregnant women will require to be moved on from unsuitable temporary accommodation, single people can be left there for months and in some cases years as councils are using this type of accommodation as part of their housing stock. Often people are left without access to kitchen or laundry facilities, have to share bathrooms and are subject to time restrictions such as evening curfews. Living in limbo in this way can have an impact on an individual's mental health and can prevent them in moving forward with their lives. This situation needs to end.
