Mayor's Office of Immigrant Affairs Announces Launch of NYCitizenship Services Approximately 650,000 immigrant New Yorkers are one step away from citizenship

New York – April 19, 2016 – Commissioner Nisha Agarwal of the Mayor's Office of Immigrant Affairs today announced the launch of NYCitizenship, a citywide program that provides citizenship legal services and financial counseling at 12 public library branches alongside services available at select New York City Human Resources Administration (HRA) sites. As part of NYCitizenship, New Yorkers will receive free services that include appointments with a trusted attorney for help with citizenship applications, information sessions about the citizenship process and its benefits, and free and confidential financial counseling.

The launch was held at New York Public Library's Mid-Manhattan branch, one of NYCitizenship's participating library branches. The Mayor's Office of Immigrant Affairs was joined at the launch by Brooklyn Public Library, New York Public Library, Queens Borough Public Library, HRA, New York Legal Assistance Group (NYLAG), Council Member Carlos Menchaca, and U.S. Citizenship and Immigration Services, as well as Citi Community Development, Carnegie Corporation of New York, Robin Hood Foundation, and the Mayor's Fund to Advance New York City, whose support makes NYCitizenship possible. NYLAG is the legal and financial service provider for NYCitizenship.

The 12 participating NYCitizenship locations include: Bronx Library Center (Fordham), Central Library (Grand Army Plaza), Central Library (Jamaica), Flushing Library, Inwood Library; Jackson Heights Library; Kings Highway Library; Mid-Manhattan Library; Mott Haven Library; New Utrecht Library (Bensonhurst); Ridgewood Library; and Sheepshead Bay Library.

NYCitizenship will also provide citizenship services to a subset of HRA's clients who stand to benefit significantly if they obtained U.S. citizenship and financial empowerment services. This will allow the program to place a targeted emphasis on reaching the most financially vulnerable New Yorkers who are eligible to naturalize.

"For cities, increasing rates of citizenship is a win-win," said **Commissioner Nisha Agarwal of the Mayor's Office of Immigrant Affairs**. "Today we deepen our commitment to creating pathways for citizenship for all New York City immigrants. Further, the NYCitizenship model empowers New York immigrants and their families to progress socioeconomically and financially. Increasing citizenship strengthens the financial standing of immigrants and directly benefits the health and vitality of all cities. We thank NYCitizenship's partners and supporters who are instrumental in making this progress possible."

"The value of this initiative is that it targets New Yorkers who are facing not only financial hardship but also health barriers that make their path to self-sufficiency even more challenging," said **NYC Department of Social Services Commissioner Steven Banks**. "By assisting immigrants through the process of naturalization, we are giving them an opportunity to improve their lives and enjoy the many benefits and protections of becoming citizens."

"By offering naturalization services, legal assistance and financial education all in one familiar place, NYCitizenship is paving the way to countless new opportunities for our immigrant communities – from better pay to homeownership. There are approximately 650,000 immigrants in New York City who are lawful permanent residents but have not taken the next step to become U.S. citizens. Increasing immigrant access to citizenship through NYCitizenship is a powerful tool for fighting poverty and supporting the economic empowerment and civic integration of foreign-born New Yorkers. A recent study commissioned by the Mayor's Office of Immigrant Affairs and supported by Citi Community Development showed for the first time that cities directly benefit when they work to increase rates of naturalization. The study found that if all eligible NYC residents naturalized, the City would see a net economic benefit of \$823 million.

We at U.S. Citizenship and Immigration Services know that libraries are a second home to immigrants – more than 55 percent of recent immigrants use the public library at least once a week. For years, libraries nationwide have been great allies for USCIS in helping to get important immigration information to those who need it. Last year, we were proud to partner with New York libraries to establish 'New Americans Corners' in every library branch in Manhattan, Brooklyn, and Queens," said **Phyllis Coven, New York District Director for U.S. Citizenship and Immigration Services**.

"Our nation's leaders must understand that the millions of immigrants in this country aren't going anywhere, they are here to stay. I'm proud to be part of a City government that understands this - and is actively investing on immigrant New Yorkers and integrating them by providing free citizenship services and financial counseling, among other types of support." said **Council Member Menchaca**.

As part of NYCitizenship and with the support of Citi Community Development, the Mayor's Office of Immigrant Affairs partnered with the New School Parsons Design for Social Innovation and Sustainability Lab to study and develop an innovative method of helping NYCitizenship applicants connect to financial empowerment services, so that individuals who are ready to obtain citizenship status can also achieve greater financial stability.

NYCitizenship was first announced by Mayor Bill de Blasio during the City's firstever Citizenship Week of Action, and builds on a letter of agreement between the City of New York and U.S. Citizenship and Immigration Services to strengthen citizenship education and awareness efforts in New York City by establishing "New Americans Corners" in all 217 of the City's library branches.
