Our Core Message

- 1. Our strongest message is that a ConCon would be dominated by special interests and lobbyists, and that the delegates would be double-dipping politicians and their family members. This would NOT be a "people's convention."
- 2. The overall cost (\$200 million) is also a concern for many voters, especially Republicans, but cost alone is not disqualifying IF voters' believe that a ConCon would result in major improvements to the constitution.
 - The best-testing slogan marries <u>both</u> of those themes: A \$200 million boondoggle for politicians and lobbyists.
- Paising the specter of potential policy outcomes proves <u>less</u> effective for two related reasons: the voters get to approve/reject any proposed amendments, and are skeptical that the worst potential outcomes (undermining LGBT rights, environmental protections, gun safety) would really happen in solid blue New York.





Methodology

Statewide Survey

- 806 likely Nov 2017 general election voters, conducted February 27 to March 2, 2017
- Margin of error = ±3.5 percentage points among all voters

Four Focus Groups


- Albany January 18: Democratic college graduates, Republican noncollege graduates
- NYC January 19: Republican college graduates, Democratic non-college graduates





Initial support for a constitutional convention starts well under 50%, with a large number of voters undecided.

How will you vote if this is on the ballot in November: "Shall there be a convention to revise the constitution and amend the same?"



Effect of Selected Information on Likelihood of Supporting Constitutional Convention








Most troubling potential delegates: special interest lobbyists and politicians' family members.


Which two of these types of people would concern you most if they were delegates?

Main arguments in favor of ConCon are lower taxes, reducing corruption, and modernizing constitution.

Proportions of SWING VOTERS saying each is a very convincing reason for convention

- 48% New York has some of the highest taxes in the country. A convention could add a **Taxpayer Bill of Rights** to the state constitution, requiring that all future tax increases be approved by voters, and requiring the government to refund any surplus revenue back to taxpayers.
- 46% Government is supposed to be by the people and for the people, but Albany politicians are ineffective, corrupt, and controlled by wealthy special interests. A constitutional convention gives power back to the people by letting them vote directly on changes to the constitution.
- 40% There is too much corruption in Albany, and the legislature isn't doing anything about it. Since the legislature won't police themselves, a constitutional convention is the best way to bring more transparency, tougher campaign finance rules, and stronger ethics and oversight to state gov't.
- 40% New York's constitution is full of meaningless, out-of-date language. One section details how the state will fund bonuses for World War II veterans and bonds issued before 1910. New York has not held a convention since 1967. The world has changed, and it is time to bring the constitution up to date.
- 23% Governor Cuomo, many Democrats and Republicans, government watchdog groups, and constitutional experts all support a convention. The only opposition is coming from public employee unions who want to protect lavish pensions and special protections for their members.





Most effective opposition messages focus on special interest/lobbyist influence and taxpayer cost.

Proportions of SWING VOTERS saying each is a very convincing reason against convention

- The convention will be dominated by special interests and lobbyists, not regular New Yorkers. Delegates' campaigns will be funded by wealthy special interests. And under the law, lobbyists are allowed to pressure delegates to rewrite the constitution to benefit their clients.
- 63% Current state legislators and other politicians are allowed to serve as convention delegates, and delegates will earn the same salary as assembly members. That means legislators and other politicians can double-dip--earning their regular legislative salary PLUS a salary for attending the convention.
- A constitutional convention is estimated to cost taxpayers about \$200 million, but there is no time limit on the convention and delegates make their own rules, so they could keep meeting and collecting a salary indefinitely. And delegates get to hire their own staff and decide how much to pay them. This will be another big Albany boondoggle at taxpayer expense. (Top message for GOP)



Other Messaging Recommendations

- 1. Police, firefighters, and teachers are more effective faces and voices for the campaign than are labor unions.
- In general, Democrats (especially downstate Democrats) support a ConCon more than Republicans, who are more worried about both the cost and likely policy outcomes in a Democratic state.
- 3. Strongest message for downstate Democrats:

You know a convention is a bad idea based on who supports it. The official campaign committee is run by lobbyists and political operatives, and one of the main organizations campaigning in favor of a convention is funded by the Koch brothers' network donors, and was founded by Donald Trump's chief strategist Steve Bannon.

Downstate Dems also worry about influence of NRA and corporate lobbyists.
