3. Agencies/firms having prior experience in drone video shooting and making documentaries/films may submit their proposal.
4. Terms and Conditions:
 - a) The agency should be empanelled with the Information & Public Relation Department, Govt. of Bihar.
 - b) Rates mentioned in the quotation should be as per DAVP.
 - c) The film should be full length high definition (Full HD) format shot with drone camera.
 - d) A 10 minutes film combining the important aspects of both documentaries should be made without any cost by the agency.
 - e) Data as required by the agency will be provided by PMAA to feed in relevant parts of the documentaries.
 - f) The proposed work must be completed and submitted within one month to Chief Executive Officer, PMAA.
 - g) Documentaries will be reviewed by a high level committee which will include technical experts. Payment will be made after reviewal by the committee.
 - h) The Agency will submit the documentaries in softcopy/DVD.
 - i) PMAA shall own the copyrights to the submitted work.
5. Decision of Chief Executive Officer, PMAA will be final in respect of any disputes.
