#### 1.0 Purpose

This report explains to outcome of the informal consultation on the review of secondary provision within the Troon area and in particular the options being considered for Marr College.

#### 2.0 Background

- 2.1 The informal consultation formed part of the outcome of the fundamental review of the school estate which was reported to South Ayrshire Council's Leadership Panel in June 2009.
- 2.2 The issues relating to the Marr College building are well known and in 2001 the school was considered for inclusion in the Council's Public Private Partnership bid. Unfortunately, the project could not proceed as the community could not agree on an option that represented Best Value with regard to the educational interests of staff, pupils and the wider community.
- 2.3 A Member/Officer Group was established in early 2008 to consider the present provision for secondary education in the Troon area and to examine options. The group included the Head Teacher of Marr College, Elected Members, parent representatives of the Parents' Council of Marr College and representatives of the Board of Governors of the Marr Trust. Officer representation was drawn from Children and Community, Estates, Planning and Legal Services in order to provide the group with technical advice as required.
- 2.3 Following an assessment by Turner Townsend, project management consultants who have extensive experience in school projects, their report "Fit for Purpose" highlighted significant suitability issues with the existing school buildings. This report was made available to the community as part of the informal consultation exercise.
- 2.4 To take the issues forward the Council agreed to enter into an extensive engagement with the Troon community and surrounding communities to explore the options available for a refurbishment and upgrade of the existing buildings at Marr College or a new build.

#### 3.0 Considerations

- 3.1 The aim of the informal consultation was to explore the potential for developing an alternative option to the refurbishment and upgrade of the existing Marr College buildings. During the meetings with the communities, Officers explained that the upgrade of the existing school remained as one option for the Council. However, due to the likely costs and the restrictions with the buildings, it was necessary to explore alternative options. The option being presented for discussion was the building of a new school on the Marr playing fields.
- 3.2 The feedback gathered from the submissions made, the staff and pupil surveys and the public meetings, is set out in section 4.0.
- 3.3 It is clearly evident that there is a strong view from those who participated in the informal consultation that the original Marr College building should be retained and upgraded as part of a wider modernisation project on the existing site.

- 3.4 A significant volume of feedback reflected the personal feelings of individuals for the Marr College building and their own very positive educational experience at the school.
- 3.5 Some respondents recognised that there were valid suitability issues with the Marr College buildings and that these issues were greater than simply dealing with the outstanding maintenance. However, there was strong criticism regarding the condition of Marr College with claims that the Council (and previous authorities) had not maintained the building properly.
- 3.6 The feedback recognised that South Ayrshire Council had addressed some of the outstanding maintenance issues, particularly the replacement of windows in the main buildings and re-roofing of areas of the school. The respondents also acknowledged that the Council had modernised a number of curricular areas such as Home Economics and Science rooms. Some respondents took the view that it was possible to modernise some rooms and others suggested that it was possible to upgrade the whole building.
- 3.7 Many external and internal parts of the original building are listed by Historic Scotland and this can limit the extent of modernisation work that can be undertaken. The Children and Community Directorate have been in contact with Historic Scotland regarding the Marr College building and they have indicated their willingness to work with the Council to develop an improvement strategy for Marr College.

#### 4.0 Consultation

The informal exercise relating to secondary provision in and around Troon has been extensive during the consultation period. Seven public meetings were held in the cluster schools and also in the Walker Hall in Troon and Marr College. In addition, officers met with the Governors of the Marr Trust and members of the Parent Council of Marr College.

Overall, some 488 people took the opportunity to attend the meetings with a number of people attending all of the meetings, such was their strength of feeling on the matter. The consultation meetings were led by officers from the Children and Community Directorate who explained the background to the review of secondary provision in Troon and the purpose of the consultation process. It was also explained that the outcome of the informal consultation would help form options that would be taken forward in the next stage of more formal consultation with the school and wider community.

All local Elected Members also attended the majority of the consultation meetings.

In addition to the public meetings, the Council provided a variety of ways in which individuals or groups could respond to the consultation, including email or written submissions. The consultation was supported by a dedicated web page which contained key information about the consultation and which was regularly updated with comments as the consultation progressed. Over 2100 people visited the website during the consultation period.

A structured electronic survey was also carried out with the pupils and staff of Marr College to gather specific feedback from the people who work or are educated in the present buildings. Over 800 pupils and the vast majority of staff responded to the surveys.

#### 4.1 Responses received from informal consultation process

4.1.1 284 responses were received through the informal consultation process and a summary of these is shown in Appendix 1. A copy of all responses received have been made available to the Elected Members for information and consideration.

The following table categorises the individual responses received by employees, parents, pupils and community.

255 (90%) of the responses received indicated a preference for the old Marr College building being retained and refurbished and 22 responses were open to the idea of building a new secondary school on the Marr playing fields.

- 4.1.2 Many of the responses received from the consultation process contained views that were consistent with other responses and therefore only a summary of the main points from the submissions is detailed below with comments from the Children and Community Directorate shown in italics after each point.
  - (a) **Point raised:** The issues at Marr College are due to the negligence of South Ayrshire Council.

**Response:** This point was made by many respondents and reflects a lack of appreciation for the significant issues facing the Council in relation to the maintenance of its school estate. As far as budgets have allowed, the Council has continued to maintain the Marr College buildings to ensure that they are safe for the users of the buildings with recent investments in window replacement, roof repairs and the upgrade of science and home economic rooms.

(b) **Point raised:** There are many examples where historic buildings have been retained and modernised.

**Response:** If the refurbishment and modernisation of the existing Marr College buildings is adopted as the preferred option by the Council, the various Council services will develop an investment strategy which enables the key features of the old building to be retained while at the same time delivering a learning centre that is suitable for the 21<sup>st</sup> Century. This will be developed in liaison with interested parties including Historic Scotland.

(c) **Point raised:** A new school would address the issues that exist at Marr College.

**Response:** The design process for a new school allows architects to ensure that the building is completely compliant with current building regulations and that it can meet the demands of the modern curriculum, A Curriculum for Excellence. There are examples where older buildings have been brought up to a modern standard but the projects are normally more challenging.

(d) **Point raised:** The original Marr College is overcrowded and cramped.

**Response:** The original building was not designed for the number of pupils now being educated and this is reflected by the pressures on the accommodation within the building. When the authority took over the building in 1975, the demands of an increasing pupil population were met by extending the school and through the provision of temporary hutted accommodation. The decision to use hutted accommodation was flawed and this has significantly contributed to issues that exist at the school. All of the hutted accommodation that was provided in 1975 has since been removed.

With careful planning and significant investment, it is possible to address many of the issues that presently exist. If some suitability issues are insurmountable, the decision will be whether or not they are serious enough to impede the education of children.

(e) **Point raised:** People have not considered the disruption to pupils if a refurbishment went ahead.

**Response:** The Council's experience and that of other authorities is that refurbishments are much more challenging than new builds, resulting in a greater disruption to pupils and staff. The impact can be minimised by careful planning, the phasing of works and the use of temporary classroom units. The cost of using temporary units can be very high and it is a cost that cannot be recovered.

(f) **Point raised:** The Marr Playing Fields should be retained as they are well used and have some of the best pitches for Rugby and Hockey.

**Response:** Some respondents have commented that, other than a Saturday morning, the playing fields are not extensively used. A full assessment of the playing fields would need to be undertaken to determine whether or not the playing fields could be improved by reconfiguring the pitches and building a new school which incorporates all weather sports facilities.

(g) **Point raised:** The sports facilities at the Marr playing fields should be expanded to include all weather facilities.

**Response:** The provision of all weather facilities can be considered whether or not a new school is built on the site. All weather facilities are part of the current design brief for a new secondary school.

(h) **Point raised:** The reports on Marr College are self serving and deliberately present a negative picture.

**Response:** The reports were written by Turner Townsend, independent consultants who are experienced in delivering modern schools through refurbishment or new builds. The "Fit for Purpose" report clearly states that the refurbishment of the existing building should remain one of the preferred options which was also stated by officers at the public meetings. The report highlights the significant condition and suitability issues that exist with the present arrangements and it is important that these are not brushed aside by individuals.

(i) **Point raised:** There are other sites available in Troon that could be considered for a new school

**Response:** All possible sites were considered as part of the options appraisal process undertaken by the member/officer group and the consultants, Turner and Townsend Management Solutions. The outcome of the options appraisal exercise was made available to the public through the Council's web site and demonstrates that very few viable options exist.

(j) **Point raised:** The loss of part of the Marr Playing Fields would impact on Rugby and Hockey for which Marr College is renowned.

**Response:** The Council is confident that a reconfiguration of the existing sports pitches at the playing fields is possible in such a way that it would minimise the impact on existing sports. A new school on the site would deliver significant improvements to the area through the provision of state of the art sports facilities both internal to the school and externally. These facilities would be in close proximity to each other, ensuring a greater efficiency of use. The new facilities, including all weather facilities, will encourage greater usage and offer pupils and the community an opportunity to gain a wider experience of sports.

(k) **Point raised:** The new secondary schools built under the Public Private Partnership (PPP) project are not as good as Marr College and will not last.

**Response:** There is no evidence to support the view from a small number of individuals that the new secondary schools are not of the same quality as the old Marr College building. The design brief for the new schools was developed following wide consultation with staff, pupils, Elected Members, parents, communities and technical advisers. The design brief was based around strict sustainability criteria and supported by a comprehensive maintenance programme which forms part of the PPP contract.

(I) **Point raised:** There was a lack of management information relating the costs of both options and how the existing Marr College building could be adapted.

**Response:** The purpose of the consultation was to initiate a debate on educational rather than the financial issues and to explore the potential for developing an alternative option to the refurbishment and upgrade of the existing Marr College building. Officers from Children and Community explained that if both options were to be taken forward for consideration, more detailed information and costs would be provided as part of a later formal consultation exercise.

(m) **Point raised:** Marr College is a landmark in Troon.

**Response:** The Council acknowledges that Marr College is a significant landmark in Troon.

(n) **Point raised:** Marr College should not be demolished.

**Response:** Marr College is a listed building and it has never been suggested that the building would be demolished, whether retained as a school or not.

(o) **Point raised:** What will happen to the old building if a new school was built?

**Response:** South Ayrshire Council do not own Marr College. The building would be handed back to the Marr Trust and the future of the building would be a matter for the Trust to decide.

(p) **Point raised:** A new school would impact on surrounding properties.

**Response:** The proposal to build a new school would require a planning application which would be subject to detailed planning scrutiny. The impact of a planning application on the local area is a key component of the planning process.

(q) **Point raised:** The people of Troon should make the decision on the future of Marr College.

Response: South Ayrshire Council is fully committed to involving communities in the decision making process. The consultation relating to Marr College has been extensive and communities have been given every opportunity to become involved at a very early stage. The delineated area for Marr College covers more than only Troon and it is important that everyone with an interest in the debate is given the opportunity to put their view forward. The consultation process has been totally open and has ensured that the opportunity to engage has been transparent and inclusive.

(r) **Point raised:** There are no real building issues with the original Marr College building. All the problems relate to the "new" extension.

**Response:** There are significant suitability and condition issues with all the buildings on the Marr College site. All the assessments of the buildings indicate that there are significant accommodation issues that need to be addressed in all the buildings. One of the major issues is the barriers that the campus creates for Inclusion.

(s) **Point raised:** There is no financial argument to replace Marr College.

**Response:** Financial information prepared as part of the Public Private Partnership bid indicates that the cost of upgrading and refurbishing the existing Marr College are similar to those relating to a new build.

(t) **Point raised:** The name Marr College would be lost if a new school was built.

**Response:** The name Marr College is embedded in an Act of Parliament that relates to the school. If a decision were taken to build a new school, the Council could seek an amendment to the Act which would allow the name to be released.

(u) **Point raised:** The ethos of the school would be lost if a new school was built.

**Response:** There are many examples across Scotland where ethos, self esteem, behaviour and culture have improved when staff and pupils move into a new school building.

(v) **Point raised**: The Council should not invest the sums required in a building it does not own.

**Response:** It is not unusual for Councils to upgrade buildings that are leased to them. There are many factors that require to be taken into consideration before the Council would make such a decision. The most important questions relate to whether the option represents Best Value, the nature of the lease and whether the building could be brought up to a standard fit for the 21<sup>st</sup> Century.

### 4.2 Staff and Pupil Survey

The outcome of the staff and pupil surveys are attached as Appendices 2 and 3.

## 4.2.1 Staff Survey

Of the 121 staff at Marr College, 80 participated in the survey which represents 66% of staff

It is clear from the survey that the present staff have a close association with the Marr College building and that the vast majority would like to see it upgraded rather than build a new school.

However the survey highlights staff recognition of the issues with the existing arrangements. Some of these are covered below:

- Many staff recognised that there were security issues with the existing arrangements, but indicated that staff and pupils still felt safe when at school.
- Although not the majority view, a significant number of staff (46.4%) felt that
  the time taken to get to and from the playing fields impacted on other subjects
  in the school.
- There were mixed responses in relation to the condition and suitability of classrooms. A significant number of staff were of the view that the condition of the classrooms was not good and that practical subject rooms were not suitable.

There were also a number of areas of the staff survey which raise concerns about staff awareness on a number of important issues. Some of these are explained below.

• There are significant barriers that exist in relation to Inclusion with the Marr College building. Disabled access is extremely poor and people with mobility problems cannot access the school through the main entrance and therefore have to enter the building through the back of the school. Movement around the school is also difficult for disabled people, particularly when moving between floors. There is only one lift in the school and people who need to use it are required, at times, to travel a long distance between classes. Disabled toilet provision is inadequate.

The staff survey indicates that between 50% and 70% of present staff felt that there were no major accessibility issues. This suggests a lack of understanding of the problems that disabled users experience at the school. The majority of staff also felt that the school could be better designed for disabled users and that there were problems for disabled people accessing the playing fields.

 35.2% of staff indicated a wish to retain the separate male and female staffrooms. Although this represents a minority it is concerning that some staff are not aware of the equalities agenda particularly in relation to breaking down gender barriers.

#### 4.2.2 **Pupil Survey**

806 pupils took the opportunity to participate in the survey which represents 71.49% of pupils.

The pupil survey clearly indicates that most pupils have a personal association with the Marr College building and the vast majority of pupils wish to retain the existing building as oppose to a new build.

The survey does highlight that there are issues with the existing arrangements some of which are detailed below.

- 46.6% of pupils felt that there were insufficient social areas for pupils.
- 50.1% were of the view that the dining hall was suitable for eating.
- It was encouraging that between 50% and 83% of pupils recognised the accessibility issues that existed for disabled people.
- 55.6% of pupils indicated a lack of pupil toilets
- Although 76% of pupils wanted the Marr College building to be retained as a school a significant number of pupils (44.8%) also indicated a willingness to consider a new school as an alternative to refurbishing the existing school. However, 73% of pupils did not want a new school built on the playing fields.
- 46.8% of pupils recognised that there were security issues with the existing buildings.

### 4.3 Points raised at the public meetings

Many of the points raised at the public meetings were also made in the individual responses received, which are covered in section 4.1 above. A list of the points raised at the public meeting is shown in Appendix 4.

#### 5.0 Resources

There are no resource implications associated with this report.

#### 6.0 Summary

- 6.1 The Council has been committed to genuine engagement with the community on what was considered a very contentious subject. The consultation timescales were extended to allow full and open discussion and a range of opportunities were on offer to the community to become involved.
  - Public meetings
  - Email and web access
  - Staff and pupil surveys
  - School tours
- Marr College is a landmark feature in Troon and the community, particularly the Troon community, has a close association with the building and its history.
- 6.3 The outcome of informal consultation indicated that many people had a view that the issues relating to Marr College simply related to a lack of maintenance over a long period of time and blamed the Council and its predecessors for this situation.

However, there was a lack of appreciation of the suitability issues that exist, particularly in relation to inclusion and equality for all pupils and the fact that facilities are spread across the site and the playing fields.

- 6.4 Although some of the buildings issues have arisen from a lack of maintenance there are others that have arisen because of the age of the building and services coming to the end of their life e.g. heating and electrical services are life expired and need to be replaced.
- 6.5 The response from the community was overwhelmingly in favour of retaining the existing school building and refurbishing it. Many people were disappointed that detailed costing had not been provided as part of the consultation which they felt would have helped the debate. A small number of people were supportive of the idea of building a new school on the playing fields and held a counter view that the playing fields were not well used.

A number of people also felt that upgrading the existing school would cause major disruption to the school.

6.6 The outcome of the staff and pupil surveys was clear. The existing Marr College building should be retained and refurbished. There was good evidence from both surveys that there are significant suitability issues needing to be addressed e.g. accessibility, learning and teaching accommodation, dining facilities and social areas for pupils and security across the school.

#### 7.0 Recommendations

- 7.1 Following the outcome of the informal consultation exercise the following 3 options will be developed in detail and taken forward for formal consultation with the community.
  - Option 1: Refurbishment of the existing school buildings,
  - **Option 2:** Retention, upgrade and extension of the original Marr College building to create a modern campus, and
  - **Option 3:** The provision of a new secondary school built on the Marr playing fields.
- 7.2 (a) It is recommended that the Executive Director of Children and Community be requested to bring forward a formal consultation document which includes the 3 options detailed above, and
  - (b) that option 2, which reflects the overwhelming view of the community, be adopted as the preferred option of the Council.
