The Burnley (Parishes) Order 2004

Made - - - - 27 January 2004

Coming into force in accordance with article 1(2)

The Secretary of State, in exercise of the powers conferred upon him by sections 14 and 23 of the Local Government and Rating Act 1997(a), and of all other powers enabling him in that behalf, hereby makes the following Order, which gives effect (without modification) to recommendations made to him by the Burnley Borough Council, following a review conducted by them in accordance with Part II of that Act, for the alteration of the area of parishes within the borough of Burnley:

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Burnley (Parishes) Order 2004.
- (2) It shall come into force
 - (a) for the purposes of this article, and proceedings preliminary or relating to elections to be held on the ordinary day of elections in 2004, on the day after that on which it is made; and
 - (b) for all other purposes, on 1st April 2004.
- (3) In this Order, "the map" means the map prepared by the Office of the Deputy Prime Minister, marked "Map of the Burnley (Parishes) Order 2004" and deposited in accordance with regulation 6(1) of the Local Government (Parishes and Parish Councils) Regulations 1999(b).

Alterations of parish areas

- 2. Each area shaded in colour and designated by a letter on the map, and specified by reference to that letter in column (1) of the Schedule, shall—
 - (a) cease to be part of the parish or unparished area specified in relation to that area in column (2) of the Schedule in relation to it; and
 - (b) become part of the parish or unparished area specified in column (3) of the Schedule in relation to it.

Order Date

3. 1st April 2004 is the Order date for the purposes of the Local Government (Parishes and Parish Councils) Regulations 1999.


This Order gives effect (without modification) to a recommendation resulting from a review conducted by the Burnley Borough Council for boundary changes to parishes within the borough of Burnley. A map forming part of this note gives a general guide to the area concerned.

Article 2 makes alterations to the areas of parishes. On 1st April 2004 each area specified in column (1) of the Schedule to the Order will become part of the parish or unparished area specified in column (3) in relation to it and will cease to be part of the parish or unparished area

specified in column (2) in relation to it. Prior to 1st April 2004, the new arrangements are applied in so far as necessary for the purposes of elections to be held on the ordinary day of elections in 2004.

Article 3 specifies 1st April 2004 as the order date for the purposes of the Local Government (Parishes and Parish Councils) Regulations 1999, which make general provision in relation to orders such as this Order.
