LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The Knowsley Metropolitan Borough Council (Reorganisation of Community Governance) Order 2013

Made on 23rd December 2013 Coming into force in accordance with article 1(2)

Knowsley Metropolitan Borough Council ("the Council"), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated 11 December 2013:

The Council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The Council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The Council makes the following Order in exercise of the powers conferred by sections 86 and 240(10) of the 2007 Act.

Citation and commencement

- 1. (1) This Order may be cited as the Knowsley Metropolitan Borough Council (Reorganisation of Community Governance) Order 2013.
 - (2) It shall come into force on 1st April 2014.

Interpretation

2. In this Order-

"borough" means the borough of Knowsley;

"map" means the map marked "Map referred to in the Knowsley Metropolitan Borough Council (Reorganisation of Community Governance) Order 2013" and deposited in accordance with section 96(4) of the 2007 Act; and

"registration officer" means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983.

Effect of Order

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

Dissolution of parish council for the parish of Tarbock

4. The parish council for the parish of Tarbock shall be dissolved.

Electoral register

5. The registration officer for the borough shall make such arrangement of, or adaptation of, the register of local government electors as may be necessary for the purpose of, and in consequence of, this Order.

Order date

6. 1st April 2014 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

EXPLANATORY NOTE (This note is not part of the Order)

This Order gives effect to recommendations made by Knowsley Metropolitan Borough Council for the abolition of the parish council for Tarbock.

The parish council for Tarbock will be abolished with effect from 1 April 2014.
