Motion by Mr. Johnson, seconded by Mr. Sterling, that Karnes County shall place in escrow \$35,000.00 for the construction of 52 miles of Highway No. 16, from the Wilson County line south, out of the \$40,000.00 bond issue recently voted by said County, with the proviso that \$5,000.00 of said bond issue shall be retained by the County out of which to purchase right-of-way for said $5\frac{1}{2}$ miles, with the understanding that any balance remaining of said \$5,000.00 after said right-of-way is purchased, shall be placed in escrow to the credit of the State Highway Department. Motion carried.

Motion by Mr. Johnson, seconded by Mr. Sterling, that \$7,500.00 be appropriated from the State Highway Fund to surface with gravel about five miles of Highway No. 68, in Ellis County, between Midlothian and the Dallas County line: and the State Highway Engineer is authorized to proceed with the work through the maintenance department. Motion carried.

Motion by Mr. Johnson, seconded by Mr. Sterling, that the State Highway Engineer be authorized to advertise for four portable rock crushing and screening gravel plants for the maintenance department and an appropriation of approximately \$7,500.00 each is made from the State Highway Fund for the purpose of purchasing said plants. Motion carried.

190. Motion by Mr. Johnson, seconded by Judge Ely, that the Minutes of the Highway Commission dated May 24, 1927, alloting aid to Gregg County for the construction of a bridge on Highway No. 31, near the town of Gladewater, be modified to read as follows:

"That 100% State Aid be allotted Gregg County for the construction of State Highway No. 31, from Smith County line to a point east of the Sabine River where the new location intersects the present road, about 2.3 miles from Smith County line, including the construction of the bridge across said River, the cost of said work to be approximately \$107,000.00. Motion carried.

Motion by Mr. Johnson, seconded by Mr. Sterling, that \$175,000.00 √ 191. be allotted from the State Highway Fund to authorization No. I, Budget No. 21 to take care of maintenance expenditures made prior to September 1 1927. Motion carried.

Motion by Mr. Johnson, seconded by Mr. Sterling, that \$2, 135.00 192. be allotted from the State Highway Fund as a special maintenance appropri ation to cover the cost of repairing a washed out bridge on Highway No. 1 in Rockwall County. Motion carried.

Motion by Mr. Johnson, seconded by Mr. Sterling, that an additional allotment of \$6,832.86 be made to Job M-4-B, in Potter County, to cover the cost of asphalt resurfacing work on Highway No. 33. Motion carried.

Motion by Mr. Johnson, seconded by Mr. Sterling, that \$11,000.00 be appropriated from the State Highway Fund for the improvement of Highway No. 26-A between Carthage and Beckville in Panola County upon the new location to be approved by the State Highway Engineer, provided Panola County will furnish an 80' right-of-way on which to construct said highway. Motion carried.
