

## ARIZONA VOLUNTARY TRAVEL ID IDENTIFICATION REQUIREMENTS

Arizona Revised Statutes section 28-3153(D) provides that the Motor Vehicle Division (MVD) must not issue to or renew a driver license or non-operating identification license for a person who does not submit proof satisfactory to MVD that the applicant's presence in the United States is authorized under federal law. MVD is required to determine that each applicant meets the requirements of the law. Identification requirements may change without notice.

## Additionally:

- All must be originals or certified copies, in English, certified by the issuing agency
- If your current legal name is different from your primary document, you must show legal proof of name change, such as a marriage certificate, divorce decree, or court order. You must first change your name with the Social Security Administration.
- Social Security number You are required by A.R.S. §§ 28-3158(D)(5) and 28-3165(F), under the authority of 42 U.S.C. §§ 405(c)(2)(C) and 666 (a)(13)(A), to provide your Social Security number. It will be used to verify your identity and to comply with federal and state child support enforcement laws. It will not be used as your driver license or identification card number.
