Minutes of a Special Meeting of the Highway Commission held in the State Highway Building with the following members present:

- 7932 In Anderson County, on bids received July 25, 1933, contract for Double Bituminous Surface Treatment from Courthouse in Palestine to the Neches River, a distance of 14.80 miles, on State Highway No. 22, Job No. M-10-0-7 is awarded to C. A. & J. W. Vilbig, Jr., Dallas, Texas, for \$28,723.20, which is the lowest and best bid.
- 7933 In Bee County, on bids received July 25th, 1933 contract for Special Rock Asphalt Wearing Surface from 1/4 mile south of Paesta Creek in Beeville to junction with Highway #12 in Skidmore, a distance of 10.88 miles, on State Highway No. 16 Job No. M-16-J-3 is awarded to Nueces Construction Co., Corpus Christi, Texas, for \$36,135.21, which is the lowest and best bid.
- 7934 In Fayette County, on bids received July 25, 1933 contract for Double Bituminous Surface Treatment from LaGrange to 4.6 miles east of LaGrange a distance of 4.613 miles, on State Highway No. 71 Job No. M-13-R-4 is awarded to R. W. McKinney, Nacogdoches, Texas, for \$8,663.56, which is the lowest and best bid.
- 7935 In Jasper County, on bids received July 25th, 1933 contract for Double Bituminous Surface Treatment from junction of Highway #45 west of Jasper to the junction of Highway #45 east of Jasper, a distance of 4.60 miles, on State Highway No. 63 Job No. M-11-A-4 is awarded to Brown & Root, Austin, Texas for \$10,984.08, which is the lowest and best bid.
- 7936 In Karnes County on bids received July 25th, 1933, contract for Special Limestone Rock Asphalt Wearing Surface from Ecletto Creek to the Wilson County line, a distance of 15.502 miles, on State Highway No. 112 Job No. M-16-0-3 is awarded to Nueces Const. Co., Corpus Christi, Texas, for \$40,598.46, which is the lowest and best bid.
- 7937 In Morris County on bids received July 25th, 1933 contract for Double Bituminous Surface Treatment from Omaha to Sulphur River, a distance of 8.70 miles, on State Highway No. 11 Job No. M-19-U is awarded to Haden & Austin, Houston, Texas, for \$19,249.38, which is the lowest and best bid.
- 7938 In Rusk County on bids received July 25, 1933, contract for Special Triple Bituminous Surface Treatment from the Smith County line via Overton to Pitner's Junction a distance of 8.20 miles, on State Highway No. 135 Job No. M-10-M-7 is awarded to R. W. McKinney, Nacogdoches, Texas for \$25,719.43, which is the lowest and best bid.
- 7939 In Scurry and Mitchell Counties on bids received July 25, 1933, contract for Special Bituminous Seal Coat from Nolan-Mitchell County line to 8.89 miles north of the Scurry-Mitchell County line, a distance of 9.32 miles, on State Highway No. 7 Job No. M-8-Y-4 is awarded to R. W. McKinney, Nacogdoches, Texas, for \$2,779.34, which is the lowest and best bid.
- 7940 It is ordered by the Commission that \$31,595.52 be appropriated to cover the cost of a Double Bituminous Surface Treatment on 14.80 miles of Highway No. 22, in Anderson County extending from the Courthouse in Palestine to the Neches River; this work to be done under the direction of the State Highway Engineer through the Maintenance Department as Special Job No. M-10-0-7.

- 7941 Minute #7849 which provided for the construction of an additional 9 ft. concrete pavement on Highway #47 from Linden west, be submitted to the Bureau of Public Roads as Project #1, in Cass County is hereby changed to read:
"The construction of an additional 11 ft. concrete pavement on Highway #47 from Atlanta, west."
- 7942 Due to the fact that State Highway #36 is being constructed over State Highway No. 93 north of Gatesville near the Reformatory School, it is ordered by the Commission that the designation of State Highway No. 93 be hereby cancelled.
- 7943 It is ordered by the Commission that an additional appropriation of \$12,224.51 be hereby made to cover the increased cost of a Double Bituminous Surface Treatment on the 17.537 mile section of Highway No. 5 in Dallam County, caused by the withdrawal by the low bidder of his bid and the necessity of awarding this contract to the next low bidder. This is an increase to Job No. M-4-Q-2 authorized under the direction of the State Highway Engineer through the Maintenance Division. A.F.E.-33-147
- 7944 It is ordered by the Commission that \$9,529.92 be appropriated to cover the cost of a Double Bituminous Surface Treatment on 4.613 miles of Highway No. 71 in Fayette County, extending from LaGrange to 4.6 miles east of LaGrange; this work to be done under the direction of the State Highway Engineer through the Maintenance Department as Special Job No. M-13-B-4. A.F.E.-33-148
- 7945 In Mays County an appropriation of \$8,228.00 is hereby made to be expended under the direction of the State Highway Engineer through the Maintenance Division for the construction of a temporary low water structure for the use of heavy vehicles over the Blanco River adjacent to the present Bridge over the Blanco River on Highway No. 2, this work to be known as Special Job No. M-14-H-6. The State Highway Engineer is directed to purchase and fence such Right-of-way as may be needed out of the money appropriated for this work. A.F.E.-33-149
- 7946 It is ordered by the Commission that an appropriation of \$6,861.03 be hereby made to cover the cost of grading and small drainage structures on a section of road connecting the site of the McDonald Observatory on Locke Mountain with the Davis Mountain State Park Highway at a point approximately 14 miles from Fort Davis in Jeff Davis County; this work to be done under the direction of the State Highway Engineer through the Maintenance Division, and on condition that adequate right-of-way be furnished by the County. Special Job No. M-24-I. A.F.E.-33-150
- 7947 It is ordered by the Commission that \$44,658.31 be appropriated to cover the cost of a Limestone Rock Asphalt Wearing Surface on 15.502 miles of Highway No. 112 in Karnes County, extending from Eoleto Creek to the Wilson County line; this work to be done under the direction of the State Highway Engineer through the Maintenance Department as Special Job No. M-16-O-3. A.F.E.-33-151
- 7948 It is ordered by the Commission that the State Highway Engineer through the Maintenance Division be authorized to pay \$50.00 to the Angelina Abstract Company for preparing abstract of title to the 2.97 acre tract of land which was donated to the Department for the new Warehouse and Office Building site in Lufkin. A.F.E.-33-152
- 7949 It is ordered by the Commission that \$21,174.32 be appropriated to cover the cost of a Double Bituminous Surface Treatment on 8.70 miles of Highway No. 11, in Morris County, extending from Omaha to Sulphur River; this work to be done under the direction of the State Highway Engineer through the Maintenance Department as Special Job No. M-19-U. A.F.E.-33-153

- 7950 It is ordered by the Commission that an appropriation of \$2,404.21 State Funds be made to cover the cost of regular roadway maintenance on 6.115 miles of Highway No. 128 in Nueces County, extending from Robstown to Calallen, and the State Highway Engineer is hereby authorized to take this section of road over for maintenance. This appropriation is divided as follows:
- \$343.46 - Cost of Maintenance for the balance of the fiscal year ending August 31, 1933, and
- \$2,060.75 - Covering the cost of maintenance for the next fiscal year beginning Sept. 1st, 1933. A.F.E.-33-154
- 7951 It is ordered by the Commission that an appropriation of \$34,323.51 be made to cover the cost of widening shoulders and asphalt surface treatment on the 10.0 mile section of Highway No. 106 in Polk County extending from the Tyler County line west to Corrigan; this work to be done under the direction of the State Highway Engineer through the Maintenance Division as Special Job M-11-F-5. A.F.E.-33-155
- 7952 An appropriation of State Funds in the amount of \$28,291.37 is hereby made to cover the cost of a Triple Bituminous Surface Treatment on 8.200 miles of Highway No. 135 in Rusk County, from Smith County line via Overton to Pitner's Junction; this work to be done under the direction of the State Highway Engineer through the Maintenance Division as Special Job No. M-10-M-7. A.F.E.-33-156
- 7953 In San Patricio County Minute 7876, dated July 12, 1933 is amended as follows:
- It is ordered by the Commission that application for designation of a road, to be extension of State Highway #119 from Refugio to Portland or Gregory, be referred to the State Highway Engineer for investigation and report.
- 7954 To amend Minute #7835 which provides that the construction of an under-pass on Highway #15 at Gilmer be submitted to the Bureau of Public Roads as Project No. 2, in Upshur County:
- Minute #7835 is hereby changed to read: "The construction of an underpass on Highway #15 at Big Sandy."
