LOCAL GOVERNMENT, ENGLAND AND WALES CHANGES IN LOCAL GOVERNMENT AREAS The Pendle (Parishes) Order 1986

Whereas the Pendle Borough Council, acting pursuant to section 48(8) of the Local Government Act 1972 (a), has made recommendations to the Local Government Boundary Commission for England for proposals about parishes in the borough:

And whereas in consequence of those recommendations the Commission has seen fit, pursuant to sections 47, 48(9) and 51(1) of that Act, to make proposals to the Secretary of State:

And whereas more than six weeks has elapsed since those proposals were made:

And whereas the Secretary of State has decided to give effect to the proposals:

Now, therefore, the Secretary of State, in exercise of his powers under sections 51(2) and 67(4) and (5) of that Act and of all other powers enabling him in that behalf, hereby makes the following order:-

Title and commencement

1. This order may be cited as the Pendle (Parishes) Order 1986.

- 2. (1) 1st January 1987 is hereby specified as the day on which this order shall come into operation for any purpose set out in regulation 4(1) (coming into operation of order) of the Local Government Area Changes Regulations 1976 (a).
- (2) For all other purposes, this order shall come into operation on lst April 1987.

Interpretation

3. In this order -

"borough ward" means a ward of the borough of Pendle;

"the boundary maps" means the 12 maps (duly numbered for reference) which are issued by the Department of the Environment as the "Maps of the Pendle (Parishes) Order 1986"; and

"county electoral division" means an electoral division of the county of Lancashire.

Creation of new parishes

- 4. (1) There shall be created in the borough of Pendle, without change to any district ward or county electoral division, 4 new parishes, to be called Barnoldswick, Barrowford, Bracewell and Brogden, and Trawden Forest.
- (2) The new parish of Barnoldswick shall consist of that part of the unparished area of the borough of Pendle which is marked E4 on boundary maps 8 and 9.
- (3) The new parish of Barrowford shall consist of that part of the unparished area of the borough of Pendle which is marked El on boundary map 9.

- (4) The new parish of Bracewell and Brogden shall consist of -
 - (a) the area of the parish of Bracewell, which is marked D4 on boundary map 8;
 - (b) that part of the area of the parish of Brogden which is marked D2 on boundary maps 8 and 9; and
 - (c) that part of the unparished area of the borough of Pendle which is marked E2 on boundary maps 8 and 9.
- (5) The new parish of Trawden Forest shall consist of that part of the unparished area of the borough of Pendle which is marked E5 on boundary maps 1 to 7.

Parish councils for the new parishes

- 5. (1) There shall be a parish council for each of the new parishes of Barnoldswick, Barrowford and Trawden Forest.
- (2) From 1st April 1987 until the fourth day after the ordinary day of election of councillors in 1987 the parish council of the new parish of Barnoldswick shall consist of the borough councillors representing the Coates and Craven borough wards immediately before 1st April 1987. Thereafter the new parish shall be divided into 2 parish wards as shown on boundary maps 8 and 9, to be known as the Coates and Craven parish wards, each parish ward to be represented by 6 parish councillors.
- (3) From 1st April 1987 until the fourth day after the ordinary day of election of councillors in 1987 the parish council of the new parish of Barrowford shall consist of the borough councillors representing the Barrowford borough ward immediately before 1st April 1987. Thereafter the new parish shall be divided into 4 parish wards as shown on boundary map 9, to be known as the Carr Hall, Central, Higherford and Newbridge parish wards, each parish ward to be represented by 3 parish councillors.

- (4) From 1st April 1987 until the fourth day after the ordinary day of election of councillors in 1987 the parish council of the new parish of Trawden Forest shall consist of the borough councillors representing the Boulsworth borough ward immediately before 1st April 1987. Thereafter the new parish shall be divided into 2 parish wards as shown on boundary map 1, the Trawden ward to be represented by 6 parish councillors and the Winewall and Cottontree ward to be represented by 4 parish councillors.
 - (5) The proper officer of the Pendle Borough Council shall convene -

the first annual meeting of each parish council created by article 5; and

the first assembly of the parish meeting for each new parish.

If in any new parish the first assembly of the parish meeting is held before the first annual meeting of the parish council created by article 5, the parish meeting may appoint a person to take the chair, who shall have, for the purpose of that meeting only, the powers and authority of the chairman.

Transfers between parishes

- 6. (1) The area of the parish of Brogden which is marked A2 on boundary map 9 shall be transferred to the parish of Blacko and to the Pendleside borough ward and the Pendle West county electoral division.
- (2) The area of the parish of Foulridge which is marked A3 on boundary map 9 shall be transferred to the parish of Blacko and to the Pendleside borough ward and the Pendle West county electoral division.
- (3) The area of the parish of Higham-with-West Close Booth which is marked Al on boundary map 11 shall be transferred to the parish of Old Laund Booth.

Transfers from unparished areas to parishes

- 7. (1) That part of the unparished area of the former urban district of Barnoldswick which is marked C5 on boundary map 9 shall become part of the parish of Blacko and shall be transferred to the Pendleside borough ward and the Pendle West county electoral division.
- (2) That part of the unparished area of the former urban district of Earby which is marked C2 on boundary map 10 shall become part of the parish of Foulridge and shall be transferred to the Foulridge borough ward and the Pendle East county electoral division.
- (3) That part of the unparished area of the former urban district of Barrowford which is marked Cl on boundary map 9 shall become part of the parish of Old Laund Booth and shall be transferred to the Fence borough ward and the Pendle West county electoral division.
- (4) That part of the unparished area of the former urban district of Brierfield which is marked C3 on boundary map 12 shall become part of the parish of Reedley Hallows.
- (5) That part of the former urban district of Barnoldswick which is marked C4 on boundary map 8 shall become part of the parish of Salterforth and shall be transferred to the Earby borough ward.

Abolition of parishes

· 8. The parishes and parish trustees of the parishes of Brogden and Bracewell shall be abolished. Their residuary successor shall be the new parish of Bracewell and Brogden, which shall also assume custody of the public books and documents of those parishes.

EXPLANATORY NOTE

(This note is not part of the order.)

This order affects parishes and the unparished area in the borough of Pendle.

It -

- (a) creates 4 new parishes of Barnoldswick, Barrowford, Bracewell and Brogden, and Trawden Forest;
 - (b) transfers areas between parishes:
 - (c) transfers areas from the unparished area to parishes; and
 - (d) abolishes the parishes of Brogden and Bracewell.

Parish councils are established for the new parishes of Barnoldswick, Barrowford and Trawden Forest.

The map forming part of this note (page 8) gives a general guide to the areas affected as from 1st April 1987.

Prints of the detailed boundary maps, which are referred to in article 3, may be inspected at the offices of the Pendle Borough Council, and may be inspected at or purchased from the Department of the Environment's Map Library, 2 Marsham Street, London SWIP 3EB.

The new parish of Barnoldswick will have approximately an area of 688 hectares, a population of 10,038 and a rateable value of £854,618.

The new parish of Barrowford will have approximately an area of 537 hectares, a population of 5,103, and a rateable value of £400,711.


The new parish of Bracewell and Brogden will have approximately an area of 1,884 hectares, a population of 204 and a rateable value of £12,333.

The new parish of Trawden Forest will have approximately an area of 2,408 hectares, a population of 2,180 and a rateable value of f 137,020.

Consequential changes to local government electoral areas are made.

The Local Government Area Changes Regulations 1976, mentioned in article 2(1), contain further provisions about the effect and implementation of orders such as the present one.
