## Office Memorandum

Subject:-Clarification in respect of Clauses 2.1`2 and 3.21 of the guidelines for Selection of new grid connected solar projects under JNNSM.

The undersigned is directed to refer to the above mentioned Guidelines notified by this Ministry (with No. 5/17/2009-P&C) and to say that it has been brought to the notice of this Ministry by some power project developers that they are experiencing some difficulties in getting the land transferred in the name of solar power project company and therefore they have suggested to waive of the condition of transfer of land in the name of solar power project company as provided in the above referred guidelines.

- The above issue has been examined and in exercise of the powers conferred in clause 4.4 of the said guidelines, it is clarified that in cases where land is held in the name of majority stakeholder of the company and cannot be transferred to their Special Purpose Vehicle (SPV) set up for implementation of the solar project due to a special order or rule of the State/Central Government, the condition of holding land in the name of project implementing company is waived off if the 'No objection' is also obtained from the concerned State/Central Government. In such cases, transfer of controlling share in the project implementing company will not be allowed for the whole duration of the PPA (Power Purchase Agreement).
- This issues with the approval of Secretaries of the Ministry of Power and Ministry of New & Renewable Energy.
