CONVENTION ON ROAD TRAFFIC CONCLUDED AT VIENNA ON 8 NOVEMBER 1968

COMMUNICATION BY ESTONIA

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

On 1 October 1993, the Secretary-General received from the Government of Estonia, in accordance with article 45 (4) of the Convention, a notification concerning the decision to "replace the former Estonian symbol 'EW'" chosen by Estonia as distinguishing sign upon its accession, with a distinguishing sign "EST".

(In this connection, reference is made to depositary notification C.N.326.1992.TREATIES-2/1 dated 25 November 1992 concerning, inter alia, the accession by Estonia to the above-mentioned Convention.)

In accordance with article 54 (4) of the Convention, the modification took effect three months after the date of receipt of the said notification, i.e. on 1 January 1994.
