1. ANNOUNCEMENT

2. JURISDICTION

The abovementioned meeting has been authorised by Motorcycling Victoria (MV) and will be held in accordance with the General Competition Rules (GCR's) of Motorcycling Australia (MA), the by-laws of MV, these Supplementary Regulations and any final instructions issued by the stewards of the meeting.

BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

3. ENTRIES

Entries will be accepted forthwith from current MA Senior National (SNA) competition licence holders.

Senior One Meeting National Licences** are available from Motorcycling Victoria for Women & Vets 035 competing in National and State Championships. These must be purchased from Motorcycling Victoria prior to the event and brought to sign in.

Riders with licenses' issued by other Federations and an FIM license are eligible to enter, provided they have a Start Permission from their Federation and have insurance to FIM standard. Current competition licence must be produced at sign in. **NO EXCEPTIONS.**

3.1.2.4 ^ Senior One Meeting National Licence subject to the following conditions:

a) Licence will be available to all applicants 16 years and older, b) Current club membership is required, c) No competency test is required if the applicant can prove that they have held an annual competition licence within the previous 10 years, d) Applicants who have never held a competition licence, or who have not held a licence within the previous 10 years must undertake a competency test, and apply for the licence via the event Race Secretary at least 21 days prior to the race meeting in which they wish to compete. The competency assessment may be undertaken at the meeting in which the participant intends to compete. 9 This licence category will only be available to: i) Participants in national classic/historic events, ii) Competitors using modern machines at a national event specifically for Veteran and/or Masters riders. The minimum age to classify a Veteran or Masters competitor for this category is 35 years, iii) Women competing in National and State Championships.

First bike, per round \$122.00

Second bike entry fee is \$80.00 per bike per round

*** Do not add to entry fee

Included in this fee is, \$12.00 Riders Levy (collected on behalf of MV), \$10.00 Flag Duty, \$5.00 gate entry (both collected on behalf of participating club) and \$25 Medical levy (collected on behalf of medical services). Second bike entry fee also includes \$25 Medical levy (collected on behalf of the medical supplier) and \$10 flag levy (collected on behalf of the participating club).

No email or posted entries accepted, on line entries only. https://www.cloudentries.com.au

Entries will only be received **online** thru Cloud entries(www.cloudentries.com.au) **NO EXCEPTIONS.** It is the rider's responsibility to complete the information correctly online to be eligible for that class. Default of payment thru Paypal will void any entry for that rider. There is a surcharge of \$3.50 entering on line.

After completion of payment for entry riders will receive 2 emails to confirm entry – one from PayPal and one from Cloudentries. This is your acknowledgement that entry has been accepted and the class you have entered. Riders should ensure that information they received back is correct.

ENTRY PAYMENTS DEFAULTED FROM ONLINE ENTRY WILL RESULT IN A \$100 LATE FEE.

Viewing of entrants list on the MV Website and Cloud Entries website (Wednesday prior to race meeting).

Final rider instructions will be emailed to all entrants entered on Wednesday evening.

NOTE: Entries close at 7pm Eastern Australia Standard Time on:

Please ensure that you have entered well before the closing time to allow your entry to progress to completion prior to the closing time. Entries will reopen after the nominated closing time of 7pm and will close on Wednesday at 23.59pm. Entries received online during this extended time will incur a \$100 Late Fee, and the rider will not be published in the programme. Payment of entry must be completed before 7pm on Monday evening to ensure late fee penalty is not incurred.

REFUNDS/TRANSFERS:

An entry fee will be credited to your paypal account if a Rider / Parent informs the Race Secretary in writing (email mxsenior@motorcyclingvic.com.au) within 24 hours of event start. Event start is at 7am.

A refund will only be issued in case of an injury that disables the rider to participate in any further rounds of the titles and a medical certificate will be required stating that the rider is unfit to participate.

A \$25.00 administration fee will apply to all refunds.

If a rider participates in the race meeting, which includes practice and then wishes to withdraw from the event for any reason - no refunds will be given.

ADMISSION FEES

Riders admission fee is Included in Race entry fee. Entry to venue after 80am may incur a charge by the host club

MEDICAL SERVICES

Event Aid Ptv Ltd will be in attendance for the entirety of each round. Riders will be required to present the medical history form at their first round entered. This form will be emailed with the final instructions or available on the MV website within the MX discipline section

SIGN IN

Sign in for the above mentioned events will take place from 6.45am to 8.00 am Saturday & Sunday.

Riders must present the self-scrutineering form at sign on with all details completed. This must be done for all bikes including spare/practice bikes entering the classes to be held that day. The self-scrutineering form will be emailed along with the final instructions for each event.

If a rider is riding both days this form must be completed and presented each day.

Riders under the age of 18 MUST have their parent/legal guardian present with them at sign in, if not accompanied by parents, must have a guardianship form filled out prior to the event and presented at sign in. The guardian must be over 18 years and have

RIDERS BRIEFING

Riders Briefing is compulsory. All riders must be present for roll call. Fines will be imposed if riders are not present and riders will be excluded from riding until fine is paid. The Riders Briefing will take place Saturday & Sunday 8.15am.

A minimum of ten (10) entries to constitute a class or at the discretion of Motocross Management. Motocross Management may combine classes if numbers are low, double gate drops may be an option.

CORNER DUTY

Responsibility of Club conducting the event.

All clubs will be responsible for providing a representative over the age of sixteen years to carry out Corner Duties during the meetings. All riders will be required to pay a flag levy of \$10.00 per bike, payable at time of entry through cloud entries.

10. GRID POSITIONS

Peg selection for first race at the first round, then in order of finishing from previous race. Grid Preference for first race following each round will be decided from the overall positions from the last round, then in order of finishing for grid preference from races that day.

In designated area only. Only one rider representative is permitted in the pit board area and must sign on from 7am - until 10mins after riders brief Saturday and Sunday, no bands will be given out after this time. A wrist band must be worn at all times. Rider Representative is only permitted in the pit board area during their riders' race.

12. PERSONAL TRANSPONDERS

Personal Transponders will be used. It is the Riders/entrant responsibility to have transponder charged at fitted to the motorcycle. Transponders must be fitted for practice. No working transponder = No points

Transponder number must be included in cloud entry details.

Motocross Management has a limited amount of transponders available for hire. Please indicate on the entry if you wish to hire a transponder. Hire is \$25 for the event.

MVMX would like to advise that a rider's licence will be held whenever they hire a transponder at any Victorian Championship round. It is the rider's responsibility to return their transponder on the completion of the event's racing in exchange for their licence.

Transponders not returned will incur a PENALTY of \$30.00 per day until the return of the transponder to MVMX.

13. SCRUTINEERING

All machines must comply with the 2017 GCRs

Scrutineering for all competitors will be conducted under the self-scrutineering criteria approved in conjunction with MA and adopted as per GCR 12.7.0.2. Riders must nominate on the form provided within the final instructions, or the MV website all bikes they have entered for the classes on that day, this includes spare bikes. All information must be completed on the forms. Incomplete forms will not be accepted. These forms are to be presented along with Helmets at scrutineering/sign on. Random full eligibility checks of machinery and equipment will take place during the meeting. These forms will not be available for riders to complete on the day, they must be completed prior.

In addition to supervising the pulling down and checking of machines after official protests have been received by the Clerk of Course in accordance with the GCRs, the Steward can order that any machine be measured. If this occurs the Scrutineer will supervise a team member to pull down any machine that has taken part in the event. Failure to comply with this rule will result in automatic exclusion from the event results.

Machines will not be sealed for later checking after the event. All machines that are to be pulled down and scrutineered will have this process take place at the venue before the machine is released by the Scrutineer. A member of the Rider's team must be available at all times to carry out the strip down under the control of the Scrutineer. Failure to comply with this rule will result in automatic exclusion from the events results.

Scrutineering/Sign on will take place Saturday and Sunday 6.45am to 8.00am

Motorcycles:

Closed Pits: dependant on club requirements if closed pits all bikes are to be kept in the pit area at all times when not being used for competition. Unless permission to remove the motorcycle has been granted by the Steward of the meeting. **No Open Toe** footwear is allowed within this pit area.

Paddock / Open Area.: Bikes are to be kept in the paddock area at all times when not being used for competition. Should a riders bike be requested to be presented to the Steward or Clerk of Course this is to be carried out immediately.

The immediate Pre-Grid/Start Gate area will be deemed as the pit area and No Open Toe footwear is allowed within this area.

As per rule 12.7.0.4 within the 2017 Manual of Motorcycle Sport - it is the riders, entrants and mechanics responsibility to ensure that their equipment is compliant for the class they are competing in.

All Helmet's must comply within the 2017 Manual of Motorcycle Sport.

Riders must display a legible back number at all times.

14. NOISE TESTING

Noise emissions must comply with rules 12.22.0.1 in the 2017 Manual of Motorcycle Sport and noise emissions must not exceed 112 dB (A) with a 2 dB (A) allowance. Noise testing will be carried out according to 12.22 in the 2017 Manual of Motorcycle Sport.

15. NUMBERS & NUMBERPLATES:

Must comply with the 2017 Manual of Motorcycle Sport.

All riders must run their Motorcycling Victoria allocated number, unless they are eligible to run the seeded number from the results of the 2016 Titles. Riders may be excluded from meeting if number is incorrect.

Background and numbers are to be specific to the class the rider is entering.

Back Numbers: All competitors must wear a corresponding and legible back number at all times when practicing or competing as per MOM's 12.15.4.

16. AWARDS

Awards will be presented at each round for 1st, 2nd and 3rd presentation for round one will be at the start of round two, and the same for all other rounds except for round four which will be at the conclusion of that round

Series Overall Trophies will be given to 1st 2nd and 3rd place getters. Medallions will be given to 4th 5th 6th 7th 8th 9th and 10th place getters.

To be eligible for these awards and prize money riders must compete in 3 of the 4 rounds of the Championship.

OVERALL PRIZE MONEY

Prize money will be presented out at the Presentation evening Saturday 2nd September 2017 (Ultima Function Centre. Bookings will be online at cloudentries.com.au) **Prize money not collected at Presentation will be posted within 7 days after presentation.**

CLASSES PAYING TO 5TH PLACE.

10 OR MORE ENTRIES HAVING COMPLETED 4 ROUNDS – 100% PRIZEMONEY PAID FOR THAT CLASS. IF A RIDER WITHIN THAT CLASS HAS ONLY COMPLETED 3 ROUNDS AND PRIZEMONEY IS ELIGIBLE FOR THAT RIDER THEY WILL ONLY RECEIVE 75% OF THE PAYMENT.

5 – 7 ENTRIES HAVING COMPLETED 4 ROUNDS – 75% PRIZEMONEY FOR ALL PLACING WITHIN THAT CLASS. IF A RIDER WITHIN THAT CLASS HAS ONLY COMPLETED 3 ROUNDS AND PRIZEMONEY IS ELIGIBLE FOR THAT RIDER THEY WILL ONLY RECEIVE 60% OF THE PAYMENT

LESS THAN 5 ENTRIES HAVING COMPLETED 4 ROUNDS -50% PRIZEMONEY FOR ALL PLACING WITHIN THAT CLASS. . IF A RIDER WITHIN THAT CLASS HAS ONLY COMPLETED 3 ROUNDS AND PRIZEMONEY IS ELIGIBLE FOR THAT RIDER THEY WILL ONLY RECEIVE 35% OF THE PAYMENT

17. CLASSES

Senior One Meeting National Licences are available for Women competing in National and State Championships. (MOMS 3.1.2.4.e.111)

Pro A Grade Lites & Open - Criteria

- All riders of 2016 Pro classes are automatically selected for the Pro class
- Any licenced A grade rider may choose to enter
- Any rider that has raced the MX Nationals 2016 (MX1, MX2, MXD) and has come inside the top 10 in the series, are automatically selected in the Pro class..
- The riders in Pro A Grade remain in this class for the series there is no dropping back to A Grade
- MX Management reserves the right to place riders in this class or remove them
- The Victorian 1 to 10 race numbers will be given to this class

MX2 (previously known as Lites) A, B & C = up to 250cc 2 or 4 stroke **

MX1 (previously known as Open) A, B & C = 122cc and over 2 or 4 stroke **

Ladies Open Expert = A & B Grade

Ladies Open Clubman = C Grade

MXD A, B & C (previously known as U19's) = up to 250cc 2 or 4 stroke - Please note no Pro riders can race in the u19 class- Must be u19 at the start of the series 8th April 2017.

Vet's 30 years to under 40 years Combined = All powers. **Must be 30 years and under 40 years at the start of the series 8th April 2017** Vet's 40 and over Combined = All powers. **Must be 40 and over at the start of the series 8th April 2017**.

- ** Bikes of the following capacity 122cc to 250cc 2 stroke or 4 stroke are only eligible to enter both classes IF the rider has two separate bikes of the same capacity.
- ** Riders with only one bike are ineligible to ride the same bike in both classes.

Interstate and Enduro riders please note the following clause in Motocross Managements Policy's and Procedures:

- **4.8** Interstate competitors competing in any of the Victorian Championships are graded to A grade, however if the competitor or competitor representative request a lower grade, this is possible but they must be made aware that Motocross Management reserves the right to regrade them at any time during the series and any points earned within that time will not be transferable.
- **4.9 Enduro riders** are to be graded to B grade, however if the competitor or competitor representative requests a higher/lower grade, this is possible but they must be made aware that Motocross Management reserves the right to regrade them at any time during the series and any points earned within that time will not be transferable
- **4.10** Motocross Management reserves the right to regrade riders at any time during the series and any points earned within that time will not be transferable.

- 20. POINTS AS PER the 2017 Manual of Motorcycle Sport 1st 35, 2nd 32, 3rd 30, 4th 28, 5th 26 then from 6th to 30th decreasing by one.
 - 21. EYEWEAR Riders are reminded that tear offs are banned for all Off Road related disciplines see Appendix A Protective Clothing/Equipment 7.2, and 7.2.0.1

22. CODE OF CONDUCT

All competitors, officials and parents are reminded of the Motorcycling Australia By-Law – CODE OF CONDUCT (as stipulated in the GCR's) which is a guide to appropriate behavior at all motorcycle race meetings. This CODE OF CONDUCT applies to this meeting and will be enforced

23. CAMPING

Please contact Host Club for camping details or see the final instructions on the MV website Tuesday prior to the event. Camping fees are up to \$15 per vehicle per night.

24. CATERING

Full catering will be available.

25. RIDING THE TRACK PRIOR TO EVENT

No competitor may enter the track for practicing on any of the 8 (eight) days immediately preceding the event other than the official press day.

26. PHOTOGRAPHERS

All photographers are to be professionals, meet the Media criteria and be accredited by MX Management (mxsecretary@motorcyclingvic.com.au) Any person on the track without the accreditation will be asked to leave, repeat offenders will be fined or rider penalized.

GENERAL

- 1. **Noise:** Noise emission must comply with Rules in the 2017 Manual of Motor Sport and not exceed listed decibel levels in the Manual
- 2. Numbers & Numberplates: Must comply with the 2017 Manual of Motorcycle Sport. All riders must run their MV allocated number. Riders may be excluded from meeting if number is incorrect
- 3. Change of Motorcycle: A change of motorcycle may be permitted prior to the start of a race or at the discretion of the Clerk of Course. The change of motorcycle must be in writing and approval obtained by the Clerk of Course
- 4. **Back Numbers:** All competitors must wear a corresponding and legible back number at all times when practicing or competing. Back Number must be contrasting colours and clearly visible from 40 meters. NO BACK NUMBER = NO POINTS
- 5. **Points Score:** As per 2017 Manual of Motorcycle Sport.
- 6. **Riding of Motorcycles:** The riding of any competing motorcycles in the pits or car park or camping area is not permitted. Infringing riders will be brought before the stewards of the meeting. Any offender may be fined \$50.00, which must be paid before any further participation is permitted. No pit bikes or non competing motorcycles are permitted to be ridden at any time at the venue.
- 7. **No Hassle Policy:** Any rider, entrant or person associated with a rider or entrant shall conduct themselves in an orderly manner in any dealings whatsoever, with any official of the meeting. A rider shall be responsible for his/her own conduct and that of any person with whom he/she is associated who abuses or threatens in any manner, either verbally or physically, any official. Penalties, which may be imposed by the stewards for breach, include reprimand or warning. Minimum \$50.00 fine or exclusion from the meeting.
- 8. **Abandonment:** In the event of the meeting being abandoned due to circumstances beyond the control of the promoters before racing commences, entry fees will be returned, less a \$20.00 fee per entry to cover administration costs. Once the competition has commenced only the stewards of the meeting have the authority to abandon the meeting and their decision shall be final. In such cases the stewards will rule on the results according to the circumstances. Entries maybe transferred to the rescheduled date if this is to occur.
- 9. Bicycles: Bicycles are not permitted in the pits or on the racing circuit. No Pit Bikes will be allowed anywhere at this complex.
- 10. Animals: Are not permitted into the grounds. Seeing Eye dogs are permitted.
- Motorcycles: If closed pits -are to be kept in the pit area at all times when not being used for competition. Unless permission to remove the motorcycle has been granted by the stewards of the meeting. Any motorcycle removed from the pit area without permission of the stewards, will be deemed to have withdrawn from the competition. No open toe foot wear to be worn in this area. Open Pits/Paddock Bikes are to e kept in the paddock area at all times when not being used for competition. Should a riders bike be requested to be presented to the Steward or Clerk of Course this is to be carried out immediately. The Pre Grid/Start gate will be deemed as the pit area and no open toe foot wear is to be worn in this area.
- 12. **Reservations:** The Stewards of the meeting reserve the right to alter, postpone or cancel all or part of the events program.
- 13. **Unauthorised:** Persons are prohibited from entering the track infield area. Such unauthorised persons will be removed from prohibited areas.
- 14. No open toe foot wear to be worn in the Pre Start or Starting grid.
- 15. IMPORTANT NOTICE TO ALL RIDERS/ENTRANTS/PARENTS/GUARDIANS: CAPITAL BENEFITS INSURANCE IS APPLICABLE TO ALL RIDERS WITH A CURRENT LICENCE.
 - It is conditional upon acceptance of this entry that it is fully understood by the rider/entrant/parent/guardian to arrange personal injury and ambulance transportation insurance cover in case you should require the same during the running of this competition.
- 16. RÍDÉRS INSURANCE: The Motorcycling Australia Insurance Scheme provides: As per 2017 Manual of Motorcycle Sport.

- that there may be no or inadequate facilities for treatment or transport of me if I am injured;
