#### 1. ANNOUNCEMENT

The Albury-Wodonga Motorcycle Club, hereinafter called the PROMOTER, will conduct the 2016 Skylift Hire & Rental Summer Short Track Series on 9th January, 30th January and 13th February.

#### 2. JURISDICTION

The abovementioned meeting has been authorised by Motorcycling Victoria (MV) and will be held in accordance with the General Competition Rules (GCR's) of Motorcycling Australia (MA), the by-laws of MV, these Supplementary Regulations and any final instructions issued by the stewards of the meeting.

BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

Entries will be accepted forthwith from current MA Senior National (SNA) and MA Junior National (JNA) competition licence holders. Current competition licence and current club membership card must be produced at sign in. NO EXCEPTIONS.

#### 3.1 Entry Fees per class:

Motorcycling Victoria Riders Levy of \$11 per rider per event is additional to above entry fees.

NOTE: Riders can enter at first round for full series or can enter round by round (premium applies for round by round entries). Entries will be taken on the day of each event commencing at 2.00pm and closing at 4.30pm.

#### **ADMISSION FEES**

Admission fees to the event will be as follows:

Adults: \$10 per person Pensioners: \$5 per person

Children 12-U16: \$5

Family Pass: \$25 (parents & children) Children under 12 years are free.

Each entry will entitle admission of the Rider and one Mechanic for free. All other attendees will be required to pay admission. Rider and maximum of two licensed Mechanics will be issued with wrist bands at sign-on. Wrist bands will be required for admission to pits.

#### 5. MEDICAL SERVICES

Event Medical Team will be in attendance from the entirety of the event.

Sign in for the abovementioned event will take place from 2.00pm until 4.30pm on each race day. Current competition licenses must be presented at sign on.

#### 7. RIDERS BRIEFING

Attendance at the Riders Briefing is compulsory. The Riders Briefings will take place at 5.00pm on each race day which ALL competitors MUST attend. Rider briefing sheets must be signed by the competitors as proof of attendance. Parents/ guardians must sign the riders briefing sheets for competitors under the age of 18 years.

#### 8. TEMPORARY GUARDIAN

Riders under the age of 18, if not accompanied by parents, must have a guardianship form filled out prior to the event and presented at sign

in. The guardian must be over 18 years and have ID.

#### 9. MINIMUM ENTRIES

Minimum six (6) solo entries to constitute a class. Grades may be combined with higher or lower grade if insufficient entries are received to constitute a class.

Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and re-distribute any awards will be at the discretion of the Club, subject to MV approval.

#### 10. GRID POSITIONS

Grid positions for all heats and rounds will be determined by peg selection at the dummy grid.

#### 11. MACHINE EXAMINATION

Machine examination will commence at 2.30pm and conclude at 4.45pm on each race day. All machines must comply with the 2016 GCR's

Machines entered in the competition must have successfully passed a machine examination prior to taking part in practice, qualifying or racing

Helmets and back protectors must be presented at scrutineering. Eligibility checks can take place at any time during the meeting. Machines which suffer accident damage in practice or race sessions must be re-examined before participating again,

In addition to supervising the pulling down and checking of machines after official protests have been received by the Clerk of Course in accordance with the GCRs, the Stewart can order that any machine be measured and if this occurs the Scrutineer will supervise a team member to pull down any machine that has taken part in the event. Failure to comply with this regulation will result in this matter being referred to the Clerk of Course for further action.

Machines will not be sealed for later checking after the event. All machines that are to be pulled down and scrutineered will take place at the circuit before the machine is released by the Scrutineer. Failure to comply with this regulation will result in the matter being referred to the Clerk of Course foe further action.

#### 12. AWARDS

All Junior & Senior classes will receive a trophy for 1st, 2nd and 3rd in each class based on overall series points.

#### 13. CAMPING

Camping is permitted at the facility.

#### 14. CODE OF CONDUCT

All competitors, officials and parents are reminded of the Motorcycling Australia By-Law – CODE OF CONDUCT (as stipulated in the GCR's) which is a guide to appropriate behaviour at all motorcycle race meetings. This CODE OF CONDUCT applies to this meeting and will be enforced.

#### 16. VENUE DESCRIPTION

Track length is 350 metres

Track surface is decomposed granite

A full canteen service will operate for the entirety of the event

#### 18. INSURANCE

National Personal Accident Scheme provides basic cover for death and permanent disability.

Ambulance Insurance is compulsory for licensees. It is strongly recommended that competitors give consideration to taking out weekly benefits insurance.

#### 19. STARTS

Clutch starts from behind Speedway start tapes. A green light will be displayed to riders, then tapes will rise within 3 to 5 seconds.

#### 20. RACE FORMAT

Practice will be three laps for each class entered. Qualifying heats are round racing will be four laps. Finals will be four laps. Each class will be conducted over three rounds of qualifying heats, with a repercharge and a final. Where there is one full grid or less, racing will be conducted over four rounds. Points will be tallied across all three series rounds to determine overall class results.

#### 21. GST

The goods and Services Tax affects the payment of prize money. If you do not provide an ABN or declare the sport is a hobby, the Promoter must withhold 48.5% of prize money over \$50.00 which is otherwise payable to you. Please tick one of the boxes on the entry form and if appropriate provide your ABN to ensure the full amount is paid to you.

#### 22. MACHINES AND RIDERS

All machines entered must comply with GCRs for dirt track competition.

Multiple entry of one machine in the same class of competition is not permitted.

Change of machine may be permitted in writing to the Clerk of Course and with the approval of the MA Steward at least 15 mins prior to the start of the event in which the substitution is requested. Substitute machine must have passed the machine examination, be eligible for the class and replace a machine that cannot be reasonably repaired. Machine substitute will only be permitted in heats and not in finals.

Scrutineered machines must remain in the pit area at all times between races and can only be removed at the conclusion of the event or with the permission of the COC. Failure to comply will result in exclusion from the meeting.

The first four place getters must remain impounded in the selected area at the conclusion of the meeting for a period of 30 mins to allow for eligibility protest to occur. During this time, no machine in the classes impounded shall be removed from the selected area. Failure to comply with this regulation will result in the matter being refereed to the COC for further action.

#### 23. RIDING NUMBER

All number plates on all machines MUST comply with the GCRs and must not contain any decals or advertising other than the required scrutineering decal.

All competitors must wear a corresponding and legible back number at all times when practicing or competing. See GCRs 12.6.5.

#### 24. TRACK WALK

All participating competitors will be given the opportunity to walk the track prior to any on track participation.

#### 25. CANTEEN FACILITIES

Canteen facilities will be open from 5.00pm on all race days.

#### 26. NOISE

Noise testing will take place at any time at the decision of the Chief Scrutineer or the Clerk of Course. Refer to GCRs.

#### 27. TYRES

No knobby tyres are allowed on the rear of any machine over 85cc 2 stk & 150 cc 4 stk.

#### 28. ANTI-DOPING POLICY

All competitors and officials are advised that drug testing may take place in accordance with MA's Anti-doping policy, as carried out but the Australian Sports Anti-Doping Authority. Refer to GCRs for details.

If any doubt exists over banned substance it is recommended competitors contact the Drugs in Sports Hotline- 1800 020 506. When drug testing takes place, the payment of prize money or awards may be delayed at MA's discretion until the results of the test are known.

#### 29. ALCOHOL TESTING PROCEDURE

All competitors and officials are advised that random breath-testing may take place during the competition.

## 30. FUEL

Refer to GRCs. Random fuel testing may be carried out throughout the event by Motorcycling Australia Officials.

#### 31. ENVIRONMENTAL PROTECTION

A protective matting or catch tray must be placed underneath the engine/ gearbox and fuel tank of any machine while parked in pit area.

#### 32. CODE OF CONDUCT

All competitors, officials and parents are reminded of MA's Code of Conduct contained with the MA's Member Protection Regulations, found at <a href="https://www.ma.org.au">www.ma.org.au</a> or Appendix 3 of the GRC, which is a guide to appropriate behavior at all motorcycle race meetings. This Code of Conduct applies to the meeting and will be enforced.

#### **GENERAL:**

- 1. Noise: Noise emissions must comply with the 2016 Manual of Motorcycle Sport and not exceed 96dB (A).
- Numbers & Numberplates: Must comply with the 2016 Manual of Motorcycle Sport.
- 3. **Change of Motorcycle:** A change of motorcycle may be permitted up to 15 minutes before the start of the race provided that the notice is in writing and handed to the secretary of the meeting and approval obtained by the stewards.
- 4. Back Numbers: All competitors must wear a corresponding and legible back number at all times when practicing or competing.
- 5. **Points Score:** As per 2016 Manual of Motorcycle Sport.
- 6. **Riding of Motorcycles:** The riding of any competing motorcycles in the pits or car park or camping area is not permitted. Infringing riders will be brought before the stewards of the meeting. Any offender may be fined \$50.00, which must be paid before any further participation is permitted. No pit bikes or non competing motorcycles are permitted to be ridden at any time at the venue.
- 7. **No Hassle Policy:** Any rider, entrant or person associated with a rider or entrant shall conduct themselves in an orderly manner in any dealings whatsoever, with any official of the meeting. A rider shall be responsible for his/her own conduct and that of any person with whom he/she is associated who abuses or threatens in any manner, either verbally or physically, any official. Penalties, which may be imposed by the stewards for breach, include reprimand or warning. Minimum \$50.00 fine or exclusion from the meeting.
- 8. **Abandonment:** In the event of the meeting being abandoned due to circumstances beyond the control of the promoters before racing commences, entry fees will be returned, less a fee per entry to cover administration costs. Once the competition has commenced only the stewards of the meeting have the authority to abandon the meeting and their decision shall be final. In such cases the stewards will rule on the results according to the circumstances.
- 9. Bicycles: Bicycles are not permitted in the pits or on the racing circuit. No Pit Bikes will be allowed anywhere at this complex.
- 10. Animals: Are not permitted into the grounds. Seeing Eye dogs are permitted.
- 11. **Motorcycles:** Are to be kept in the pit area at all times when not being used for competition. Unless permission to remove the motorcycle has been granted by the stewards of the meeting. Any motorcycle removed from the pit area without permission of the stewards, will be deemed to have withdrawn from the competition.
- 12. Reservations: The Stewards of the meeting reserve the right to alter, postpone or cancel all or part of the events program.
- 13. **Unauthorised:** Persons are prohibited from entering the track infield area. Such unauthorised persons will be removed from prohibited areas.
- 14. IMPORTANT NOTICE TO ALL RIDERS/ENTRANTS/PARENTS/GUARDIANS: CAPITAL BENEFITS INSURANCE IS APPLICABLE TO ALL RIDERS WITH A CURRENT LICENCE.

It is conditional upon acceptance of this entry that it is fully understood by the rider/entrant/parent/guardian to arrange personal injury and ambulance transportation insurance cover in case you should require the same during the running of this competition.

- "Motorcycling Organisation" means and includes MA, and the MA members (including the SCBs and affiliated clubs) and where the context so permits, their respective directors, officers, members, servants or

# 3. ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS I ACKNOWLEDGE that:

- motorcycle sport is dangerous and that by engaging in the sport (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
- that I may be injured, physically or mentally, and may be killed; that my machinery or equipment may be damaged, lost or destroyed;

- that competitors may ride dangerously or with a lack of skill; that track or event conditions may be hazardous and may vary without warning or predictability;
- that organisers, officials, landowners/track operators and any agents representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or events;
- that any policy of insurance of or in respect of my life or physical or mental health may be voided;
- that there may be no or inadequate facilities for treatment or transport of me if I am injured; that I have an obligation to myself and to others to act safely and within the
- rules and regulations of MA; the Indemnitees do not make any warranty that the services at the Meeting
- will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are
- to the extent that any warranty is implied it is excluded to the full extent permitted by law;
- have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Event.

I understand it is compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership.
